the above entitled matter is hereby vacated and held for naught.

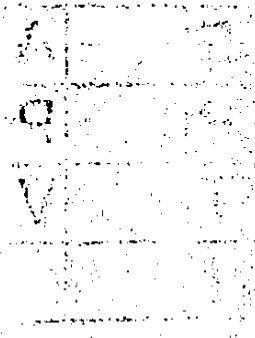
