THIS INDENTURE WITNESSETH, That the Grantor CHRIS GRABIK and EWA DRABIK, husband and wife

of the County of Cook and State of Illinois For and in consideration of TEN AND 00/100 DOLLARS (\$10.00) and other good and valuable considerations in hand paid, CONVEY S and WARRANT S unto the THE CHICAGO TRUST COMPANY, a corporation of Illinois, whose address is 171 N Clark Street, Chicago, IL 60601-3296, as Trustee under the provisions of a trust agreement dated the 6th day of May, 1996, known as Trust Number 1102177, the following described real estate in the County of Cook and State of Illinois, to-wit:

Lot 9 in Larry's Resubdivision of Lot 1 in Larry J. Pontarelli's Industrial Subdivision, being a Subdivision of part of the South Half of the West Half of the Northwest Quarter of Section 18, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

delivery thereof the trust created by this indenture and by said trust agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this indenture and in said trust agreement or in some amendment thereof and binding upon all beneficiaries thereunder, (c) that said trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

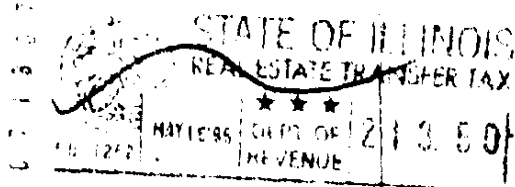

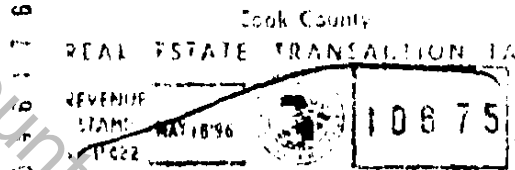

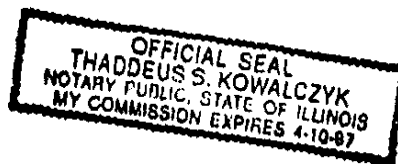
