FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 14th day of May 1996 by and between William J. Byrne, Jr., a single person never been married

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated May 14, 1996 (herein "Note") with a credit limit of One Hundred Thousand Dollars and no/100 dollars (\$ 100,000.00) (a minimum amount of \$10,000.00) of which an initial advance of xxxxxxxxxxxxxxxxxxxxxxxxxxxxxxxxx (\$ XXX) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim and convey) unto Lender and its successors and assigns, the following described property located in the County of Cook, State of Illinois:

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over full, Mortgagor, and ground rents on the Property if any, plus one-twelfth of yearly premium installments for hazard full.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Set forth below is a list of events which, upon the lapse of the applicable grace period, if any, shown generally affectually after such event, will constitute an Event of Default: (1) Borrower's failure to pay when due any amounts due under the Credit Documentation (any grace period); (2) Lender's receipt of actual knowledge of any material misrepresentation by Borrower in connection with the line of credit, whether committed in or omitted from Borrower's credit application or communicated during the term of the Note (no grace period); (3) Borrower's default status and the transfer of Borrower's interest in the Collateral (as such term is defined in the Security Agreement) to someone who is a signer of all the Credit Documents, if any, and, as a result thereof, Lender's sale of tandem, or promise to sell or transfer, all or any part of the Property of any interest therein, or any interest in the Collateral, whether voluntary or involuntary; without Lender's prior written consent (no grace period); (5)

A. An Event of Default will occur hereunder upon the expiration of the grace period, if any, after Lender gives Borrower written notice of the breach of Borrower's promises under this Note or any of the Credit Documents and upon Borrower's failure to cure such breach and to provide Lender with a reasonable satisfactory explanation of the cause of the breach within the applicable grace period, if any.

In the event of such cure, within the applicable grace period, if any, in each case, the grace period begins to run on the day after notice is given, and expires at 11:59 p.m., Central time, on the last day of the period. All grace periods are extended in calendar days, not business days. If there is no grace period applicable to a particular type of credit, the Event of Default will be complete upon the giving of the notice. Such notice shall be given to Borrower in accordance with Paragraph 11 hereof and shall contain the following information: (1) the nature of Borrower's breach; (2) the applicable grace period, if any, during which such breach must be cured; and (3) whether failure to cure such breach within the specified grace period, if any, will result in acceleration of the sums secured by this Mortgage and the foreclosure of this Mortgage. The notice shall further inform Borrower of the right, if any under applicable law, to prepay the revolving line of credit under this Mortgage after acceleration.

EVENTS OF DEFAULT

14. **REMEDIES CUMULATIVE.** Lender may exercise all or some rights and remedies provided in this Mortgage and in the Credit Documents, or which may be available to Lender by law, and all such rights and remedies shall be cumulative and concurrent, and may be pursued singly, successively or together, at Lender's sole discretion, and may be exercised as often as occasion therefor shall occur.

12. GOVERNMENT LAW; SEVERABILITY. This Mortgage shall be governed by the laws of the State of Illinois, which laws shall also govern and control the construction, enforceability and interpretation of this Mortgage. The foregoing sentence shall not limit the applicability of general law to this Mortgage. Every provision hereof is intended to be severable. 16. **TRANSFER OF PROPERTY.** Upon the occurrence of an Event of Default as specified in Paragraph 15.B(4) above, Lender shall be entitled to immediately accelerate the amounts due under the Note and declare all indebtedness secured by this Mortgage to be immediately due and payable. Failure to pay such indebtedness within thirty (30) days after notice to Borrower of such acceleration shall constitute an Event of Default. Any use or attempted use by Borrower of the revolving line of credit evidenced by the Note after such an Event of Default shall constitute a separate Event of Default.

As an alternative to declaring all sums secured by this Mortgage to be immediately due and payable, Lender may waive its option to accelerate and agree in writing, prior to close of the sale or transfer to the transferee's assumption of the outstanding obligation under the Note, on terms satisfactory to Lender, subject to Lender's right, described in Paragraph 6.D of the Note, to freeze or reduce the line of credit. Further advances on the line of credit will cease as of the date of the written assumption agreement signed by the transferee and Lender. The transferee and Borrower shall retain the right to repay the Note before the final payment date set forth in Paragraph 4 of the Note, in whole or in part, at any time without premium or penalty.

17. **ACCELERATION; REMEDIES (INCLUDING FREEZING THE LINE).** Upon the existence of an Event of Default Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, and invoke any remedies permitted by applicable law.



CONDOMINIUM RIDER

THIS CONDOMINIUM RIDER is made this 14TH day of MAY, 1996, and is incorporated into and shall be deemed to amend and supplement a Mortgage To Secure An Open-End Credit Account ("Mortgage") dated of even date herewith, given by the undersigned (herein "Borrower") to secure Borrower's Open-End Credit Account Variable Interest Rate Promissory Note to Glenview State Bank (herein "Lender"), and covering the Property described in the Mortgage and located at 1912 MISSION HILLS LANE B-C, NORTH BROOK, IL 60062.

The Property comprises a unit in, together with an undivided interest in the common elements of, and the right (if any) to the exclusive use of certain portions of the common elements of, a condominium project known as MISSION HILLS (herein "Condominium Project").

CONDOMINIUM COVENANTS. In addition to the covenants and agreements made in the Mortgage, Borrower and Lender further covenant and agree as follows:

A. ASSESSMENTS AND OTHER OBLIGATIONS. Borrower shall promptly pay, when due, all assessments imposed by the Owners Association or other governing body of the Condominium Project (herein "Owners Association") pursuant to, and shall perform all of Borrower's other obligations under, the provision of the declaration, by-laws, code of regulations or other constituent document of the Condominium Project.

In the event of a distribution of hazard insurance proceeds in lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any such proceeds payable to Borrower are hereby assigned and shall be paid to Lender for application to the sums secured by the Mortgage with the excess, if any, paid to Borrower.

E. REMEDIES.
