AGREED FINAL JUDGEMENT AGAINST DEFENDANTS

This matter coming to be heard on the court's status, due notice having been given, and the court being fully advised in the premises, this court orders the following and acknowledges that the defendants have agreed to all of its terms and conditions:

a) Nominal defendant Celebrity Cruises, Inc. is dismissed from this action without prejudice;

b) a final judgment is entered against (i) Sylvia Addison, individually and d/b/a Smart World Travel, (ii) Gunde Addison (a/k/a Hildegunde Addison) individually and d/b/a Smart World Travel and Smart World Service Inc., d/b/a Smart World Travel;

c) it is ordered that defendants have engaged in a pattern of trade and commerce that violates the Consumer Fraud Act;

d) it is ordered that defendants have engaged in a pattern of trade and commerce that violates the Travel Promotion Consumer Protection Act, specifically, that

defendants are travel promoters under the act and are required to maintain an escrow account for payments received from consumers and their failure to do so has caused and continues to cause harm to consumers;

e) this court issues a permanent injunction prohibiting defendants from committing further violations of the Consumer Fraud Act and the Travel Promotion Consumer Protection Act;

f) this court prohibits defendants from owning and/or working for and/or acting as an agent of a travel agency, travel promotion business and/or other similar travel business that fails to fully comply with the requirements of the Consumer Fraud Act and/or the Travel Promotion Consumer Protection Act, 815 ILCS 420/6 et seq.;

g) this court permanently enjoins defendants, and their respective agents/employees/representatives from advertising travel services until such time they cease violating the Consumer Fraud Act and the Travel Promotion Consumer Protection Act and comply with all requirements of said acts;

h) this court orders defendants (i) Sylvia Addison, individually and d/b/a Smart World Travel, (ii) Gunde Addison (a/k/a Hildegunde Addison) individually and d/b/a Smart World Travel and Smart World Service Inc., d/b/a Smart World Travel to provide restitution to the following members of the public who paid to travel on the "Vienna Interlude" cruise and were damaged by defendants' conduct:

i) this court orders the Clerk of the Circuit Court to disperse instantler to the Cook County State's Attorney the \$30,000.00, and any interest accrued thereof, held in the escrow account dated January 17, 1996 and created by judicial order dated January 17, 1996. The State's Attorney will disperse these monies to the consumers listed in Exhibit AA;

j) this court enters a \$20,000.00 civil penalty against (i) Sylvia Addison, individually and d/b/a Smart World Travel, for her violations of the Consumer Fraud Act and Travel Promotion Consumer Protection Act.

k) this court enters a \$15,000.00 civil penalty against (ii) Gunde Addison (a/k/a Hildegunde Addison), individually and d/b/a Smart World Travel, for her violations of the Consumer Fraud Act and Travel Promotion Consumer Protection Act.

1. The State's Attorney's Office will establish and manage an escrow account for the purpose of distributing payments to the members of the public listed in Exhibit AA;

2. The State's Attorney will determine (i) when restitution payments will be distributed to members of the public listed in Exhibit AA and (ii) the amounts of any partial payments;

3. Defendants must deliver all payments in satisfaction of this judgement to the Cook County State's Attorney's Office, Consumer Fraud Division, 28 North Clark Suite 400, Chicago, Illinois, 60602;

4. The State's Attorney does not waive collection of interest on this judgement;

5. All monies recovered from defendants shall first be paid to the consumers listed in Exhibit AA and then to satisfy any civil penalty or other costs;

m) this court prohibits defendants for 18 months from owning and/or acting as a partner or principal of a travel agency, travel promotion business and/or other similar travel business;

COMPLIANCE

Defendants shall not enter into, form, organize, or reorganize into any partnership, corporation, or any other legal structure for the purpose of avoiding compliance with the terms of this Final Judgment.

Compliance with this Final Judgement does not relieve Defendants of any other obligations imposed by applicable federal, state or local laws.

The State's Attorney may delay or refrain from enforcing any of its rights under this Final Consent Judgment.

In the event defendants violate any of the provisions of this Final Judgment, Defendants shall held in contempt of Court upon issuance of a Rule to Show Cause.
