FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 21st day of May 1996 by and between John M. Holthaus and Ellen L. Holthaus, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated May 21, 1996 (herein "Note") with a credit limit of One Hundred Thousand Dollars and no/100 dollars (\$ 100,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXXXXXXXXXX (911 X X X) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim and convey) unto Lender and its successors and assigns, the following described property located in the County of Cook, State of Illinois:

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over this Mortgagor, and ground rents on the Property if any, plus one-twelfth of yearly premium installments for hazard

1. PAYMENT AND COMPLIANCE WITH NOTE: APPLICABILITY OF PAYMENTS. Borrower shall promptly pay when due the principal and interest on the indebtedness evidenced by the Note together with any late charges or other charges imposed under the Note, and the principal and interest on any future Advances (as defined in Paragraph 27 below) secured by this Mortgage. Unless applicable law requires otherwise, all payments received under the Note and this Mortgage shall be applied by Lender first in Payment of any additional sums owing to Lender; whether or not the Credit Documents provide otherwise, attorney's fees (to the extent permitted by law) delinquentics, costs and expenses of exercising rights and remedies granted under the Credit Documents; second, to the payment of principal of the Note; and then to interest and principal on any future documents; third, to the payment of principal on any future advances.

Covenants. Borrower and Lender covenant and agree as follows:

THIS MORTGAGE IS GIVEN TO SECURE: (i) the repayment of the indebtedness evidenced by the Note; (ii) the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this mortgage; and (iii) the performance of the covenants and agreements of Borrower contained herein and in the Note, and, if title to the property is held by a Trust, in the FlexEquity Security Agreement (the "Security Agreement") of even date herewith. The Note, the Security Agreement, this Mortgage and all instruments now or hereafter given to evidence the indebtedness evidenced by the Note are collectively referred to herein as the "Credit Documents". The Credit Documents constitute and this Mortgage purports and secures, future advances.

Borrower acknowledges that the Note calls for a variable interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances thereunder, reduce the amount of credit available, and/or require repayment of the outstanding balance under the Note.

Borrower covenants that BORROWER is the lawful owner of the estate in land hereby conveyed and has the right to grant, convey and mortgage the property, and that the property is unencumbered except for that certain Mortgage or Deed of Trust in favor of CECIL HORTAGNE COMPANY dated November 25, 1994 as Document No. 9438439 in the Office of Recorder of Deeds/Register of Titles, County of Broward, Florida (hereinafter referred to as "Title Company"). The Borrower further agrees to execute such documents as may be required by Title Company to record the Deed of Trust in the Office of Recorder of Deeds. The Borrower further agrees to pay all costs and expenses of recording the Deed of Trust, including attorney's fees and recording fees.

TO GETHER WITH all improvements now or hereafter erected on the property, and all easements, rights, and rents (subject however to the rights and authorities given herein to Lender to collect and apply such property, and rents) royalties mineral, oil and gas rights and profits, water, water rights, and all applicable such improvements and additions thereto, shall be deemed to be and remain a part of the property, all of which, including condemnation proceedings, and all fixtures now or hereafter attached to the property, all of which, including Mortgagor, and of the foregoing, together with said property (or the lessorhold estate if this Mortgagor is deceased), and of the lessorhold referred to as "Property"; as to any property which does not constitute a Security such term is defined in the Uniform Commercial Code); this Mortgage is deemed to be, as well, a Security (as Agreements under the UCC for the purpose of creating a security interest in such property, which Borrower hereby agrees to Lender as Secured Party (as such term is defined in the UCC); and norwithstanding anything to the contrary herein, the Property shall include all of Borrower's right, title, and interest in and to the real property described above whether such right, title, and interest acquired before or after execution of this Mortgage.

Specifically, and without limitation of the foregoing, if this Mortgage is given with respect to a lessorhold estate held by Borrower, and subsequently acquires a fee interest in the real property, the lessor of this Mortgagor shall attach to and include the fee interest acquired by Borrower.

insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of execution of the language that interest on the Funds shall be paid to Borrower, and unless such agreement be made or applicable law requires such interest to be paid, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds, if any, are pledged as additional security for the sums secured by this Mortgage, and are held by Lender as a creditor and not as a trustee.

If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. If the amount of Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within thirty (30) days from the date notice is mailed by Lender to Borrower requesting payment thereof.

Neither Lender nor any institution designated by Lender to hold the Funds shall be liable for any failure to make the payments of insurance premiums, taxes or ground rents unless Borrower, while not in default hereunder, shall have requested Lender or such institution to make application of the Funds to the payment of the applicable insurance premiums, taxes or ground rents, accompanied by the bills for such insurance premiums, taxes or ground rents. Notwithstanding the foregoing Lender may, at its option, make or cause such institution to make any such application of the Funds without any direction or request to do so by Borrower.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

3. PRIOR ENCUMBRANCE; CHARGES; LIENS. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

4. HAZARD INSURANCE. Borrower shall, at Borrower's cost keep the improvements now existing or hereafter erected on the Property insured against loss by fires, hazards included within the term "extended coverage" and such other hazards (collectively agreed to as "Hazards" as Lender may require. Borrower shall maintain Hazard insurance for the entire term of the Note or such other periods as Lender may require and in an amount equal to the lesser of (a) the maximum insurable value of the Property or (b) the amount of the line of credit secured by this Mortgage plus the outstanding amount of any obligations secured in priority over this Mortgage, but in no event shall such amounts be less than the amount necessary to satisfy the co-insurance requirement contained in the insurance policy.

If under Paragraph 17 hereof the property is acquired by Lender, all rights, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the property prior to such sale or acquisition shall become the property of Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

If the property is abandoned by Borrower or if Borrower fails to respond to Lender in writing within thirty (30) calendar days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is irrevocably authorized to settle the claim and to collect and apply the insurance proceeds at Lender's sole option either to repair the property or to the sums secured by this Mortgage.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower. Subject to the terms of any mortgage, deed of trust or other security agreement with a licen which has or appears to be a party jointly over this Mortgage and unless Borrower and Lender otherwise agree in writing insurance subject to the terms of any mortgage, deed of trust or other security agreement with a licen which has or appears to be a party jointly over this Mortgage, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower.

Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. **INSPECTION.** Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. **CONDEMNATION.** The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

16. **TRANSFER OF PROPERTY.** Upon the occurrence of an Event of Default as specified in Paragraph 15.B(4) above, Lender shall be entitled to immediately accelerate the amounts due under the Note and declare all indebtedness secured by this Mortgage to be immediately due and payable. Failure to pay such indebtedness within thirty (30) days after notice to Borrower of such acceleration shall constitute an Event of Default. As an alternative to declaring all sums secured by this Mortgage to be immediately due and payable, Lender may waive its option to accelerate and agree in writing, prior to close of the sale or transfer to the transferee's assumption of the outstanding obligation under the Note, on terms satisfactory to Lender, subject to Lender's right, described in Paragraph 6.D of the Note, to freeze or reduce the line of credit. Lender's acceptance of the transferee's assumption of the obligation under Note shall not release Borrower from any of obligations under the Note and the Credit Document, and Borrower shall assume the status of the guarantor of the Note until paid in full. Borrower understands that Lender will not permit the assumption of the outstanding balance under the Note in any event and will declare the entire outstanding principal balance plus accrued interest and other charges due to be immediately due and payable (see Paragraph 17 hereof), unless (i) Borrower has submitted to Lender a written acknowledgement from the transferee that the transferee has received (a) a copy of each of the Credit Documents and (b) notice of the amount of Borrower's outstanding principal balance on the line of credit; (ii) Borrower has submitted to Lender a written acknowledgement from transferee that transferee has received such material and understands that Lender's security interest reflected by this Mortgage and the Security Agreement, if any, will remain on the Property and the Beneficial Interest, if any, until the entire outstanding principal balance of Borrower's line of credit as of the date of such sale or transfer or promise, plus any subsequent borrowing made under Borrower's line of credit before Lender has actual knowledge of the sale or transfer, together with accrued interest and other charges, is paid in full; (iii) Borrower causes to be submitted to Lender from the transferee a loan application as required by Lender so that Lender may evaluate the creditworthiness of the transferee as if a new loan were being made to the transferee; and (iv) Lender does not in its sole opinion, believe that (a) its security will be adversely affected, or (b) a breach of any promise or agreement in this Mortgage or the Security Agreement, if any, will occur or (c) such transfer will permit the acceleration of any loan which has priority in right of payment over the indebtedness evidenced by the Note. Further advances on the line of credit will cease as of the date of the written assumption agreement signed by the transferee and Lender. The transferee and Borrower shall retain the right to repay the Note before the final payment date set forth in Paragraph 4 of the Note, in whole or in part, at any time without premium or penalty.

17. **ACCELERATION; REMEDIES (INCLUDING FREEZING THE LINE).** Upon the existence of an Event of Default Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, and invoke any remedies permitted by applicable law.

22. **TIME OF THE ESSENCE.** Time is of the essence to this Mortgage and all provisions relating thereto are to be strictly construed.

27. INCORPORATION OF TERMS. All of the terms, conditions and provisions of the Note are by this reference incorporated herein as if set forth in full. Any Event of Default under the Note shall constitute an Event of Default hereunder without further notice to Borrower.

REQUISITE FOR NOTICES. Borrower requests that copies of any notice of default be addressed to the holder of any lien which has priority over this Mortgagor's address, as set forth on page one of this Mortgage.

19. RELEASE. Upon payment and discharge of all sums secured by this Mortgage and termination of the
Account, this Mortgage shall become null and void and Lender shall release this Mortgage without charge to Borrower.

Upon acceleration under Paragraph 17 hereof, or abandonment, transfer at any time without notice, in person, by agent or by judicially appointed receiver, and without regard to the adequacy of any security for the indebtedness secured by this Mortgage, shall be entitled to enter upon, take possession of, and manage the Property, and in its own name sue for, or collect the rents of the Property, including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of operation and management of the Property and collection of rents, including, but not limited to, receivers' fees, promissory notes and receivables arising therefrom, a fee, and then to the sums secured by this Mortgage. Lender and the receiver shall be liable to account only for those rents actually received. The encircling Upon and taking possession of the collection and publication of the facts shall not cure or waive any notice.

18. ASSIGNMENT OF RENTS; APPROPRIAMENT OF RECEIVER; LENDEER IN POSSESSION. As additional security beforehand, Borrower hereby assents to Lender's rights to rents of the Property, provided that prior to acceleration under Paragraph 17 hereof or the occurrence of an Event of Default hereunder or abandonment of the property, Borrower shall have the right to collect and retain such rents as they become due and payable.

If Leander increases or reduces the line of credit, Leander shall notify Borrower, in the manner provided in Paragraph 11 of this Master Agreement, within three (3) days after such action has taken. Such notice shall specify; (i) the reasons for such action; (ii) the new credit limit, if the credit limit has been reduced; and (iii) that any reinstatement of the credit privileges must by requested by Leander will reinstate the line of credit at Borrower's request if the event giving rise to such reduction of credit no longer exists and no other event that would give Leander the right to reduce or reduce the line of credit of any Event of Default is then existing. If the line of Credit is frozen or reduced, Borrower is not obligated to repay the outstanding principal balance until the final payment date set forth in Paragraph 4 of the Note; provided, however, that Leander will still have the right, in accordance with the terms of the Note, to accelerate the final payment date upon the occurrence of an Event of Default, thus advancing the date principal repayment the line of credit when permitted to do so by the terms of this Paragraph.

As additional specific protection, notwithstanding any other term of the Note, Lender, without detracting or asserting any right to any future Event of Default or any of its remedies pertaining to Events of Default, may cancel Borrower's right to any future Advances under the Note, (that is "recess" the line of credit) or may reduce the maximum amount of credit available to Borrower under the Note (that is "reduce" the line of credit), without requiring acceleration repayment of the outstanding principal balance, upon the occurrence and during the continuation of any of the following events: (i) the value of the property decisions significantly below the property's appraised value for purposes of the Note; (ii) Lender's reasonable belief that Borrower will be unable to fulfill the payment obligations under the Note because of a material change in Borrower's financial condition; (iii) the occurrence of an Event of Default; or (iv) Lender is precluded by government action from imposing the interest rate priority of Lender's security interest in the Property or the line of credit under the Note; or (v) the priority of Lender's security interest in the Property or the line of credit under the Note is reduced to be less than 120% of the line of credit evidenced by the Note; (vi) Lender is notified by its regular agency that certain advances under the Note constitute an unsafe and unsound practice; or (vii) the maximum interest rate permitted to be charged by Lender under the Note is reached.

23. **ACTUAL KNOWLEDGE.** For purposes of this Mortgage and each of the other Credit Documents, Lender will not be deemed to have received actual knowledge of information required to be conveyed to Lender in writing by Borrower until the date of actual receipt of such information at 800 Waukegan Road, Glenview, Illinois 60025 (or such other address by Lender to Borrower). Such date shall be conclusively determined by reference to the "Received" date stamped on such written notice by Lender or Lender's agent. With regard to other events or information not provided by Borrower under the Credit Documents, Lender will be deemed to have actual knowledge if such event or information as of the date Lender receives a written notice of such event or information from a source Lender reasonably believes to be reliable, including but not limited to, a court or other governmental agency, institutional lender, or title company. 24. **TAXES.** In the event of the passage after the date of this Mortgage of any law changing in any way the laws now in force the taxation of mortgages, or debts secured thereby, or the manner of operation of such taxes, so as to affect the interest of Lender, then and in such event Borrower shall pay the full amount of such taxes.

25. **WAIVER OF STATUTORY RIGHTS.** Borrower shall not and will not apply for or avail itself of any homestead, appraisement, valuation, redemption, stay, extension, or exemption laws, or any so-called "moratorium laws", now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this mortgage, but hereby waives the benefits of such laws. Borrower, for itself and all who claim through or under it, waives any and all right to have the property and estates comprising the Property marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Property sold as an entirety. Borrower hereby waives any and all rights of redemption under any order or decree of foreclosure, pursuant to rights herein granted, on behalf of Borrower, all persons beneficially interested in the Property and each and every person acquiring any interest in or title to the Property or the Collateral subsequent to the date of this Mortgage, and on behalf of all other persons, to the extent permitted by Illinois law.

26. **EXPENSE OF LITIGATION.** In any suit to foreclose the lien of this Mortgage or enforce any other remedy of the Lender under this Mortgage or the Note or the Credit Documents there shall be allowed and included, as additional indebtedness in the judgment or decree, all expenditures and expenses which may be paid or incurred by or on behalf of Lender for attorney's fees, appraiser's fees outlays for documentary and expert evidence, stenographer's charges, publication costs, survey costs, and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all abstracts of title, title searches and examinations, title insurance policies, Torrens certificates, and similar data and assurances with respect to title as Lender may deem reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or value of the Property. All expenditures and expenses of the nature in this paragraph mentioned, and such expenses and fees as may be incurred in the protection of said Property and the maintenance of the lien of this Mortgage, including the fees of any attorney employed by Lender in any litigation or proceeding affecting this Mortgage, the Note or the Property or in preparation for the commencement or defense of any proceeding or threatened suit or proceeding, shall be immediately due and payable by Borrower, with interest thereon at the rate from time to time in effect under the Note with respect to revolving credit advances.


