and Stan Matoska and Sheryl Koca, as joint tenants with right of survivorship and not as tenants in common.

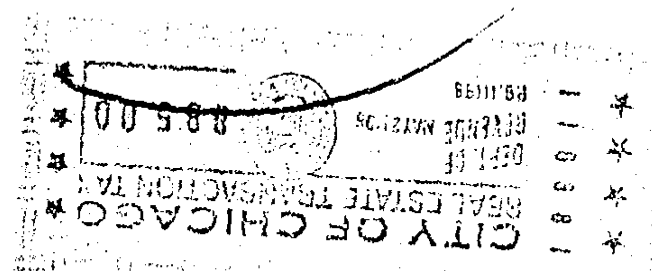
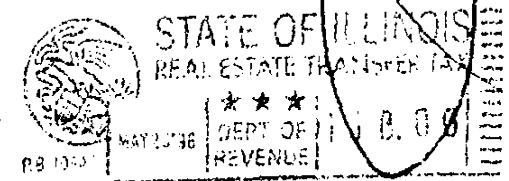
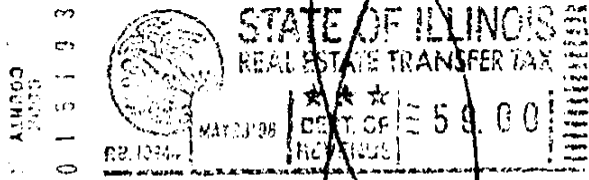
