AGREED ORDER

THIS CAUSE coming on to be heard by agreement of the parties, due notice having been given, the court being fully advised:

By agreement of the parties, IT IS HEREBY ORDERED THAT:

1. That DAVID MORROW acknowledges that he has received from SUZANNE MORROW the equivalent of forty-nine (49) months pre-paid child support commencing March 1, 1996, calculated in accordance with ILCS, Ch. 850, par. 5/505 of the Illinois Marriage and Dissolution of Marriage Act based on SUZANNE MORROW having a gross income of \$21,930 per year. This pre-payment arises from the provisions of this Agreed Order relative to division of property. In the event that the residential arrangements with respect to the minor children, THOMAS, having been born April 29, 1981, and TIFFANY, having been born April 26, 1982, are changed either by the parties' agreement or by a Court of competent jurisdiction, SUZANNE MORROW, shall not be entitled to any refund of the pre-paid child support.

2. That the obligation of DAVID MORROW to pay and the right of SUZANNE MORROW to receive the sum of \$15,000.00 as set forth in paragraph nine (9) of the Marital Settlement Agreement incorporated into the Judgment for Dissolution of Marriage entered in this cause.


