THIS CAUSE coming on to be heard by agreement of the parties, due notice having been given, the court being fully advised:

By agreement of the parties, IT IS HEREBY ORDERED THAT:

- That DAVID MORROW acknowledges that he has received from SUZANNE MORROW the equivalent of forty-nine (49) months pre-paid child support commencing March 1, 1996, calculated in accordance with ILCS, Ch. 850, par. 5/505 of the Illinois Marriage and Dissolution of Marriage Act based on SUZMNE MORROW having a gross income of \$21930 per year. This pre-perment arises from the provisions of this Agreed Order relative to division of property.
