REVOLVING MORTGACE, SECURITY AGREEMENT AND FINANCING STATEMENT

This REVOLVING MORTGAGE, SECURITY AGREEMENT AND FINANCING STATEMENT is made as of May 16. 1997 by LASA/LE NATIONAL BANK, a national banking association, whose address is 135 South La Salle Street, Suite 1840, Chicago, Illinois 60603, not personally, but solely as Successor Trustee (the "Mortgagor") to LaSalle National Trust, N.A., under a Trust Agreement dated October 13 1964 and known as Trust No. 31062 (the "Trust Agreement") to LASALLE NATIONAL BANK, a national banking association (the "Mortgagee"), whose address is 135 South La Salle Street, Suite 1225, Chicago, Illinois 60603.

WITNESSETH:

WHEREAS, the Mortgagor is justly indebted to the Mortgagee in the principal sum of Three Hundred Thousand and 00/100 Dollars (\$300,000,00), as evidenced by that certain Revolving Note dated May 16, 1997 (together with any and all notes issued in renewal thereof or in substitution or replacement therefor being collectively referred to herein as the "Note"), executed by the Mortgagor and made payable to the order of and delivered to the Mortgagee, in and by which Note the Mortgagor promises to pay the principal sum thereof, together with interest thereon prior to maturity or the occurrence of a Default (as hereinafter defined) at the per annum rate of interest announced from time to time by the Mortgagee as its Prime Rate (the "Interest Rate") and following maturity or the occurrence of a Default at the Interest Rate plus three percent per annum (the "Default Rate"). Each installment shall be paid at such

place as the holder of the Note may, from time to time, in writing appoint, and in the absence of such appointment, then at the office of the Mortgagee set forth above; and

NOW, THEREFORE, in consideration of the obligations and liabilities evidenced by the Note, and to secure the payment of the principal sum of money, and interest thereon in accordance with the terms, provisions and limitations of this Mortgage, and of the Note (the Note, this Mortgage and any and all other documents executed in connection therewith being collectively referred to herein as the "Loan Documents"), including any and all extensions, modifications and renewals of the Indebtedness (as hereinafter defined), and the performance of the covenants and agreements herein contained, by the Mortgagor to be performed, and also in consideration of the sum of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged, the Mortgagor does by these presents GRANT, MORTGAGE, WARRANT and CONVEY unto the Mortgagee, its successors and assigns, the following:

- (a) All that certain described real estate and all of its estate, right, title and interest therein, sinuate, lying and being in County of Cook, State of Illinois, which is more specifically described on Exhibit "A" attached hereto, which, with the property hereinafter described, is referred to herein as the "Premises";
- (b) All improvements, tenements, easements, fixtures, and appurtenances thereto belonging, and all rents, issues and profits thereof for so long and during all such times as the Mortgagor may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily);
- If and to the extent owned by the Mortgagor, all fixtures, fittings, furnishings, (c) appliances, apparatus, equipment and ruschinery now or hereafter installed on the Premises, including, without limitation, all gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, ovens clevators and motors, bathtubs, sinks, water closets, basins, pipes, faucets and other air conditioning, plumbing and heating fixtures, mirrors, mantles, refrigerating plants, retrigerators, iceboxes, dishwashers, carpeting, furniture, laundry equipment, cooking apparatus and appurtenances, and all building material, supplies and equipment now or hereafter delivered to the Premises and intended to be installed therein; all other fixtures and personal property of whatever kind and nature at present contained in or hereafter placed in any building standing on said Premises; such other goods, equipment, chattels and personal property as are usually furnished by landlords in letting other premises of the character of the Premises; and all renewals or replacements thereof or articles in substitution thereof: and all proceeds and profits thereof and all of the estate, right, title and interest of the Mortgagor in and to all property of any nature whatsoever, now or hereafter situated on the Premises or intended to be used in connection with the operation thereof;
- (d) All of the right, title and interest of the Mortgagor in and to any fixtures or personal property subject to a lease agreement, conditional sale agreement, chattel mortgage, or security agreement, and all deposits made thereon or therefor, together with the benefit of any payments now or hereafter made thereon;

- (e) All leases and use agreements of machinery, equipment and other personal property of the Mortgagor in the categories hereinabove set forth, under which the Mortgagor is the lessee of, or entitled to use, such items;
- (f) All rents, income (including income and receipts from the use and occupancy of any hotel rooms), profits, revenues, receipts, royalties, bonuses, rights, accounts, contract rights, general intangibles and benefits and guarantees under any and all leases, tenancies, licenses or other use agreements or arrangements now existing or hereafter created of the Premises or any part thereof (including any business conducted thereon) with the right to receive and apply the same to the Indebtedness due the Mortgagee and the Mortgagee may demand, sue for and recover such payments but shall not be required to do so:
- (g) All judgments, awards of damages and settlements hereafter made as a result of or in lieu of any taking of the Premises of any part thereof or interest therein under the power of eminent domain, or for any damage (whether caused by such taking or otherwise) to the Premises or the improvements thereon or any part thereof or interest therein, including any award for change of grade of streets,
- (h) All proceeds of the conversion, voluntary or involuntary of any of the foregoing into cash or liquidated status;
- (i) Any monies on deposit with the Mortgagee for the payment of real estate taxes or special assessments against the Premises or for the payment of premiums on policies of fire and other hazard insuranc: covering the collateral described hereunder or the Premises, and all proceeds paid for carrage done to the collateral described hereunder or the Premises;
- (j) All substitutions, replacements, additions and proceeds, including insurance and condemnation award proceeds, of any of the foregoing property; it being understood that the enumeration of any specific articles of property shall in no wise exclude of be held to exclude any items of property not specifically mentioned. All of the land, estate and property hereinabove described, real, personal and mixed, whether affixed or annexed or not (except where otherwise hereinabove specified) and all rights hereby conveyed and mortgaged are intended so to be as a unit and are hereby understood, agreed and declared to form a part and parcel of the real estate and to be appropriated to the use of the real estate, and shall be for the purposes of this Mor gaze deemed to be real estate and conveyed and mortgaged hereby.

As to any of the property aforesaid which (notwithstanding the aforesaid declaration and agreement) does not so form a part and parcel of the real estate, this Mortgage is hereby deemed to be, as well, a Security Agreement under the Uniform Commercial Code in effect in the jurisdiction in which the Premises are located (hereinafter referred to as the "UCC") for the purpose of creating hereby a security interest in such property, which the Mortgagor hereby grants to the Mortgagee as Secured Party (as said term is defined in the UCC), securing said Indebtedness and obligations and the Mortgagee shall have in addition to its rights and remedies hereunder all rights and remedies of a Secured Party under the UCC. As

to above personal property which the UCC classifies as fixtures, this instrument shall constitute a fixture filing and financing statement under the UCC.

The Mortgagor covenants for and on behalf of the beneficiaries of the Trust Agreement (collectively, the "Beneficiary") that (i) the Mortgagor is tawfully seized of the Premises, (ii) the Premises are subject only to the liens, encumbrances, conditions, restrictions, easements, and other matters, rights or interests disclosed in Exhibit "B" attached bereto and made a part hereof, and (iii) the Mortgagor has good right, full power and tawful authority to convey and mortgage the same and that it will warrant and forever defend said Premises and the quiet and peaceful possession of the same against the lawful claims of all persons whomsoever.

As used in this Mortgage, the term "Indebtedness" shall mean and include the principal sum evidenced by said Note, together with all interest and late charges thereon, any other payments one to the Mortgagee thereunder, and all other sums at any time secured by this Mortgage. Further, as used in this Mortgage, the term "Note" shall mean and include any renewals, more stions, extensions, amendments, substitutions and replacements thereof.

TO HAVE AND TO HOLD the Premises unto the Mortgagee, its successors and assigns, for the purposes and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

1. Maintenance, Repair and Restartion of Improvements, Payment of Prior Liens, etc.

The Mortgagor shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the Premizes which may become damaged or be destroyed; (b) keep said Premises in good condition and repair, without waste, and free from mechanics' liens or other liens or claims for lien not expressly subordinated to the lien hereof, other than any such liens which are being contested in a diligent and good faith manner by appropriate proceedings; (c) pay when due any indebtedness which may be secured by a lien or charge on the Premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (d) complete which a reasonable time any building or buildings now or at any time in process of erection upon said Premises; (e) comply with all requirements of law, municipal ordinances, or restrictions of record with respect to the Premises and the use thereof; (f) make no alterations in said Premises; (p) suffer or permit no change in the general nature of the occupancy of the Premises, without the Mortgagee's prior written consent; (i) pay each item of Indebtedness secured by this Mortgage when due according to the terms hereof or of said Note.

Payment of Taxes.

The Mortgagor shall pay, before any penalty attaches, all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the Premises when due, and shall, upon written request, furnish to the Mortgagee duplicate receipts therefor.

3. Tax Deposits.

Immediately upon the occurrence of a Default (as hereinafter defined), the Mortgagor covenants and agrees to deposit with the Mortgagee at the office of the Mortgagee set forth on the first page of this Mortgage, commencing on the first day of the calendar month following such request by the Mortgagee, and on the first day of each calendar month thereafter until the Indebtedness secured by this Mortgage is fully paid, a sum equal to one-twelfth of the last total annual taxes and general and/or special assessments (collectively, the "Taxes") for the last ascertainable year on said Premises (unless such Taxes are based upon assessments which exclude the improvements or any part thereof now constructed or to be constructed, in which event the priount of such deposits shall be based upon the Mortgagee's reasonable estimate as to the amount of Taxes to be levied and assessed). Such deposits shall be held without allowance for interest and shall be used for the payment of Taxes on said Premises next due and payable when they become due. If the funds so deposited are insufficient to pay the Taxes for any year when the same shall become due and payable, the Mortgagor shall, within ten (10) days after receipt of demand therefor, deposit such additional funds as may be necessary to pay the Taxes in full. If the funds so deposited exceed the amount required to pay the Taxes for the year, the excess shall be applied on a subsequent deposit or deposits. Said deposits need not be kept separate and apart from other funds of the Mortgagee.

Anything in this Section 3 to the contrary notwithstanding, if the funds so deposited are insufficient to pay the Taxes or any instrument thereof, the Mortgagor will, not later than thirty (30) days prior to the last day on which the same may be paid without penalty or interest, deposit with the Mortgagee the full amount of any such deficiency.

If any Taxes shall be levied, charged, assessed or imposed upon or for the Premises, or any portion thereof, and if such Taxes shall also be a levy, charge, assessment or imposition upon or for any other premises not covered by the lien of also. Mortgage, then the computation of any amount to be deposited under this Section 3 shall be based upon the entire amount of such Taxes, and the Mortgagor shall not have the right to appearing the amount of any such taxes or assessments for the purpose of such computation.

4. Mortgagee's Interest In and Use of Deposits.

In the event of a Default hereunder or the Note secured hereby, the Morgagee may at its option, without being required to do so, apply any monies at the time of deposit pursuant to Section 3 and Section 5 hereof, on any of the Mortgagor's obligations herein or in said Note contained, in such order and manner as the Mortgagee may elect. When the Indebtedness secured hereby has been fully paid, any remaining deposits shall be paid to the Mortgagor or to the then owner of the Premises. A security interest within the meaning of the UCC is hereby granted to the Mortgagee in and to any monies on deposit pursuant to Section 3 and Section 5 hereof, as additional security for the Indebtedness hereunder and shall be applied by the Mortgagee for the purposes made hereunder and shall not be subject to the direction or control of the Mortgagor; provided, however, that the Mortgagee shall not be liable for any

failure to apply to the payment of taxes, assessments and insurance premiums any amount so deposited unless the Mortgagor, while not in Default hereunder, shall have requested the Mortgagee in writing to make application of such funds to the payment of the particular taxes, assessments and insurance premiums for payment of which they were deposited, accompanied by the bills for such taxes, assessments and insurance premiums. The Mortgagee shall not be liable for any act or omission taken in good faith or pursuant to the instruction of any party but shall be liable only for its gross negligence or willful misconduct.

5. <u>Insurance</u>.

The Mortgagor shall keep all buildings and improvements now or hereafter situated on the Premises insured against loss or damage by policies of All Risk Replacement Cost Insurance with an Agreed Amount Endorsement and such other appropriate insurance, all in form and substance satisfactory to the Mortgagee, including, without limitation, rent insurance, business interruption insurance, flood insurance (if and when the Premises lie within an area designated by an agency of the federal government as a flood risk area) and war risk insurance whenever in the opinion of the Mortgagee such protection is necessary and such war risk insurance is obtainable from an agency of the United States Government. The Mortgagor shall also provide liability insurance with such limits for personal injury and death and property damage as the Mortpagee may require. All policies of insurance to be furnished hereunder shall be in forms, companies and amounts satisfactory to the Mortgagee, each insurer to have a Best's rating of A+. V, with mortgagee clauses attached to all policies in favor of and in form satisfactory to the Mortgagee, including a provision requiring that the coverage evidenced thereby shall not be arminated or materially modified without ten (10) days prior written notice to the Mortgagee. To Mortgagor shall deliver all policies including additional and renewal policies, to the Mortgagee, and, in the case of insurance about to expire, shall deliver renewal policies not less than ten (10) days prior to their respective dates of expiration.

The Mortgagor shall not take out separate insurance consument in form or comributing in the event of loss with that required to be maintained hereunder unless the Mortgagee is included thereon under a standard mortgagee clause acceptable to the Mortgagee. The Mortgagor shall immediately notify the Mortgagee whenever any such separate insurance is taken out and shall promptly deliver to the Mortgagee the policy or policies of such insurance.

Upon the occurrence of a Default hereunder and following request by the Mortgagee, the Mortgagor shall deposit with the Mortgagee, beginning on the first day of the calendar month following such request by the Mortgagee and continuing on the first day of each month thereafter, an amount equal to the premiums that will next become due and payable on such policies divided by the number of months to elapse prior to the date when such premiums become delinquent. No interest shall be payable on such deposits, and such deposits need not be kept in a separate account.

6. Adjustment of Losses With Insurer and Application of Proceeds of Insurance.

In case of loss or damage by fire or other casualty, the Mortgagee is authorized (a) to settle and adjust any claim under insurance policies which insure against such risks, or (b) to allow the Mortgagor to agree with the insurance company or companies on the amount to be paid in regard to such loss. In either case, the Mortgagee is authorized, to collect and issue a receipt for any such insurance money. At the option of the Mortgagee, such insurance proceeds shall be applied either to reduce the Indebtedness secured hereby or to reimburse the Mortgagor for the cost of rebuilding and restoration. Irrespective of whether such insurance proceeds are used to reimburse the Mortgagor for the cost of said rebuilding or restoration or not, and irrespective of whether such insurance proceeds are or are not adequate for such purpose, the buildings and improvements shall be so restored or rebuilt so as to be of at least equal value and substantially the same character as prior to such damage or destruction. If the cost of rebuilding, repairing or restoring the building and improvements can reasonably exceed the sum of Twenty Five Thousand and 00/100 Dollars (\$25,000.00), then the Mortgagee shall approve plays and specifications of such work before such work shall be commenced. In any case, where the insurance proceeds are used for rebuilding and restoration, such proceeds shall be disbursed in the aranner and under the conditions that the Mortgagee may require and upon the Mortgagee being furnished with satisfactory evidence of the estimated cost of completion thereof and with architect's certificates, waivers of lien, contractor's and subcontractors' sworn statements and other evidence of cost and payments so that the Mortgagee can verify that the amounts disbursed from time to time are represented by completed and in place work and that said work is free and clear of mechanics' lien claims. If the estimated cost of completion exceeds the amount of the insurance proceeds available, the Mortgagor immediately shall, on written demand of the Mortgagee, deposit with the Mortgagee in cash the amount of such estimated excess cost. No payment made prior to the final completion of the work shall exceed ninety percent (90%) of the value of the work performed from time to time, and at all times the undisbursed balance of such proceeds remaining in the hands of the disbursing party shall be at least sufficient to pay for the cost of completion of the work free and clear of liens. Any surplus which may remain out of said insurance proceeds after payment of such cost of building or restoration shall, at the option of the Mortgagee, be applied on account of the Indebtedness secured hereby or be paid to any party entitled thereto without interest.

7. Stamp Tax.

If, by the laws of the United States of America, or of any state having jurisdiction over the Mortgagor, any tax is due or becomes due in respect of the issuance of the Note hereby secured, the Mortgagor covenants and agrees to pay such tax in the manner required by any such law. The Mortgagor further covenants to reimburse the Mortgagee for any sums which the Mortgagee may expend by reason of the imposition of any tax on the issuance of the Note secured hereby.

8. Lease of Premises.

As additional security for the payment of the Note secured hereby and for the faithful performance of the terms and conditions contained herein, the Mortgagor, as landlord, has assigned to the Mortgagee all of its right, title and interest as landlord in and to all existing

le ises and occupancy agreements with respect to the Premises. All future leases of the Premises are subject to the approval of the Mortgagee as to form, content and tenants.

The Mortgagor shall not, without the Mortgagee's prior written consent, make any lease of all or any part of the Premises, provided, however, that if any such lease is consented to by the Mortgagee, the Mortgagor shall not, without the further prior written consent of the Mortgagee, (i) execute an assignment or pledge of any rents of the Premises and/or any leases of the Premises; or (ii) accept any prepayment of any installment of any rents more than thirty (30) days before the due date of such installment.

The Mortgagor, at its sole cost and expense, shall (i) at all times promptly and faithfuily abide by, discharge and perform all of the material covenants, conditions and agreements contained in all leases or occupancy agreements of the Premises, on the part of the landlord the cunder to be kept and performed, following any applicable grace or cure period; (ii) enforce of secure the performance of all of the material covenants, conditions and agreements of such leases on the part of the lessee or occupant to be kept and performed; (iii) appear in and defend any action or proceeding arising under, growing out of or in any manner connected with such lesses or occupancy agreements or the obligations, duties or liabilities of landlord or of the lessees thereunder; (iv) furnish the Mortgagee, within twenty (20) days after a request by the Mortgagee to do so, a written statement containing the names of all lessees or occupants, terms of all leases or occupancy agreements of the Premises, including the spaces occupied and the rentals payable thereunder; (v) exercise within five (5) days of any demand therefor by the Mortgagee any right to request from the lessee under any lease of the Premises a certificate with respect to the status thereof, and (vi) not permit any leases of the Premises to become subordinate to any lien on the Premises without the prior written consent of the Mortgagee, and will include in each lease or occupancy agreement of the Premises a provision whereby the tenant thereunder covenants that it will not subordinate its leasehold interest therein to any lien on the Premises without the prior written consent of the Mortgagee.

Nothing in this Mortgage or in any other document relating to the loan secured bereby shall be construed to obligate the Mortgagee, expressly or by implication, to perform any of the covenants as landlord under any of the leases or occupancy agreements assigned to the Mortgagee or to pay any sum of money or damages therein provided to be paid by the landlord, each and all of which covenants and payments the Mortgagor agrees to perform and pay. Utiless waived by the Mortgagee, all leases of space in the Provises shall have subordination provisions, in form and substance reasonably satisfactory to the Mortgagee, subordinating the interest of the tenants under such leases to this Mortgage, and all renewals, modifications, consolidations, replacements and extensions hereof and shall have attornment and noncancellation clauses in form and substance reasonably satisfactory to the Mortgagee. Until the Indebtedness and other sums secured by this Mortgage are paid in full, the Mortgagee reserves the right to require that specific leases be made either superior to or inferior to the lien of this Mortgage.

In the event of the enforcement by the Mortgagee of the remedies provided for by law or by this Mortgage, the lessee or occupant under each lease or occupancy agreement of the Premises shall attorn to any person succeeding to the interest of the Mortgagor as a result of

such enforcement and shall recognize such successor in interest as landlord under such lease without change in the terms or other provisions thereof; provided, however, that said successor in interest shall not be bound by any payment of rent or additional rent for more than one month in advance, and shall not be bound by any amendment or modification to any lease made without the consent of the Mortgagee or said successor in interest. Each lessee, upon request by said successor in interest, shall execute and deliver an instrument or instruments confirming such attornment.

The Mortgagee shall be entitled to cure any default of landlord, within any applicable grace or cure period, in any lease of the Premises, and the cost to effect any curing of default (including reasonable attorneys' fees), together with interest thereon at the Default Rate shall be so much additional Indebtedness secured hereby and shall be immediately due and payable without notice.

9. Effect of Extensions of Time.

If the payment of said Indebtedness or any part thereof is extended or varied or if any part of any security for the payment of the Indebtedness is released or additional security is taken, all persons now or at any time hereafter liable therefor, or interested in said Premises, shall be held to assent to such extension, variation, or taking of additional security or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding such extension, variation, taking of additional security or release.

10. Effect of Changes in Laws Regarding Taxation.

In the event of the enactment after this date of any law of the state in which the Premises are located deducting from the value of the land for the purpose of taxation any lien thereon, or imposing upon the Mortgagee the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by the Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the Mortgagee's interest in the Premises, or the manner of collection of taxes, so as to affect this Mortgage or the debt secured hereby or the holders thereof, then, and in any event, the Mortgagor, upon demand by the Mortgagee, shall pay such taxes or assessments, or reimburse the Mortgagee therefor; provided, however, that if in the opinion of counsel for the Mortgagee (a) it might be unlawful to require the Mortgagor to make such payment or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, the Mortgagee may elect, by notice in writing given to the Mortgagor, to declare all of the Indebtedness secured hereby to be and become due and payable sixty (60) days from the giving of such notice.

11. Mortgagee's Performance of Defaulted Acts.

In the event of a Default hereunder, the Mortgagee may, but need not, make any payment or perform any act herein required of the Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on

prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said Premises or consent to any tax or assessment or cure any default of landlord in any lease of the Premises. All monies paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other monies advanced by the Mortgagee in regard to any stamp tax or any leases of the Premises or to protect the Premises and the lien hereof, shall be so much additional Indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at the Default Rate. Inaction of the Mortgagee shall never be considered as a waiver of any right accruing to it on account of any Default hereunder.

12. Mortgagee's Reliance on Tax Bills, Etc.

The Mortgagee in making any payment hereby authorized: (a) relating to taxes and assessments, may do so according to any bill, statement or estimate procured from the appropriate public order without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof; or (b) for the purchase, discharge, compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.

13. Acceleration of Indebtedness in Case of Default.

The occurrence of any one or more of the following shall constitute a Default under this Mortgage (a "Default"):

- (a) default shall be made in the due and punctual payment of the Note secured hereby, either of principal or interest, or any other payment due in accordance with the terms of any of the other Loan Documents;
- (b) default shall be made in the due observance of performance of any of the covenants, agreements or conditions contained herein, and such default in performance continues for a period of thirty (30) days after the Mortgagor has received notice or knowledge from any source of such default in performance (the "leital Cure Period"), provided, however, that if such default is not susceptible of cure within the Initial Cure Period, it shall be a Default hereunder if the Mortgagor fails to comments, to cure such default within the Initial Cure Period or fails to diligently proceed to cure such default within an additional period of ninety (90) days;
- (c) default shall be made in the due observance or performance of any of the covenants, agreements or conditions contained in the Note or any of the other Loan Documents, and such default in performance continues beyond any notice and cure periods provided therein;
- (d) default shall be made in the due payment, observance or performance of any of the covenants and agreements or conditions contained in any other agreements or financing arrangements now existing or hereafter entered into between the Mortgagor

and the Mortgagee, or between the Mortgagor and any other party, and such default continues beyond any notice and cure periods provided therein;

- (e) any of the Mortgagor, the Beneficiaries or any guarantor of the Note (collectively referred to herein as an "Obligor") shall file a petition seeking relief under the Federal Bankruptcy Code (11 U.S.C. 101 et seq.) or any similar law, state or federal, whether now or hereafter existing, or any answer admitting insolvency or inability to pay its or their debts, or fail to vacate or obtain a stay of any involuntary proceedings under any such bankruptcy or insolvency statute within thirty (30) days;
- (f) an order for relief shall be entered in an involuntary case against any Obligor, or a trustee or a receiver shall be appointed for any Obligor, or for all or any part of the property of any Obligor in any involuntary proceeding, or any court shall have taken jurisdiction of all or any part of the property of any Obligor in any voluntary or involuntary proceeding for the reorganization, dissolution, liquidation or winding up of such Obligor, and in the case of an involuntary proceeding, such trustee or receiver shall not be discharged or such jurisdiction relinquished or vacated or stayed on appeal or otherwise stayed within thirty (30) days;
- (g) any Obligor shall make an assignment for the benefit of creditors, or shall admit in writing its inability to pay its debts generally as they become due, or shall consent to the appointment of a receiver or mustee or liquidator of all or any part of its property;
- (h) any event occurs or condition (xists which constitutes a default, following any applicable grace or cure period, under any of the Loan Documents;
- (i) an unpermitted transfer as described in Section 31 of this Mortgage shall occur.

Upon the occurrence of a Default, the whole of the Indibtedness hereby secured shall, at once, at the option of the Mortgagee, become immediately due and payable without notice to the Mortgagor. 15. Application of Proceeds of Foreclosure Sale.

16. Appointment of Receiver.

The Mortgagee shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under any leases. 18. Application of Income Received by Mortgagee.

Any sale, conveyance, assignment, Idelge, hypothecation, mortgage, encumbrance, lease (other than for actual occupancy as conserved to by the Mortgagee or the Mortgagor as provided herein) or other transfer of title to the Premises, or any interest therein, including, without limitation, the beneficial interest of the Beneficiary in the Premises, or any portion thereof, or of any entity or any person owning, directly or indirectly, any interest therein (whether voluntary or by operation of law) without the Mortgagoe's prior written consent shall be deemed to be an unpermitted transfer of title to the Premises and therefore a Default hereunder.

It is understood and agreed that the Indebtedness secured hereby was created solely due to the financial sophistication, creditworthiness, background and business sophistication of the Mortgagor, and the Mortgagee continues to rely upon same as the means of maintaining the value of the Premises. It is further understood and agreed that any junior financing placed upon the Premises or the improvements located thereon, or upon the interests of the Mortgagor may divert funds which would otherwise be used to pay the Indebtedness secured hereby, and could result in acceleration and/or foreclosure by any such junior lienor. 32. Future Advances.

The Mortgager hereby agrees to execute any and all supplemental notes, agreements or other documents as the Mortgagee may reasonably request to evidence such future advances, which such supplemental notes, agreements or other documents shall be similar in form and substance to the existing notes, agreements and other documents from the Mortgagor in favor of the Mortgagee.

33. Enforceability.

This Mortgage and the inceptedness arising hereunder shall be governed by, and construed in accordance with, the internal laws of the State of Illinois applicable to contracts made and performed in such State and any applicable laws of the United States of America.

34. <u>Illinois Mortgage Foreclosure Act.</u>

The Mortgagee shall have the benefit of any any exercise any and all of the rights and remedies set forth in the Illinois Foreclosure Act, 735 U.SS 5/15, et seq. (the "Foreclosure Act"), as amended from time to time, and such provisions of the Foreclosure Act are incorporated herein by express reference.

35. Revolving Credit Arrangement..

This Mortgage is given to secure a revolving credit loan and shall secure not only the existing Indebtedness, but also future advances, whether such advances are obligatory or are to be made at the option of the Mortgagee, or otherwise, as are made within twenty (20) years from the date hereof, to the same extent as if such future advances were made on the date hereof. The total amount of the Indebtedness secured hereby may increase or decrease from time to time, but the total unpaid balance so secured at any one time shall not exceed the maximum principal amount of \$15,000,000 plus interest thereon and any disbursements which are made for the payment of taxes, special assessments or insurance on the Premises or other disbursements as provided for herein.

36. Miscellaneous.

This Mortgage and all provisions hereof, shall extend to and be binding upon the Mortgagor and its successors, grantees and assigns, any subsequent owner or owners of the

Premises, and all persons claiming under or through the Mortgagor, including, but not limited to, the Beneficiary, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the Indebtedness or any part thereof, whether or not such persons shall have executed the Note or this Mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of the Mortgagee named herein, and the holder or holders, from time to time, of the Note secured hereby.

In the event one or more of the provisions contained in this Mortgage or the Note secured hereby or in any other security documents given to secure the payment of the Note secured hereby shall for any reason be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall, at the option of the Mortgagee, not affect any other provision of this Mortgage, and this Mortgage shall be construed as if such invalid, illegal or unenforceable provision had never been contained herein or therein.

No offset or claim that the Mortgagor now has or may have in the future against the Mortgagee shall relieve the Mortgagor from paying any amounts due under the Note secured hereby or from performing any other obligations contained herein or secured hereby.

The Mortgagor shall not by act or omission permit any building or other improvement on the Premises not subject to the lien of this Mortgage to rely on the Premises or any part thereof or any interest therein to 6.1511 any municipal or governmental requirement, and the Mortgagor hereby assigns to the Mortgagee any and all rights to give consent for all or any portion of the Premises or any interest therein to be used. Similarly, no building or other improvement on the Premises shall rely or any premises not subject to the lien of this Mortgage or any interest therein to fulfill any governmental or municipal requirement. The Mortgagor shall not by act or omission impair the integrity of the Premises as a single zoning tot separate and apart from all other premises. Any zet or omission by the Mortgagor which would result in a violation of any of the provisions of this Section shall be void.

The Mortgagor, upon written request from the Morgagee, will furnish a signed statement of the amount of the Indebtedness secured hereby and whether or not any Default then exists hereunder and specifying the nature of any such Default.

The Mortgagee shall have the right at its option to foreclose this Mortgage subject to the rights of any tenant or tenants of the Premises and the failure to make any such tenant or tenants a party defendant to any such civil action or to foreclose their rights will not be asserted by the Mortgagor as a defense in any civil action instituted to collect the Indebtedness secured hereby, or any part thereof or any deficiency remaining unpaid after foreclosure and sale of the Premises, any statute or rule of law at any time existing to the contrary notwithstanding.

At the option of the Mortgagee, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority of entitlement to insurance proceeds or any award in condemnation) to any and all leases of all or any part of the Premises upon the execution by the Mortgagee and recording or registering thereof, at any time hereafter, in the

office wherein this Mortgage was recorded or registered, of a unilateral declaration to that effect.

Any property management agreement in effect for the Premises with any other property manager shall contain a "no lien" provision whereby the property manager waives and releases, to the extent permitted by law, any and all mechanics' lien rights, if any, that it or anyone claiming through or under it may have pursuant to applicable law. Such property management agreement or a short form thereof shall, at the Mortgagee's request, be recorded with the Office of the Recorder of Deeds for the county in which the Premises are located. In addition, the Mortgagor shall cause such other property manager to enter into a subordination agreement with the Mortgagee, in recordable form, whereby the property manager subordinates, to the extent permitted by law, its present and future lien rights and those of any party claiming by, through or under it, to the lien of this Mortgage. The Mortgagor's failure to require the "no lien" provision or the subordination agreement described herein shall constitute a Default hercunder.

The terms "Mortgage", "Security Agreement" and "Mortgage and Security Agreement" wherever used herein or in the Note secured hereby or in any other instrument evidencing or securing the Note secured hereby shall mean this Mortgage and the Security Agreement herein contained or any other security agreement securing the Note, as the context may so require.

37. <u>Trustee's Exculpation</u>.

This Mortgage is executed by LaSalle National Bank (the "Trustee"), not personally but solely as Trustee in the exercise of the power and authority conferred upon and vested in it as such Trustee (and said Land Trustee hereby warrants that it possesses full power and authority to execute this instrument). It is expressly understood and agreed that all of the warranties, indemnities, representations, covenants, undertakings and agreements berein made on the part of the Trustee are undertaken by the Trustee solely in its capacity as trustee and not personally. It is further understood and agreed that the Trustee merely holds title to the Premises and has no agents, employees or control over the management of the Premises and no knowledge or of other factual matters except as represented to the Trustee by the Beneficiary. No personal liability or personal responsibility is assumed by or shall at any time by asserted or enforceable against the Trustee on account of any warrang, indemnity. representation, covenant, undertaking or agreement of the Trustee in this Mortgage, all such liability being expressly waived by the Mortgagee and by every person now or hereafter claiming any right or security hereunder; and the owner of any of the Indebtedness or cause of action for breach of any warranty, indemnity, representation, covenant, undertaking or agreement accruing hereunder shall look solely to the Trust estate or the Premises conveyed for the payment thereof, by the enforcement of the lien hereby created, in the manner herein and in the Note provided or by action to enforce the personal liability of any guarantor.
