TOGETHER with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances and rents all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereimafter referred to as the "Property."

- 17. Acceleration; Remedies. Except as provided in paragraph 16 hereof, upon Borrower's breach of any covenant or agreement of Borrower in this Mortage, including the covenants to pay when due any sums secured by this Mortage, Lender prior to acceleration shall give a tick to Borrower as provided in paragraph 12 hereof specifying: (1) the breach; (2) the action required to cure such breach; (3) a date, not less than 10 days from the date the notice is mailed to Borrower, by which such breach must be cure; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the sums scan ed by this Mortage, foreclosure by judicial proceeding, and sale of the Property.
