MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED MAY 19, 1997, BETWEEN Do Young Han and Chon Ok Han, husband and wife, (referred to below as "Grantor"), whose address is 7506 Arcadia, Morton Grove, IL 60053; and Korea First Bank, Chicago (referred to below as "Lender"), whose address is 205 N. MORTGAGE. Grantor and Lender have entered into a mortgage dated May 19, 1994 (the "Mortgage") recorded in Cook County, State of Illinois as follows:

Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the

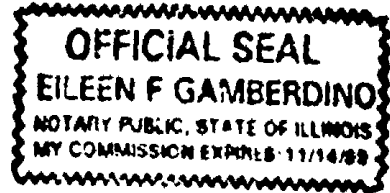
