

THIS MORTGATE made and entered into this 30th day of May, 1997, by and between ANNA PLATOS (herein, together with her successors, assigns and heirs, including each person now or hereafter claiming any interest in the Premises hereinafter referred to, collectively referred to as "Mortgagor"), as Grantor and Mortgagor, to ARCHER BANK, an Illinois banking corporation, whose address is 4970 S. Archer Avenue, Chicago, Illinois 60632 herein together with its successors of 25°, 2018, called "Mortgagee").

WITNESSETH:

WHEREAS, Mortgagor is the owner in the of those certain pieces, parcels or tracts of real property and the improvements located thereon, situated in the City of Chicago, Cook County, Illinois, and commonly known as 6520 653. W. Archer Avenue, Chicago, Illinois, and more fully described in Exhibit "A" attached hereto and made a part hereof (hereinafter referred to as the "Mortgaged Premise").

WHEREAS, Mortgagor, along with Bank of Chicago, not pervorally but as Trustee under a Trust Agreement dated May 19, 1986 and known as Trust No. 86-5-6, has executed and delivered to Mortgagee (herein, together with its successors and assigns, including each and every owner and holder of Now evereinafter sometimes also referred to as "Lender" or "Holder") a Promissory Note dated as of the date hereof, hereing a fixed rate of interest as therein stated, in the principal sum of \$540,000.00, payable to the order of Mortgagee (collectively hereinafter referred to as the "Note"); and

WHEREAS, the indebtedness evidenced by the Note, including the principal thereof and interest and premium, if any, thereon and all extensions and renewals thereof in whole or in part and any and all other sums which may at any time be due and owing or required to be paid as provided for in the Note or herein, and any other indebtedness of the Mortgagor, payable to the Mortgagor, evidenced by a promissory note, or a purposity of a promissory note, executed and delivered by Mortgagor while the Note remains unpaid, stating that said in the detences is secured by this Mortgagor, including the principal thereof and interest and premium, if any, thereon and all extensions and renewals thereof in whole or in part and any and all other sums which may at any time be due and owing or required to be paid as provided for in said promissory note or herein, are herein called the "Indebtedness Hereby Secured." At no time shall the principal amount of the Indebtedness Hereby Secured, not including the sums advanced in accordance herewith to protect the security of this Mortgagor, exceed the original amount of the Note, plus ONE MILLION (\$1,000,000.00) DOLLARS.

WHEREAS, any entity, person, firm or corporation taking a junior mortgage, or other lies or interest in and upon the Premises secured hereby or any part thereof or any interest therein, shall take the said lies subject to the rights of Mortgagee to amend (including, without limitation, changing the rate of interest, manner of computation thereof, due date), modify, extend or release the Note, this Mortgage, or any other document or instrument

evidencing, securing or guarantying the Indebtedness Hereby Secured, in each and every case without notice and consent of the holder of such junior lien and without the lien of this Mortgage losing its priority over the rights of any such junior lien, except as otherwise expressly provided in a separate Subordination Agreement by and between the Mortgagee and the holder of such junior lien.

NOW, THEREFORE:

GRANTING AND PLEDGING PROVISIONS

For good and valuable consideration, including the Indebtedness Hereby Secured herein recited, the receipt of which is hereby acknowledged, Mortgagor does hereby ABSOLUTELY AND UNCONDITIONALLY GRANT, DEMISE, CONVEY, ALIEN, TRANSFER, and MORTGAGE unto the Mortgagee and its successors and assigns forever, under and subject to the terms and conditions herein set forth, all and sundry the rights, interest, and property hereinafter described (herein together called the "Premises"), to-wit:

- (a) Ail of the real estate described in Exhibit "A" attached hereto and made a part hereof in fee simple;
- (b) All right title, and interest of Mortgagor in and to any other rights, interests or greater estate in the Premises or other rights and properties comprising the Premises, now owned or hereafter acquired by Mortgagor;
- (c) All buildings and other inconvenients now or at any time hereafter constructed or erected upon or located on the Premises, together with all test ments, easements, fixtures and appartenances thereto belonging (the Fee Parcel being herein called the "Real Estate"), together with and including, but not limited to, all fixtures, equipment, machinery, appliances and other articles and attachments now or hereafter forming part of, attached to, or incorporated in any such buildings or improvements (all berein generally called the "Improvements");
- (d) All privileges, reservations, allowances, har ditaments, tenements, and appurtenances now or hereafter belonging or pertaining to the Real Estate or Improvement.
- (e) All estates, right, title, and interest of Montgagor in ray and all leases, subleases, arrangements or agreements relating to the use and occupancy of the Real Estate and Improvements or any portion thereof, now or hereafter existing or entered into (all herein generally called "Leases"), togethat with all cash or security deposits, advance rentals and other deposits or payments of similar nature given in connect; m with any Leases;
- (f) All rents, issues, profits, royalties, income, avails and other benefits now or bereafter derived from the Real Estate and Improvements, under Leases or otherwise (all herein generally called "Rents"), subject to the right, power and authority given to the Mortgagor in the Absolute and Unconditional Assignment of Leases and Rents hereinafter referred to, to collect and apply the rents;
- (g) Any interests, estates or other claims, both in law and in equity, which Mortgagor now has or may hereafter acquire in the Real Estate or Improvements or other rights, interests or properties comprising the Premises now owned or hereafter acquired;
- (h) All right, title, and interest of Mortgagor now owned or hereafter acquired in and to (i) any land or vaults lying within the right-of-way of any street or alley, open or proposed, adjoining the Real Estate; (ii) any and all alleys, sidewalks, strips and gores of the land adjacent to or used in connection with the Real Estate and Improvements; (iii) any and all rights and interests of every name or nature forming part of or used in connection with the Real Estate and/or the operation and maintenance of the Improvements; and (iv) all easements, rights-of-way and rights used in connection with the Real Estate or Improvements or as a means of access thereto;

(i) All the estate, interest, right, title or claim or demand which Mortgagee now has or may hereafter have or acquire with respect to (i) the proceeds of insurance in effect with respect to the Premises; and (ii) any and all awards, claims for damages and other compensation made for or consequent upon the taking by condemnation, eminent domain or any like proceedings, or by any proceeding or purchase in lieu thereof, of the whole or any part of the Premises, including, without limitation, any awards and compensation resulting from a change of grade of streets and awards and compensation for severance damages (all herein generally called "Awards"):

TO HAVE AND TO HOLD the Premises and each and every part thereof unto the Mortgagee, its successors and assigns forever, for the purposes and upon the uses herein set forth.

- (2) The equal and ratable payment of principal and interest and premium, if any, on the Note and all modifications, (att usions and renewals thereof, according to their tenor and effect, without preference or priority of principal over interest over principal;
 - (b) Payment of all other Indebtedness Hereby Secured with interest thereon;
- (c) Performance by Mortgagor of all obligations of Mortgagor hereunder and all agreements of Mortgagor incorporated by reference forein or contained herein whether or not the Mortgagor shall be personally obligated or liable therefor;
- (d) Performance and observace: of all the terms, provisions, conditions, and agreements on Mortgagor's part to be performed and observed value and pursuant to that certain Absolute and Unconditional Assignment of Leases and Rents dated the date hereof (havin called the "Absolute Assignment of Rents") and Real Estate Tax Escrow Agreement (hereinafter "Tax Escrow") dated the date hereof from Mortgagor to Mortgagee given as security for the Indebtedness Hereby Secured;
- (e) Payment of all sums advanced by Holder to perform any of the covenants and agreements of Mortgagor hereunder or otherwise advanced by Mortgagee or any holder or holders pursuant to the provisions hereof to protect, enforce, and preserve the Premises and/or the lien hereof, together with interest on all such sums at the Default Rate specified in the Note (herein called the "Default Rate"), it being intended and agreed that all such sums with interest thereon being for all purposes hereof deemed so much additional bushedness Hereby Secured.

(The Note, this Mortgage, the Absolute Assignment of Rents, and the Tax Escrow Agreement are berein together called the "Loan Documents").

PROVIDED. NEVERTHELESS, and these presents are on the express condition that if the Anigagor shall pay when due the Indebtedness Hereby Secured and shall duly and timely perform and observe all of the terms, provisions, covenants, and agreements herein and in the other Loan Documents provided to be performed and observed by the Mortgagor, then this Mortgage and the estate, right, and interest of the Mortgagee in the Premises shall cease and become void and of no effect, otherwise to remain in full force and effect.

AND the Mortgagor does hereby further covenant and agree as follows:

1. The Mortgagor will (a) pay when due the principal of and interest and premium, if any, on the Indebtedness Hereby Secured, and all other sums which may become due pursuant thereto, hereto and all other Loan Documents (all of which shall constitute additional Indebtedness Hereby Secured); (b) duly and punctually perform and observe all of the terms, provisions, conditions, covenants, and agreements on the Mortgagor's part to be performed or observed as provided herein or in the Note, any other note or guaranty executed and delivered by

Mortgagor to Mortgagee, or other Loan Documents (and this Mortgage shall secure such payment, performance and observance); (c) pay when due all indebtedness secured by a lien upon the Premises, whether such lien is prior to, on a parity with or subordinate to the lien hereof, and perform and observe all of the terms, provisions, and conditions contained in all instruments creating such liens or evidencing or securing any indebtedness secured thereby, provided that nothing in this Subsection (c) shall be deemed a consent to the existence of any such liens or to vary the provisions of Section 20 hereof; (d) at all times duly and punctually perform and observe all of the terms, provisions, and conditions on Mortgagor's part as Lessor to be performed and observed under any Lease to the end that no default shall exist under the Lease; and (e) not cause, suffer or permit to exist any default under or event or condition which would itself or with the passage of time or the giving of notice, or both, constitute a default under any Lease, or any Easement or entitle the Lessee thereunder to terminate the Lease or the owner of paramount title to any Easement Parcels to terminate the same.

- 2. The Mortgagor will (a) promptly repair, restore or rebuild any building or improvement now or hereafter on the Premises which may become damaged or be destroyed; (b) keep the Premises in good condition and repair, without waste, and five from mechanics', materialmen's or laborer's liens or other liens or claims for lien; (c) complete, within a re-so able time, any building or buildings now or at any time in the process of erection upon the Premises; (d) comply win oll requirements of law, municipal ordinance or restrictions of record with respect to the Premises and the use thereof; (2) make or permit no material alterations in the Premises except as required by law or ordinance without the prior mitten consent of the Holder; (f) comply with all provisions and conditions on Lessor's part to be performed under Drases of the Premises; (g) suffer or permit no change in the general nature of the occupancy of the Premises; (n) not, without Mortgagee's consent, initiate or acquiesce in any zoning reclassification with respect to the Premi es; (i) suffer or permit no unlawful use of, or musance to exist upon, or waste of the Premises; and, (1) not remove any wienhone wiring or equipment installed within the Premises if to do so would materially damage or destroy any portion of the Premises unless Mortgagor first deposits such sums with the Mortgagee or any holder as may be required to restore the Premises to its pre-existing condition. Notwithstanding anything herein contained to the contrary, a longagor shall have the right to contest any mechanic's lien placed upon the property, provided that Mortgagor shall obtain title insurance over said mechanic's lien covering the interest of Mortgagee in said property.
- 3. Except as permitted in Section 21 hereof, the Mortgago, will not create or suffer or permit any lien, charge or encumbrance to attach to the Premises, other than permitted title exceptions, whether such lien or encumbrance is inferior or superior to the lien of this Mortgage, excepting only the lien of real estate taxes and assessments not due or delinquent.
- 4. The Mortgagor will pay all general taxes before any penalty or interest . Inches, and shall pay special taxes, special assessments, water charges, sewer service charges, and all other charges at a just the Premises of any nature whatsoever when due, and will, upon written request, furnish to Mortgagee duplicate receipts therefor within thirty (30) days following the date of payment. The Mortgagor shall pay in full "under protest" are text or assessment which Mortgagor may desire to contest, in the manner provided by law.
- 5. Mortgagor shall deposit with the Mortgagee, or the Mortgagee's designated agent (hereinaber called "Collection Agent"), on the date of disbursement of the proceeds of the loan secured hereby the sum of \$6,718.00 and on the 30th day of each month beginning June 30, 1997 and each month thereafter (unless otherwise agreed to by Mortgagee), the sum of \$1,344.00. Such deposits shall be governed by the terms and conditions of the Tax Escrow Agreement.
- 6. For the purpose of providing funds with which to pay premiums when due on all policies of fire and other hazard insurance covering the Premises and the Collateral (defined in Section 22) and unless waived by Mortgagee in writing, the Mortgager shall deposit with the Mortgagee or the Collection Agent, commencing on the date of disbursement of the proceeds of the loan secured hereby and on the first day of each month following the month in which said disbursement occurs (unless otherwise agreed to by Mortgagee), a sum equal to the Mortgagee's estimate of the premiums that will next become due and payable on such policies reduced by the amount, if any, then

on deposit with the Mortgagee, divided by the number of months to elapse before two (2) months prior to the date when such premiums become due and payable. No interest shall be allowed or paid to Mortgagor on account of any deposit made hereunder and said deposit need not be kept separate and apart from any other funds of the Mortgagee.

- 7. In the event of a default hereunder, the Mortgagee may, at its option but without being required so to do, apply any monies at the time on deposit pursuant to Section 5 and Section 6 hereof on any of Mortgagor's obligations contained herein or in the Note and/or Guaranty, in such order and manner as the Mortgagee may elect. When the Indebtedness Secured Hereby has been fully paid, any remaining deposits shall be paid to Mortgagor or to the then owner or owners of the Premises as the same appear on the records of the Mortgagee. A security interest, within the meaning of the Illinois Uniform Commercial Code is hereby granted to the Mortgagee in and to all monies at any time on deposit pursuant to Section 5 and Section 6 hereof and such monies and all of Mortgagor's right, title and interest therein are hereby assigned to Mortgagee, all as additional security for the Indebtedness bereunder and shall, in the ab care of default hereunder, be applied by the Mortgagee for the purposes for which made hereunder and shall be subject to the direction or control of the Mortgagor; provided, however, that Mortgagee shall not be liable for any failur: to apply to the payment of taxes or assessments or insurance premiums any amount so deposited unless Mortgagor, while not in default hereunder, shall have furnished Mortgagee with the bills therefor and requested Montgagee in writing to make application of such funds to the payment of the particular taxes or assessments or insurance premiums for payment of which they were deposited, accompanied by the bills for such taxes or assessments or insurant premiums. Mortgagee shall not be liable for any act or omission taken in good faith, but only for its gross neglige ace or willful misconduct.
- 8. The Mortgagor will insure at d keep insured all of the buildings and Improvements now or hereafter constructed or erected upon the Premises and cach and every part and parcel thereof, against such perils and hazards as the Mortgagee or the Holder may from time to time reasonably require with no more than \$1,000 deductible in any case, and in any event including any and all manage required by any Lease, and the following:
- (a) Insurance against loss or damage to the Improvements by fire, risks covered by the so-called standard extended coverage endorsement, vandalism and maliculus mischief endorsement and so-called "all perils" endorsement and such other risks as the Montgagee or the Holder, ricy reasonably require, in amounts equal to the full replacement value of the Premises plus the cost of debris removes, with a full replacement cost endorsement, and Lender's Loss Payable endorsement;
- (b) Comprehensive general public liability insurance against lookily injury and property damage arising in connection with the Premises with such limits as the Mortgagee or any Holder may reasonably require;
- (c) If there are pressure fired vehicles or vessels within the Premise, broad form boiler and machinery insurance on all equipment and objects customarily covered by such insurance, providing for full repair and replacement cost coverage;
- (d) Other insurance of the types and in amounts as the Mortgagee or any Holder 10'19 reasonably require, but in any event not less than customarily carried by persons owning or operating like properties:
- (i) builders completed value risk insurance against "all risks of physical loss" including collapse and transit coverage during such construction in non-reporting form, covering the total value of work performed and equipment, supplies, and materials furnished, containing "permission to occupy upon completion" endorsement; (ii) insurance covering claims based on the owner's contingent liability not covered by the insurance provided above; and, (iii) employer's liability and workmen's compensation insurance covering all persons engaged in making such construction, alterations or improvements; and
- (f) Federal Flood Insurance in the maximum obtainable amount, if the Premises is in a "flood plain area" as defined by the Federal Insurance Administration pursuant to the Federal Flood Disaster Protection Act of

1973, as amended.

- 9. All policies of insurance to be maintained and provided as required by Section 8 hereof shall be in form and substance, and written by companies and in amounts (subject to the provisions of Section 8 hereof) satisfactory to the Holder and in connection with such insurance:
- (a) All policies of casualty insurance shall have attached thereto mortgagee clauses or endorsements in favor of and with loss payable to the Holder as its interest may appear, all in form satisfactory to Holder.
- (b) Mortgagor will deliver all policies, including additional and renewal policies to the Collection Agent for the benefit of the Holder, and in case of insurance policies about to expire, the Mortgagor will deliver renewal policies not less than ten (10) days prior to the respective dates of expiration.
- (c) If under the terms and provisions of any Lease now in effect or of any other Lease specifically approved by the Molder, the Lessee under such Lease is required to maintain insurance in the types and amounts as set forth in Section 3 terms.
 - (i) If pursuant to the terms of such Lease, such insurance is to be maintained for the benefit of both Lessor and any Mortgagee of Lessor, the Holder will accept such policy or policies in lieu of policies required by Section 8 or this Section 9 hereof, provided that the policies furnished by such Lesse meet the requirements set forth in Section 8 and this Section 9 hereof; and
 - (ii) In the event any such Lessee shall fail to keep such insurance in full force and effect, and deliver the same as provided in in Section 8 and in this Section 9 hereof, than the Mortgagor shall obtain and deliver such policy or policies as required by Section 8 and this Section 9 hereof.
- (d) Each policy of insurance shall be endo sed to provide that (i) it may not be cancelled or amended except upon ten (10) days prior written notice to Collectic o Agent and Holder; and, (ii) no act or negligence of the insured or any occupant, and no occupancy of the Premises or one thereof for purposes more hazardous then permitted by the terms of the policy will affect the validity or enforceability of the insurance as against the Mortgagee or any Holder.
- 10. The Mortgagor will give the Mortgagee, each Holder and the Collection Agent prompt notice of any damage to or destruction of the Premises, and:
- (a) In case of loss covered by policies of insurance, the Holder (or, litter entry of decree for foreclosure, the purchaser at the foreclosure sale or decree creditor, as the case may be) is breby authorized at its option either (i) to settle and adjust any claim under such policies without the consent of the Mongage i, or (ii) allow the Montgagor to agree with the insurance company or companies on the amount to be paid upon the loss; provided, that the Montgagor may itself adjust losses aggregating not in excess of Fifty Thousand (\$50,000.00) Dollars, and provided further that in any case the Montgagee (at the direction of the Holder or the Collection Agent on its behalf, if so directed) shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the expenses incurred by the Montgagee, Holder or Collection Agent in the adjustment and collection of insurance proceeds shall be so much additional Indebtedness Hereby Secured, and shall be reimbursed to Holder upon demand.
- (b) In the event of any insured damage to or destruction of the Premises or any part hereof (herein called an "Insured Casualty"), the Holder (or the Collection Agent on its behalf) may, at its election either:
 - (i) Apply the proceeds of insurance to reimburse the Mortgagor for the cost of restoring, repairing, replacing or rebuilding the Premises or part thereof subject to Insured Casualty, as provided for in Section 12 hereof; and in such case the Mortgagor hereby covenants and agrees

forthwith to commence and to diligently prosecute such restoring, repairing, replacing or rebuilding; provided always that the Mortgagor shall pay all costs of such restoring, repairing, replacing or rebuilding in excess of the proceeds of insurance; or, if Mortgagor shall elect not to restore, repair, replace or rebuild, then Mortgagee shall

- (ii) Apply the proceeds of insurance consequent upon an Insured Casualty to the Indebtedness Hereby Secured, in such order or manner as the Holder may elect, but no prepayment premium or penalty shall be applicable to any such application provided, that in such case Mortgagor shall not be obligated to restore, repair, replace or rebuild the Insured Casualty.
- (c) In the event that proceeds of insurance, if any, shall be made available to the Mortgagor for the restoring, repairing or rebuilding of the Premises, the Mortgagor hereby covenants to restore, repair, replace or rebuild the same to be of at least equal value, and of substantially the same character as prior to such damage or destruction; all to be effected in accordance with plans and specifications to be first submitted to and approved by the Holder.
- 11. In the event he Mortgagor is entitled to reimbursement out of insurance proceeds held by the Holder (or the Collection Agent on its behalf):
- (a) Such precious shall be disbursed from time to time upon the Holder being furnished with satisfactory evidence of the estimated ext. of completion of the restoration, repair, replacement, and rebuilding together with funds (or assurances satisfactor; to the Holder that such funds are available) sufficient in addition to the available proceeds of insurance, to con olete the proposed restoration, repair, replacement, and rebuilding and with such architect's certificates, waivers of lie, comractors' sworn statements and such other evidence of cost and of payment as the Holder may reasonably require and approve;
- (b) The Holder may, in any event, require that all plans and specifications for such restoration, repair, replacement, and rebuilding be submitted to and apper set by the Holder prior to commencement of work;
- (c) No payment made prior to the final compilation of the restoration, repair, replacement or rebuilding shall exceed ninety (90%) percent of the value of the work performed from time to time;
- (d) Funds other than proceeds of insurance shall be dislussed prior to disbursement of such proceeds;
- (e) At all times the undisbursed balance of such proceeds remaining in the hands of the Holder or the Collection Agent, together with funds deposited for the purpose or irrevocably committed to the satisfaction of the Holder by or on behalf of the Montgagor for the purpose, shall be at least sufficient in the raso able judgment of the Holder to pay for the cost of completion of the restoration, repair, replacement or rebuilding, free and clear of all liens or claims for lien;
- (f) No interest shall be allowed to the Mortgagor on account of any proceeds of insurance or other funds held in the hands of the Holder or the Collection Agent;
- (g) The Holder may in any event require title insurance in connection with each disbursement of insurance proceeds, assuring to the Holder's satisfaction that this Mortgage remains a prior lien upon the Premises subject only to matters existing at the time of initial disbursement of the Indebtedness Hereby Secured, which title insurance shall specifically insure against mechanics' and materialmen's liens arising in connection with the restoration, repair, replacement, and rebuilding;
- (h) If after completion of and payment of all costs of restoration, repair, replacement, and rebuilding any proceeds of insurance remain unexpended, such unexpended proceeds shall be applied first to

reimburse Mortgagor for any funds advanced by Mortgagor in payment of such costs and any remainder shall be applied by Mortgagee upon the Indebtedness Hereby Secured without prepayment premium as penalty.

- 12. Mortgagor hereby assigns, transfers, and sets over unto the Holder the entire proceeds of any Award or claim for damages for any of the Premises taken or damaged under the power of eminent domain, or by condemnation; and, in connection therewith:
- (a) Mortgagor shall notify Mortgagee, in writing, not later than thirty (30) days from the date of the receipt of the Award by Mortgagee, of Mortgagor's election to restore or rebuild the Premises, or to apply said proceeds to the reduction of the Indebtedness Hereby Secured. If Mortgagor elects to restore or rebuild the Premises, the proceeds shall be held by the Holder or by the Collection Agent on its behalf and shall be used to reimburse the Mortgagor for the cost of such rebuilding or restoring.
- (b) if the Mortgagor is required or permitted to rebuild or restore the Premises as aforesaid, such rebuilding or restoration shall be effected solely in accordance with plans and specifications previously submitted to and approved by the Holder and proceeds of the Award shall be paid out in the same manner as provided in Section 8 hereof for the an ment of insurance proceeds towards the cost of rebuilding or restoration.
- (c) If the annual of such Award is insufficient to cover the cost of rebuilding or restoration, the Mortgagor shall pay such costs in excess of the Award, before being entitled to reimbursement out of the Award.
- (d) Any surplus which may remain out of the Award after payment of such costs of rebuilding or restoration shall, at the option of the Houler, it applied on account of the Indebtedness Hereby Secured then most remotely to be paid, or be paid to any other party smithed thereto.
- (e) No interest shall be allowed to Morganon on account of any Award held by the Holder or the Collection Agent.
- (f) No prepayment premium or penalty shall be applicable with respect to any amount of such Award applied upon the Indebtedness Hereby Secured as provided to therein.
- 13. If, under the Laws of the United States of America, or of any state having jurisdiction over the Mortgagor, any tax is due or becomes due in respect of the issuance of the Mortgagor shall pay such tax in the manner required by such law.
- 14. At such time as the Mortgagor is not in default under the terms of the Note, or under the terms of this Mortgage, or any other Loan Documents, the Mortgagor shall have the privilege of making prepayments on the principal of the Note (in addition to the required payments thereunder) in accordance with the term is and conditions, if any, set forth in the Note and/or Guaranty.
- 15. If the payment of the Indebtedness Hereby Secured or any part thereof, be extended or veried, or if any part of the security be released, all persons now or at any time hereafter liable therefor, or interested in the Premises, shall be held to assent to such extension, variation or release, and their liability, and the lien, and all provisions thereof, shall continue in full force and effect; the right of recourse against all such persons being expressly reserved by the Mortgagee and the Holder, notwithstanding any such extension, variation or release. Any person, firm or corporation taking a junior mortgage, or other lien upon the Premises, or any interest therein, shall take the said lien subject to the rights of the Mortgagee and the Holder herein to amend, modify, and supplement this Mortgage, the Note, and the Assignment, and to extend the maturity of the Indebtedness Hereby Secured, in each and every case without obtaining the consent of the holder of such junior lien and without the lien of this Mortgage losing its priority over the rights of any such junior lien.
 - 16. No action for the enforcement of the lien or any provision hereof shall be subject to any defense which

would not be good and available to the party interposing the same in an action at law upon the Note.

- 17. In case of default herein, the Mortgagee (at the request of the Holder) or any Holder may, but shall not be required to, make any payment or perform any action herein required of the Mortgagor (whether or not the Mortgagor is personally liable therefor) in any form and manner deemed expedient to the Mortgagee or Holder so doing; and without limiting the foregoing, the Mortgagee (at the request of the Holder), or any Holder may, but shall not be required to, perform any act or thing, and make any payment required of Lessor under any Lease, make full or partial payments of principal or interest on prior or junior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting the Premises, or consent to any tax or assessment; and in connection with the foregoing:
- (a) All monies paid by the Mortgagee or any Holder for any of the purposes herein authorized, and all expertes yaid or incurred in connection therewith, including attorneys' fees incurred by the Mortgagee or any Holder in connection with the enforcement of any rights and remedies herein contained or in connection with any action or proceeding, instituted or threatened, to which the Mortgagee or any Holder may be made a part on account of this Mortgage or the interest of the Mortgagee or any Holder in the Premises and any other monies advanced by the Mortgagee or any Holder to protect the Premises and the lien hereof, shall be so much additional Indebtedness Hereby Secured, and shall become immediately due and payable without notice, and shall bear interest thereon at the Default Rate until paid.
- (b) Inaction by Mortgapes or any Holder shall never be considered as a waiver of any right accrning to it on account of any default on the part of the Mortgagor.
- (c) The Mortgagee or any Ho'de, in making any payment hereby authorized (i) relating to taxes and assessments, may do so according to any bill, size ement or estimate, without inquiry into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim there if, or (ii) for the purchase, discharge, compromise or settlement of any other lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.
- 18. The Mortgagee and any Holder and the Collection A of 1 upon prior notice shall have the right to inspect the Premises at all reasonable times, and access thereto shall be permitted for that purpose.
- 19. The Mortgagor's beneficiary will (a) within ninety (90) days after the end of each of its fiscal years, furnish to the Holder at the place where interest on the Indebtedness Hereby Sector Liv then payable, financial and operating statements of the Premises, and (b) within ninety (90) days after the end of each of the fiscal year of Mortgagor's beneficiary, a personal financial statement of Mortgagor's beneficiary and each guarantor of the Note. The foregoing statements shall be prepared and certified by Mortgagor's beneficiary. These statements shall in each case include a balance sheet and income statement and in connection with the Premises, a rant of and statement of income and expense, all in such detail as the Holder may require. Such statements shall be prepared in accordance with the basis that Mortgagor's beneficiary's accountants typically employ. If such statements are 1 of prepared in accordance with generally accepted accounting principles, or if Mortgagor's beneficiary fails to furnish there on time, any Holder may audit the books of the Premises and of Mortgagor's beneficiary, all at Mortgagor's expense, and the cost thereof shall be so much additional Indebtedness Hereby Secured, bearing interest at the Default Rate until paid, and payable upon demand.
- 20. Subject to the provisions of Section 21 hereof, it shall be an immediate Event of Default and default hereunder if, without the prior written consent of the Holder:
- (a) The Mortgagor shall create, effect or consent to or shall suffer or permit any conveyance, sale, assignment, transfer, lien, pledge, mortgage, security interest or other encumbrance of alienation of the Premises or any part thereof, or interest therein, excepting only sales or other dispositions of Collateral (herein called "Obsolete Collateral") no longer useful in connection with the operation of the Premises, provided that prior to the sale or other

disposition thereof, such Obsolete Collateral has been replaced by Collateral, subject to the lien hereof, of at least equal value and utility;

- (b) If the Mortgagor is or at any time shall be a corporation, any shareholder of such corporation shall create, effect or consent to, or shall suffer or permit any sale, assignment, transfer, lien, pledge, mortgage, security interest or other encumbrance or alienation of any such shareholder's share in the corporation;
- (c) If the Mortgagor is or at any time shall be a partnership or joint venture, any partner or joint venturer thereof shall create, effect or consent to, or shall suffer or permit any sale, assignment, transfer, lien, pledge, mortgage, security interest or other encumbrance or alienation of any part of the general partnership or joint venture interest, as the case may be, of such partnership or joint venture.

In each case whether any such conveyance, sale, assignment, transfer, lien, pledge, mortgage, security interest, encumbrance or dienation is effected directly, indirectly, voluntarily or involuntarily, by operation of law or otherwise, the provisions of this Section 20 shall be operative with respect to, and shall be binding upon any persons who, in accordance with the terms hereof or otherwise, shall acquire any part of or interest in or encumbrance upon the Premises, or such beneficial interest in, share of stock of or partnership or joint venture interest.

- 21. The provisions of fertion 20 hereof shall not apply to the following transfers and encumbrances, each of which shall be deemed consented as:
 - (a) Liens securing the I det tedness Hereby Secured:

- (b) The lien of current taxes and assessments not in default;
- (c) Transfer of the Premises, or pasts thereof, or interest therein or any beneficial interest, shares of stock or partnership or joint venture interests, the transfer of which would otherwise result in an Event of Default pursuant to the provisions of Section 20 hereof, by or on tability of an owner thereof who is deceased or declared judicially incompetent, to such owner's heirs, legatees, devices, executors, administrators, estate, personal representatives and/or committee.
- 22. In addition to the lien which this Mortgage places upon the real estate conveyed bereunder, this Mortgage also constitutes a Security Agreement under the Uniform Commercial Code of the State of Illinois (herein called the "Code") with respect to all rents, issues, profits and avails of any Leare of the Premises, and with respect to any part of the Premises which may or might now or hereafter be deemed to be reasonal property, fixtures or property other than real estate (all for the purpose of this Section 22 called "Collateral"; all of the terms, provisions, conditions, and agreements contained in this Mortgage pertain and apply to the Collateral as folly and to the same extent as to any other property comprising the Premises; and the following provisions of this Section 22 shall not limit the generality or applicability of any other provision of this Mortgage but shall be in accurior chereto:
- (a) The Mortgagor (being the Debtor as that term is used in the Code) is and will be the true and lawful owner of the Collateral.
- (b) The Collateral is to be used by the Mortgagor solely for business purposes, being installed upon the Premises for Mortgagor's own use or as the equipment and furnishings by Mortgagor, as Landlord, to tenants of the Premises.
- (c) The Collateral will be kept at the Real Estate comprised in the Premises, and will not be removed therefrom without the consent of the Holder and Mortgagee (being the Secured Party as that term is used in the Code); and the Collateral may be affixed to the Real Estate but will not be affixed to any other real estate.
 - (d) The only persons having any interest in the Premises are (i) the Mortgagor, (ii) the Mortgagee

and the Holder; and (iii) Lessees under existing Leases.

- (e) No financing statement covering any of the Collateral or any proceeds thereof is on file in any public office except pursuant hereto, and Mortgagor will at its own cost and expense, upon demand, furnish to the Mortgagee and Holder such further information and will execute and deliver to the Mortgagee or any Holder such financing statements and other documents in form satisfactory to the Mortgagee or any Holder and will do all such acts and things as the Mortgagee or any Holder may at any time or from time to time reasonably request or as may be necessary or appropriate to establish and maintain a perfected security interest in the Collateral as security for the Indebtedness Hereby Secured, subject to any adverse liens or encumbrances; and the Mortgagor will pay the cost of filing the same or filing or recording such financing statements or other documents, and this instrument, in all public offices wherever filing or recording is deemed by the Mortgagee or any Holder to be necessary or desirable.
- (f) Upon the occurrence of any default or Event of Default hereunder (regardless of whether the Code has been according the jurisdiction where rights or remedies are asserted) and at any time thereof (such default not having previously been cured), the Mortgagee (at the request of the Holder) or any Holder at its option may declare the Indebte me's Hereby Secured immediately due and payable, all as more fully set forth in Section 23 hereof, and thereupon he Mortgagee and the Holder shall have the remedies of a secured party under the Code. including without limitation the right to take immediate and exclusive possession of the Collateral, or any part thereof, and for that purpose way, so far as the Mortgagor can give authority therefor, with or without judicial process enter (if this can be done without breach of the peace), upon any place which the Collateral or any part thereof may be situated and remove the tarre therefrom (provided that if the Collateral is affixed to real estate, such removal shall be subject to the conditions stated in the Code); and the Mortgagee and the Holder and each of them shall be entitled to hold, maintain, preserve and prepare the Collateral for sale until disposed of, or may propose to retain the Collateral subject to Mortgagor's ru nt of redemption in satisfaction of the Mortgagor's obligations, as provided in the Code. The Montgagee and the Fioliles without removal may render the Collateral unusable and dispose of the Collateral on the Premises. The Mortg gee and the Holder may require the Mortgagor to assemble the Collateral and make it available to the Mortgagee and 'he l'older for their possession at a place to be designated by them which is reasonably convenient to both parties. The Mortgagee or Holder, as the case may be, will give Mortgagor at least five (5) days notice of the time and place of may public sale thereof or of the time after which any private sale or any other intended disposition thereof is made. The requirements of reasonable notice shall be met if such notice is mailed, by registered or certified mail, postage in orid, to the address specified for notices to Montgagor as set forth in Section 37 hereof at lest five (5) days from the time of the sale or disposition. The Mortgagee or any Holder may buy at any public sale and if the Collater I is of a type customarily sold in a recognized market or is of a type which is the subject of widely distributed standard price quotations, Mortgagee or any Holder may buy at private sale. Any such sale may be held as part of and in configuration with any foreclosure sale of the real estate comprised within the Premises; the Collateral and real estate to be sold as one lot if Mortgagee (at the direction of the Holder) or any Holder so elects. The net proceeds realized upon any such disposition, after deduction for the expenses of retaking, holding, preparing for sale, selling or the like and the researchle attorneys' fees and legal expenses incurred by the Mortgagee and the Holder, shall be applied in satisfaction of the Indebtedness Hereby Secured. The Holder will account to the Mortgage for any surplus realized on such disposition:
- (g) The remedies of the Mortgagee and Holder hereunder are cumulative and the exercise of any one or more of the remedies provided for herein or under the Code shall not be construed as a waiver of any of the other remedies of the Mortgagee or any Holder, including having the Collateral deemed part of the realty upon any foreclosure thereof so long as any part of the Indebtedness Hereby Secured remains unsatisfied.
- (h) The terms and provisions contained in this Section 22 shall, unless the context otherwise requires, have the meaning and be construed as provided in the Code, and the Mortgagee and the Holder shall be deemed secured parties for the purpose of the Code, with respect to this Section 22.
 - 23. If one or more of the following events (herein called "Events of Default") shall occur:

- (a) If default is made in the due and punctual payment of any Note or any installment of any Note, either principal or interest, as and when the same is due and payable; or if default is made in the making of any payment of monies required to be made hereunder or under the Note and/or Guaranty, or any other of the Loan Documents, and any applicable period of grace specified in the Note shall have elapsed;
 - (b) If an Event of Default pursuant to Section 20 hereof shall occur and be continuing;
- (c) If any Event of Default or default shall occur under any of the Loan Documents, and any applicable grace periods shall have expired;
- (d) If any default or Event of Default shall occur under any Lease, or if there shall occur any event which alone or with the passage of time or the giving of notice, or both, would, in the reasonable judgment of any Holder, entitle Essee under any Lease to terminate the same:
- (c) If default is made in the maintenance and delivery by Mortgagor of insurance required to be maintained and delivered hereunder, without notice or grace of any kind;
- (f) If (and for the purposes of this Section 23(f) the term "Mortgagor" shall mean and include not only the Mortgagor named above, but also each titleholder of the Premises and each person who, as guarantor, co-maker or otherwise shall be or become obligated upon all or any part of the Indebtedness Hereby Secured or any of the covenants or agreements in this Mortgage or in the Note or other Loan Documents contained):
 - (i) Mortgagot chall file a petition in voluntary bankruptcy under the Chapter of the Federal Bankruptcy Code or try similar law, state or federal, now or hereafter in effect;
 - (ii) Mortgagor shall file in arrower admitting insolvency or inability to pay its debts;
 - (iii) Within sixty (60) days after the filing against Mortgagor of any involuntary proceedings under such Bankruptcy Code or similar law, such proceedings shall not have been vacated or stayed;
 - (iv) Mortgagor shall be adjudicated a bankrupt, c. a trustee or receiver shall be appointed for the Mortgagor or for all or the major part of the Mortgagor's property or the Premises in any involuntary proceedings, or a court shall have taken jurisdicated of all or the major part of the Mortgagor's property or the Premises in any involuntary proceeding for the reorganization, dissolution, liquidation or winding up of the Mortgagor, and such trustee or receiver shall not be discharged or such jurisdiction relinquished or vacated or stayed on appeal or otherwise stayed with sixty (60) days; or
 - (v) Mortgagor shall make an assignment for the benefit of creditors or shall admit in writing its inability to pay its debts generally as they become due or shall concent to the appointment of a receiver or trustee or liquidator of all or the major part of its property, or the Premises:
- (g) If any default shall occur (and shall not be cured within any applicable grace period) under the provisions of Section 30 hereof or under the Assignment referred to in said Section;
- (h) If any default in the due and punctual performance or observance of any agreement or condition herein or in any Note or other Loan Documents not specifically enumerated in this Section 23 shall continue for thirty (30) days after notice thereof to Mortgagor;
 - (i) If any representations or warranties made by or on behalf of Mortgagor or its beneficiary herein

or in any of the Loan Instruments or in any other documents or certificate delivered in connection with the Indebtedness Hereby Secured shall prove untrue in any material respect;

(j) If the Premises shall be abandoned;

then the Mortgagee (at the direction of any Holder) or any Holder is hereby authorized and empowered, at its option, and without affecting the lien bereby created or the priority of said lien or any right of the Mortgagee or any Holder, to declare, without further notice, all Indebtedness Hereby Secured to be immediately due and payable, whether or not such Event of Default be thereafter remedied by the Mortgager, and the Mortgagee (at the direction of any Holder) or any Holder may immediately proceed to foreclose this Mortgage and/or to exercise any right, power or remedy provided by this Mortgage and the Note, by the Assignment or by law or in equity conferred, all without presentment, demand, notice of broken conditions or other notice whatsoever.

- 24. While the Indebtedness Hereby Secured shall become due, whether by acceleration or otherwise, the Mortgagee (at the direction of any Holder) or any Holder shall, if applicable law permits, have the right to enter into and upon the Premiss and take possession thereof or to appoint an agent or trustee for the collection of the rents, issues, and profits of the Premises; and the net income, after allowing a reasonable fee for the collection thereof and for the management of the Premises, may be applied to the payment of taxes, insurance premiums and other charges against the Premises, or in reduction of the Indebtedness Hereby Secured; and the rents, issues, and profits of and from the Premises are hereby specifically pledged to the payment of the Indebtedness Hereby Secured.
- 25. When the Indebtedness Hereby Secured, or any part thereof, shall become due, whether by acceleration or otherwise, the Mortgagee or the Holder either of them shall have the right to foreclose the lien hereof for such indebtedness or part thereof. In any suit to speciose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale, and expensionable expenditures and expenses which may be paid or incurred by or on behalf of the Mortgagee or any Holder for attorneys' fees, appraiser's fees, Mortgagee's fees, outlays for documentary and expert evidence, stenographer's charge, publication costs, and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, title insurance policies, Torrens Certificates, and similar data and assurance with respect to title, as the Mortgagee or any Holder may deem reasonably necessary either to prosecute such suit or evidence to bidders at sales which may be had pursuant to such decree, the true condition of the title to or the value of the Premises. All expenditures and expenses of the nature in this Section mentioned, and such other expenses and fees as may be incurred in the protection of the Premises and the maintenance of the lies of this Mortgage as in this Mortgage provided, including the fees of any attorney or attorneys employed by the Morter (20) or any Holder in any litigation or proceedings involving, relating to or affecting this Mortgage, the Note or the Frencises, including probate and bankruptcy proceedings, or in preparation for the commencement or defense of any proceedings or threatened suit or proceedings, shall be so much additional Indebtedness Hereby Secured and shall be introductely due and payable by the Mortgagor, with interest thereon at the Default Rate until paid.
- 26. Upon, or at any time after, the filing of a complaint to foreclose this Mortgage, the court with which such complaint is filed shall, at the request of the Mortgagee or any Holder, appoint a receiver of the Premises pursuant to 735 ILCS 5/15-1701 and 735 ILCS 5/15-1704. Such appointment may be made either before or after sale, without notice, without regard to solveney or insolveney of the Mortgagor at the time of application for such receiver, and without regard to the then value of the Premises or whether the same shall be then occupied as a homestead or not; and the Mortgagee or any Holder or the Collection Agent may be appointed as such receiver. Such receiver shall take immediate possession of the Premises, shall have the power to collect the rents, issues, and profits of the Premises with full power to protect, control, manage, operate, complete construction of and pay the cost of construction of and rent the Premises and shall have all other customary powers, to be exercised as said receiver may deem best for all parties concerned during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, if any, whether there be a redemption or not, as well as during any further times when the Mortgagor, except for the intervention of such receiver, would be entitled to collection of such rents, issues, and profits and all other powers which may be necessary or are usual in such cases

for the protection, possession, control, management, and operation of the Premises during the whole of said period. The court may, from time to time, authorize the receiver to apply the net income from the Premises in said receiver's hands in payments in whole or in part of:

- (a) The Indebtedness Hereby Secured or the indebtedness secured by any decree foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to the foreclosure sale; or
 - (b) The deficiency in case of a sale and deficiency.
- 27. The proceeds of any foreclosure sale of the Premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in Section 25 hereof; Second, all other items which, under the terms hereof, constitute Indebtedness Hereby Secured additional to that evidenced by the Note, with interest on such items as herein provided; Third, to principal and interest remaining unpaid upon the Note, ratably and without priority; and, lastly, any overplus to the Mortagan, and its successors or assigns, as their rights may appear.
- 28. In case of an insured loss after foreclosure proceedings have been instituted, the proceeds of any insurance policy or policies, if the applied in rebuilding or restoring the building or improvements, as aforesaid, shall be used to pay the amount due in a condance with any decree of foreclosure that may be entered in any such proceedings, and the balance, if any, shall be paid as the court may direct. In the case of foreclosure of this Mortgage, the court, in its decree, may provide that the loss clause attached to each of the casualty insurance policies may be canceled and that the decree creditor may cause a new loss clause to be attached to each of said casualty insurance policies making the loss thereunder paya) le to said decree creditors; and any such foreclosure decree may further provide that in case of one or more redemptions under said decree, pursuant to the statutes in such case made and provided, then in every such case, each and every such essive redemptor may cause the preceding loss clause attached to each casualty insurance policy to be canceled and a new loss clause to be attached thereto, making the loss thereunder payable to such redemptor. In the event of Survalosure sale, the Mortgagee or any Holder is hereby authorized, without the consent of the Mortgagee or such Holder may from advisable to cause the interest of such purchaser to be protected by any of the said insurance policies.
- 29. The Mortgagor hereby covenants and agrees to the full extent percented by law (but not otherwise) that it will not at any time insist upon or plead, or in any mamer whatsoever claim or take any advantage of, any stay, exemption or extension law, any "Homestead Law" now or at any time hereafter in and, nor claim, take or insist upon any benefit or advantage of or from any law now or hereafter in force providing for the valuation or appraisement of the Premises, or any part thereof, prior to any sale or sales hereof to be made pursuant to any provisions herein contained, or to decree, judgment or order of any court of competent jurisdiction; or after such sale or sales claim or exercise any rights under any statute now or hereafter in force to redeem the property so sold, or any part thereof, or relating to the marshaling thereof, upon foreclosure sale or other enforcement he col. Insofar as the Mortgagor may lawfully so agree, the Mortgagor covenants and agrees not to invoke or utilize any such law or laws or otherwise hinder, delay or impede the execution of any right, power or remedy herein otherwise granted or delegated to the Mortgagoe or any Holder, but covenants and agrees to suffer and permit the execution of every such right, power, and remedy as though no such law or laws had been made or enacted.
- 30. As security for the Indebtedness Hereby Secured, the Mortgagor has, concurrently herewith, executed and delivered to the Holder, the Absolute Assignment of Rents wherein and whereby, among other things, the Mortgagor has assigned to the Holder, all of the rents, issues, and profits and any and all Leases and/or the rights of management of the Premises, all as therein more specifically set forth, which said Absolute Assignment of Rents is hereby incorporated herein by reference as fully and with the same effect as if set forth herein at length. The Mortgagor agrees that it will duly perform and observe all of the terms and provisions on its part to be performed and observed under the Absolute Assignment of Rents. The Mortgagor further agrees that it will duly perform and

observe all of the terms and provisions on Lessor's part to be performed and observed under all Leases of the Premises to the end that no defaults on the part of Lessor shall exist thereunder. Nothing herein contained shall be deemed to obligate the Mortgagee or any Holder or the Collection Agent to perform or discharge any obligation, duty or liability of Lessor under any Lease of the Premises, and the Mortgagor shall and does hereby indemnify and hold the Mortgagee and any Holder and the Collection Agent hamnless from any and all liability, loss or damage which the Mortgagee or any Holder or the Collection Agent may or might incur under any Lease of the Premises or by reason of the Assignment; and any and all such liability, loss or damage incurred by the Mortgagee or any Holder or the Collection Agent, together with the costs and expenses, including reasonable attorneys' fees, incurred by the Mortgagee or any Holder or the Collection Agent in the defense of any claims or demands therefore (whether successful or not), shall be so much additional Indebtedness Hereby Secured, and the Mortgagor shall reimburse the Mortgagee and Holder and the Collection Agent therefor on demand, together with interest at the Default Rate from the date of demand to the date of payment.

- 31. Nowing herein contained shall be construed as constituting the Mortgagee or any Holder as a holder in possession.
- 32. Mortgagor an enants and agrees at all times to be in full compliance with provisions of law prohibiting discrimination on the basis of size, color, creed or national origin including, but not limited to, the requirements of Title VIII of the 1968 Civil Ri bus Act and the amendments thereto.
- 33. At the request of Mongagee or any Holder, the Mortgagor will cause this Mortgage and all other documents securing the Indebtedness Herr by Secured at all times to be properly filed and/or recorded at Mortgagor's own expense and in such manner and in such places as Mortgagee or any Holder may request in order to fully preserve, perfect, and protect the rights and security of the Mortgagee or any Holder.
- 34.
