THIS MORTGAGE IS DATED MAY 21, 1997, between FRANK L. MIRABELLA and GENEVEVE M. MIRABELLA. HRISBAND AND WIFE, AS JOINT TENANTS, whose address is 3314 S. NORMAL AVE., CHICAGO, R. 60616 (referred to below as "Grantor"); and Chicago Community (with, whose address is 1110 W. 35th St., Chicago, IL \$0609 (referred to below as "Lender").

GRANT OF MORTGAGE.
