AND IT IS EXPRESSLY PROVIDED AND AGREED, That if all or any part of the property or an interest in the property is sold or transferred by Mortgagor without Mortgagoe's prior written consent, Mortgagoe, at Mortgagoe's option, may require immediate payment in full of the entire amount due under the Mortgagoe and Home Payrovement Metail Installment Contract. Mortgagoe, at Mortgagoe's option, may waive the right to declare the balance immediately due and may accept in writing an assumption agreement executed by the person to whom the Mortgagor is transferring or selling the interest in the property. If Mortgagoe does allow Mortgagor's successor in interest to assume the obligation sortgagor will be released from further obligation under this Mortgagoe and the Home Improvement Patail Installment Contract. The following types of transfers will not give Mortgagoe the right to require immediate payment in full:

(a) the creation of liens or other claims against the property which are inferior to this

Mortgage;

(b) a transfer of rights in household appliances to a person who provides the Mortgagor with the money to by these appliances in order to protect that person against possible losses; he (c) a transfer of the land to surviving co-owners, following the death of a co-owner, when the transfer is automatic according to law;

(d) leasing the property for three years or less; so long as the lease does not include an

option to buy;

(a) a transfer to Mortgagor's relative resulting from death of the Mortgagor;

(f) a transfer where Hortgagor's spouse or children become owners of the property;

(g) a transfer to Hortgagor's spouse resulting from a divorce decree, separation agreement, or property settlement agreement;

(h) a transfer into an inter vivos trust in which the Mortgagor is and remains a beneficiary, so long as there is no transfer of rights of occupancy in the property.

IT IS FURTHER EXPRESSLY PROVIDED AND AGREED, That if default be made in the payment of the said contract, or of any part thereof, or in the case of waste or non-payment of taxes or assessments on said premises, or of a breach of any of the covenants of agreements harein contained, then in such case the whole of said sum, less unearned charges, secured by the said contract in this mortgage mentioned, shall thereupon, at the option of the said mortgage, his or its attorneys or assigns, and as provided by law, become due and payable, and this mortgage may be foreclosed to pay the same, and it shall be lawful for the said mortgages, his or its attorneys or assigns, to enter into and upon the premises, hereby granted, or any part thereof, and to receive and collect all rents, issues and profits thereof.
