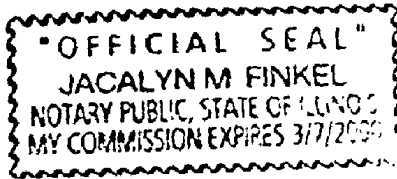

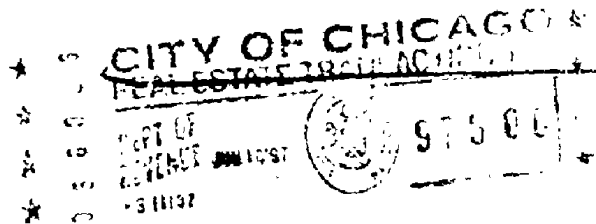
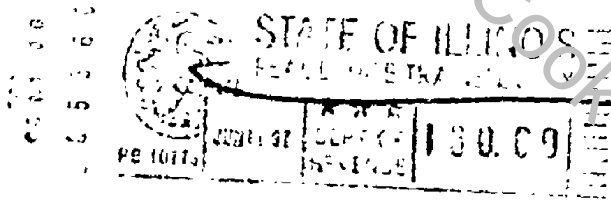

UNIT 303 IN BAYPOINT CONDOMINIUM AS DELINEATED ON A SURVEY OF THE FOLLOWING DESCRIBED REAL ESTATE:

- PARCEL 1: LOT 1 IN BAYPOINT CONDOMINIUM SUBDIVISION, BEING A RESUBDIVISION OF LAND, PROPERTY AND SPACE IN THE WEST $\frac{1}{2}$ OF THE NORTHWEST $\frac{1}{4}$ OF SECTION 39, TOWNSHIP 40 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS, WHICH SURVEY IS ATTACHED AS EXHIBIT "A" TO THE DECLARATION OF CONDOMINIUM RECORDED AS DOCUMENT NUMBER 97318783, AS AMENDED FROM TIME TO TIME, TOGETHER WITH ITS UNDIVIDED PERCENTAGE INTEREST IN THE COMMON ELEMENTS, ALL IN COOK COUNTY, ILLINOIS.
- PARCEL 2: THE EXCLUSIVE RIGHT TO THE USE OF S-303, A LIMITED COMMON ELEMENT AS DELINEATED ON THE SURVEY ATTACHED TO THE DECLARATION AFORESAID RECORDED AS DOCUMENT NUMBER 97318783.
- PARCEL 3: NON-EXCLUSIVE EASEMENT FOR THE BENEFIT OF PARCEL 1 AFORESAID FOR INGRESS, EGRESS, USE AND ENJOYMENT AS CREATED BY DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS RECORDED AS DOCUMENT NUMBER 97318782.

This deed is subject to the following permitted exceptions:

- (1) current real estate taxes and taxes for subsequent years not otherwise due and payable at the time of closing;
- (2) the terms and provisions of the Condominium Declaration, and any permitted amendments thereto, and the Illinois Condominium Property Act;
- (3) the terms and provisions of that certain Declaration of Covenants, Conditions, Restrictions, and Easements made by 3169 N. Lincoln Corporation as of April 30, 1977, and any amendments thereto;
- (4) covenants, conditions and restrictions of record;
- (5) applicable zoning and building laws, ordinances and restrictions;
- (6) roads and highways, if any;
- (7) title exceptions pertaining to liens or encumbrances of a definite or ascertainable amount, which may be removed by the payment of money at the time of closing and which the Grantor shall so remove at that time by using the funds to be paid upon delivery of the deed;
- (8) title exceptions over which the Title Company is willing to insure;
- (9) acts done or suffered by Grantee or anyone claiming by, through or under Grantee; and
