If default be made in the farme or conditions of the debt or debts hereby secured or of any of the terms of this mortgage, or in the payment of any installments when due, or if the ide (tagor(s) shall become bankrupt or insolvent, or make an assignment for the benefit of creditors, or have a receiver appointed, or should the mortgagy of property or any part thereof be attached, levied upon or seized, or if any of the representations, warranties or statements of Mortgagor(s) herein contained be incorrect or if the Mortgagor(s) shall abandon the mortgaged property, or sell or attempt to sell all or any part of the same, then the whole amount here! yie curred shall, at the Mortgagoe's option, become immediately due and payable, without notice or demand, and shall be collectible in a suit at law or by for possive of this mortgage. In any case, regardless of such enforcement, Mortgagee shall be entitled to the immediate possession of the mortgaged property with the rents, issues, income and profits therefrom, with or without foreclosure or other proceedings. Mortgagor(s) shall pay all costs, including reasor able a torney's fees, expenses of receivership and any additional expenses which may be incurred or paid by Mortgagoe in connection with any suit or proceeding to which it may be a party by reason of the execution or existence of this mortgage and in the event of foreclosure of this mortgage, Mortgagor(s) will pay to forth pagés, in addition to taxable costs, a reasonable fee for the search made and preparation for such foreclosure, together with all other and further expenses. If no reclosure and sale, including expenses, fees and payments made, to prevent or remove the imposition of liens or claims against the property and expiners. If upkeep and repair made in order to place the same in a condition to be sold.
