Such certified copies may be obtained ONLY from the Secretary of State.
- 5. Any change of registered agen must be by resolution adopted by the board of directors. This statement must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
- The registered agent may report a charge of the registered office of the corporation for which he or she is registered agent. When the agent reports such a change, this statement must be signed by the registere 9742-968 Office agent.
