THIS INDENTURE, made this 29th day of May, 1997, by HARVEY HOSPITALITY INC., an Illinois corporation ("Mortgagor"),

WITNESSETH:

WHEREAS, TR'ENDSHIP MOTELS OF HARVEY INC., an Illinois corporation, executed and delivered to SOUTH SHORE BANK OF CHICAGO ("Mortgagee") that certain note of even date herewith (such note and all notes delivered in substitution, replacement or exchange therefor, as any of the foregoing may from time to time heremoned, are hereinafter collectively called the "Note") payable to the order of Mortgagee in the principal amount of Two Million and 00/100 Dollars (\$2,000,000.00), with interest thereon provided in the Note, and payable as provided therein, all as set forth in the Note and as hereinafter described, with a final payment of principal and interest, if not sooner paid, due and payable on the 1st day of November, 2012, and Mortgageor has agreed to grant Mortgagee a junior mortgage lien encumbering the Mortgaged Premises; and,

WHEREAS, Mortgagor desires to secure the prompt and timely payment of the principal of the Note together with interest thereon in accordance with the terms of the Note, and all extensions or renewals thereof; and,

WHEREAS, Mortgagor desires to induce Mortgagee to extend the financing accommodations as evidenced by the Note:

NOW THEREFORE, to secure payment of the indebtedness secured hereby and the performance of the covenants, agreements and provisions herein and contained in the Note, and for TEN and 00/100 DOLLARS (\$10.00) and other good and valuable consideration in hand paid, the receipt, adequacy and sufficiency of which are hereby acknowledged, Mortgagor does by these presents grants, mortgages and conveys unto Mortgagee, its successors and assigns, the real estate legally described on Exhibit "A" attached hereto and made a part hereof (the "Real Estate" or the "Mortgaged Premises");

TOGETHER with all the estate, right, title and interest, if any, (including without limitation any after-acquired title, franchise or license and the reversions and remainders thereof), in and to the land lying within any alley way, street, roadway, strips and gores, beds adjoining the Real Estate;

- 1. PAYMENT OF INDEBTEDNESS. Mortgagor shall procure and deliver to Mortgagee, in advance, statements for such charges. In the event of any default under the terms of this Mortgagee, any part or all of the amounts paid by Mortgagee may be applied to the Indebtedness secured hereby, and in refunding any part of such amounts, Mortgagee may deal with whomever is represented to be the owner of the Premises at that time. No interest shall be payable on amounts deposited with Mortgagee under this provision, but until application by Mortgagee, such amounts shall be deemed to be trust funds. A. 

A. Mortgagor will keep and maintain the Mortgaged Premises in good order and condition and will make, as and when the same shall become necessary, all structural and non-structural, exterior and interior, ordinary and extraordinary, foreseen and unforeseen, repairs, maintenance and restoration necessary or appropriate. Furthermore, and without limiting the generality of the foregoing, Mortgagor will suffer or commit no waste to the Mortgaged Premises or any portion thereof. B. Mortgagor will promptly comply with all present and future laws, ordinances, rules, regulations and other requirements of all governmental authorities with respect to the Mortgaged Premises or any portion thereof, or the use, occupancy or possession thereof.

5. OTHER LIENS AND CHARGES.

- Mortgagor will keep and maintain the Mortgaged Premises free from all liens of persons supplying boar and materials entering into the construction, modification, repair, restoration or maintenance of the Mortgaged Premises or any portion thereof. If any such liens for labor or materials shall be filed against the Mortgaged Premises, Mortgagor shall discharge the same of record by payment and satisfaction in full (or crus) same to be bonded or insured over by a bonding company or title insurer satisfactory to Mortgagee) within thirty (30) days after the date of filing thereof.
- B. Mortgagor will pay promptly when due all charges for utilities or services, including but not limited to electricity, gas, water and sewer. If Mortgagor fails to pay promptly all such charges, Mortgagee, at its option, may pay same and any amounts so paid by Mortgagee shall become immediately due and payable by Mortgagor with Interest as described in the Note hereof, and shall be secured by this Mortgage.
- C. If any action or proceeding shall be instituted to evict Mortgagor or recover possession of the Mortgaged Premises or any part thereof, or for any other purposes affecting the Mortgaged Premises or this Mortgage, or any notice relating to a proceeding or a default is served on Mortgagor, Mortgagor immediately upon service thereof on or by Mortgagor, will deliver to Mortgagee a true copy of each petition, summons, complaint, notice of motion, order to show cause, and all other process, pleadings and papers, however designated, served in any such action or proceeding.
- CONDEMNATION AND EMINENT DOMAIN. If all or any part of the Mortgaged Premises 6. are damaged, taken or acquired, either temporarily or permanently, as a pasult of any condemnation proceeding, or by exercise of the power of eminent domain, or by agreement among Nortgagor, Mortgagee and those authorized to exercise such power (it being agreed that Mortgago) will not enter into any agreement for the taking of the Mortgaged Premises, or any part thereof, with anyone authorized to acquire the same in or by condemnation proceedings or by exercise of any power of eminent domain unless and until Mortgagee shall have consented thereto in writing), or by the alteration with grade of any street affecting the Mortgaged Premises, the amount of any award or payment for such taking or damage made in consideration thereof, to the extent of the full amount of the then remaining unpaid indebtedness secured hereby, is hereby assigned to Mortgagee, who is empowered to adjust and compromise the claim for and collect and receive the same and to give proper receipts therefor in the name of Mortgagor, and the same shall be paid forthwith to Mortgagee. Any award or payment so received by Mortgagee shall be released to Mortgagor for the purpose of altering, restoring, or rebuilding any part of the Mortgaged Premises which may have been altered, damaged or destroyed as the result of such taking, alteration, or proceeding, but Mortgagee shall not be obligated to see to the application of any amounts so released. Mortgagor further covenants and agrees to make, execute and deliver to

Mortgagee, at any time or times upon request, free, clear and discharged of any liens, claims or encumbrances of any kind whatsoever, any and all further assignments or instruments deemed necessary by Mortgagee for the purpose of validly and sufficiently assigning to Mortgagee all awards and other compensation theretofore and hereafter to be made to Mortgagor for any taking, either permanent or temporary, under any such proceeding.

- 7. <u>DUE ON SALF</u>. It shall be an immediate default hereunder if, without the prior written consent of Mortgagee, Mortgagor shall create, effect or consent to or shall suffer or permit any conveyance, sale, assignment, transfer or allenation of the Mortgaged Premises or any part, or interest in and to, the Mortgaged Premises.
- 8. <u>EVENTS OF DEFAULT.</u> Each of the following shall constitute a default and an Event of Default horounder;
- Failure to pay when due (whether such failure is caused by lapse of time, acceleration, or otherwise) any payment provided for in the Note, or any payment of any other indebtedness secured bereby or otherwise required herein, which payment continues unpaid for ten (10) days after written notice or Mortgagor;
- B. Failure to perform or observe any other term, covenant, provision, agreement, condition or obligation herein contained which is not hereinabove specifically referred to and such failure shall continue for a period of twent; (20) days after written notice thereof to Mortgagor (unless such failure requires work to be performed, acts to be done, or conditions to be removed which cannot by their nature reasonably be performed, done or removed, as the case may be, within such twenty (20) day period and Mortgagor shall diligently and continuously a osecute the same to completion);
 - C. If Mortgagor or a shareholder of Mortgagor shall:
 - (1) file a voluntary petition in bankruptcy;
 - (2) be adjudicated a bankrupt or insolvent;
 - (3) file any petition or answer 235king reorganization, arrangement, composition, readjustment, liquidation, dissolution, (in Jimilar relief under the present or any future federal, state or other bankruptcy act or any other present or future applicable federal, state or other statute or law;
 - (4) seek or consent to or acquiesce in the appointment of any trustee, receiver or liquidator of Mortgagor, or of all or any substantial part of its properties or of any of the Mortgaged Premises;
 - (5) make any assignment for the benefit of creditors, or admin writing its insolvency or inability to pay its debts generally as they become due;
- D. If within sixty (60) days after the commencement of any proceeding against Mortgagor or a shareholder of Mortgagor seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar relief under the present or any future federal, state or other bankruptcy act or any other present or future applicable federal, state or other statute or law, such proceeding shall not have been dismissed, or if, within sixty (60) days after the appointment of any trustee, receiver or liquidator of Mortgagor or any shareholder thereof (without the consent or acquiescence of Mortgagor or any said shareholder) of all or any substantial part of properties of such shareholder, or any

of the Mortgaged Premises, such appointment shall not have been vacated or stayed on appeal or otherwise, or If, within thirty (30) days after the expiration of any such stay, such appointment shall not have been vacated:

E. If a lien in excess of Ten Thousand Dollars (\$10,000.00), for the performance of work or the supply of materials, fixtures or articles be filed against the Mortgaged Premises, or any portion thereof, and remains filed and not fully satisfied and released (or bonded or insured over by a bonding company or title insurer satisfactory to Mortgagee) for a period of thirty (30) days after the date of filling thereof;

F. If the Mortgaged Premises shall be abandoned;

if any one or more of the foregoing Events of Default shall occur, then Mortgagee shall have the right, but not the obligation, to exercise any one or more of the following rights and remedies, at any time and from time to time, singularly, successively or together, as Mortgagee in its sole discretion from time to time may determine:

- (1) Without further notice, Mortgagee may declare all indebtedness secured hereby, including, without limitation, the whole of the principal amount remaining unpaid on the Note, logather with all interest accrued thereon, to be immediately due and payable, whereupon all of the foregoing shall become and be immediately due and payable, and may be recovered at once, whether or not such default be thereafter remedied by Mortgagor.
- (2) Mortgages may proceed to protect and enforce the rights of Mortgagee hereunder by either or both:
 - (i) any action ciclaw, suit in equity or other appropriate proceedings, whether for the specific performance of any agreement contained herein, or for an injunction against the violation of any of the terms hereof, or in aid of the exercise of any power granted hereby or by law, or
 - (II) the foreclosure of this Mortgage.
- (3) Mortgages shall, as a matter of right, without notice and without giving bond to Mortgagor or anyone claiming by, under or through Mortgagor, and without regard to the solvency or insolvency of Mortgagor or its beneficiarios or the then value of the Mortgaged Premises, be entitled to have a receiver appointed of all or any part of the Mortgaged Premises and the rents, issues and profits thereof, as provided herein, and Mortgagor hereby consents to the appointment of such receiver and shall not oppose any such appointment.
- (4) Mortgagee may cure any default of Mortgagor, take possession of the Mortgaged Premises, and collect the avails, rents issues and profits of the Mortgaged Premises, all as set forth in Paragraph 9 hereof.
- (5) Mortgagee may exercise any other rights, powers and remedies provided by any one or more of this Mortgage, the Note, and any one or more of any other collateral or documents securing all or any part of the indebtedness secured hereby.
- (6) Mortgagee may exercise any other rights, powers and remedies provided by law or in equity.

9. MORTGAGEE MAY CURE DEFAULTS OF MORTGAGOR, MORTGAGEE MAY TAKE POSSESSION OF THE PREMISES. Without limitation of any other provisions of this Mortgage:

- A. If Mortgagor shall fall to pay any Impositions described in Paragraph 2 hereof or to make any other payment required to be made by Mortgagor under this Mortgage, at the time and in the manner provided in this Mortgage, or if Mortgagor shall be in default in the performance or observance of any other agreement, obligation, term, provision or condition required to be performed or observed by Mortgagor under this Mortgage, then, upon expiration of the applicable cure period, without limiting the generality of any other provision of this Mortgage, and without waiving or releasing Mortgagor from any of its agreements and obligations hereunder, Mortgagee shall have the right, but shall be under no obligation, to:
 - (1) pay any of such impositions (including, without limitation, any penalties or interest thereon) or other payment (receipt of the proper recipient being conclusive widence of the payment, amount and validity thereof), and



10. <u>FORECLOSURE: FEES AND EXPENSES: DISTRIBUTION OF PROCEEDS OF</u> FORECLOSURE SALE.

- When the indebtedness secured hereby or any part thereof shall become due and payable, whether by acceleration or otherwise. Mortgagee shall have the right to foreclose the lien hereof for such indebtedness secured hereby, or part thereof. Without limitation of any other provisions of this Mortgage, if Mortgagee shall incur or expend any sums, including without limitation reasonable attorneys' fees, whether in connection with any action or proceeding or not, to sustain the lien of this Mortgage or its priority, or to protect or enforce any of the Mortgagee's rights hereunder, or to recover any indebtedness secured hereby (including without limitation any foreclosure proceeding), all such sums shall become immediately due and payable by Mortgagor with Interest thereon as described in the Note hereof. All such sums shall be secured by this Mortgage and be a lien on the Mortgaged Premises prior to any right, title, interest, or claim, in, to, or upon the Mortgaged Premises attaching or accruing subsequent to the lien of this Mortage. Without limitation of the generality of the foregoing, in any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness secured hereby in the decree for sale all costs and expenses which may be paid or incurred by or on behalf of Mortgagee or holders of the Note for attorneys' fees, appraiser's fees, receiver's costs and expenses, insurance, taxes, outlays for documentary and expert evidence, costs for preservation of the Mortgaged Premises, stenographer's charges, publication costs and conts of procuring all abstracts of title, title searches and examinations, guarantee policies and similar data and assurances with respect to title as Mortgagee may deem to be reasonably necessary either to prosecule such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or value of the Mortgaged Premises or for any other reasonable purpose. APPOINTMENT OF RECEIVER. Upon or at any time after the filing of a suit or bill to foreclose this Mortgage, or as otherwise provided by Paragraph 8 hereof, Mortgagee may make application, and the court in which such suit or bill is filed may appoint a receiver of the Mortgaged Premises. Such appointment may be made either before or after sale, with notice, without regard to the solvency or insolvency at the time of application for such receiver of the person or persons, if any, liable for the payment of the indebtedness secured hereby and without regard to the then value of the Mortgaged Premises whether the same shall then be occupied as a homestead or not and Mortgagee hereunder may be appointed as such receiver. Such receiver shall have power to collect the rents, sales proceeds, issues, profits and proceeds of the Mortgaged Premises during the pendency of such foreclosure suit, as well as during any further times when Mortgagor, its successors or assigns, except for the intervention of such receiver, would be entitled to collect such rents, sales proceeds, issues, proceeds and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the Mortgaged Premises during the whole of said period. - E. amends or modifies in any respect with the consent of Mortgagor any of the agreements, obligations, terms, provisions and conditions hereof or of the Note;
- F. consents, with Mortgagor's approval, to the filling of any map, plat, replat or condominium declaration affecting all or any part of the Mortgaged Premises;
- G. consents, with Mortgagor's approval, to the granting of any easement or other right affecting all or any part of the Mortgaged Premises; or
 - H. makes or consents to any agreement subordinating the lien hereof,

then and in any such event, such act or omission to act shall not release, discharge, modify, change or affect (except to the extent of changes referred to in clause (e) above) the liability under this Mortgage or the Note, or any guaranty, and any such act or omission to act shall not release Mortgagor, or any makers, sureties, or guarantors of this Mortgage or of the Note or of any guaranty, under any agreement, obligation, term, provision or condition of this Mortgage or of the Note, or of any additional collateral or of any guaranty, nor preclude Mortgagee from exercising any right, power, or privilege herein granted or intended to be granted upon the occurrence of an Event of Default or otherwise, and any such act or

No right or remedy of Mortgagee shall be exclusive of, but shall be in addition to every other right or remedy now or hereafter existing at law or in equity. No delay in exercising, or omission to exercise, any right or remedy accruing on any default shall impair any such right or remedy, or shall be construed to be a waiver of any such right or remedy or acquiescence in such default, nor shall it affect any rights and remedies of Mortgagee arising under the agreements, obligations, terms, provisions and conditions contained in this Mortgage and the Note shall be separate, distinct and cumulative and none of them shall be in exclusion of the others and no act of Mortgagee shall be construed as an election to proceed under any of the provisions herein or in such other documents to the exclusion of any other provision, anything herein or otherwise to the contrary notwithstanding, and every such right or remedy may be exercised concurrently or Independently, and when and as often as Mortgagee in its sole discretion may determine. Mortgagor hereby expressly releases and walves any and eliminates under and by virtue of the homestead exemption laws of the state in which the Mortgaged Premises are located, all rights to retain possession of the Mortgaged Premises after an Event of Default, and any and all rights of redemption from sale under any order or decree of foreclosure of this Mortgage or under any sale or statute or order, decree, or judgment of any court, on behalf of itself and each and every person acquiring any interest in or title to the Mortgaged Premises or any portion thereof subsequent to the date hereof, except decree and judgment creditors of Mortgagor. Mortgagor will not hinder, delay or impede the exercise of any right, power or remedy herein or otherwise granted or delegated to Mortgagee, or invoke or utilize any law or laws which will accomplish same, but will suffer and permit the exercise of every such right, power and remedy as though no such law or laws have been made or enacted.
- 16. <u>USE OF PROCEEDS.</u> Mortgagor represents and agrees that the principal obligation secured hereby constitutes a business loan not subject to any usury laws.

- ASSIGNMENT OF LEASES AND RENTS. Although it is the intention of the parties that the assignment contained in this paragraph shall be a present assignment, it is expressly understood and agreed, anything herein contained to the contrary notwithstending, that Mortgagee shall not exercise any of the rights or powers conferred upon it by this paragraph until and unless one or more of the Events of Default set forth herein shall have occurred.
- 17. <u>TIME OF ESSENCE.</u> Time is of the essence of this Mortgage and of the performance by Mortgagor of its obligations harrunder.
- 18. <u>INVALIDITY.</u> Nothing herein or in the Note contained nor any transaction related thereto shall be construed or shall so operate, either presently or prospectively:
- A, to require Mortgage to pay interest at a rate greater than is at any time lawful in such case to contract for, but shall require payment of interest only to the extent of such lawful rate, or
 - B. to require Mortgagor to make any payment or do any act contrary to law.



Without limitation of the foregoing, Mortgagor will not in any other manner impair the security of this Mortgage for the payment of the indebtedness secured hereby, it being

- 20. <u>WAIVER OF DEFENSE</u>. No action for the enforcement of the lien hereof or of any provision hereof shall be subject to any defense which would not be good and valid to the party interposing same in an action at law upon the Note.
- 21. <u>INSPECTION OF MORTGAGED PREMISES.</u> Mortgagor shall permit Mortgages or its agents to inspect the Mortgaged Premises from time to time at normal business hours and as frequently as Mortgagee considers reasonable.

Without limitation of any other provision of this Mortgage, this Mortgage constitutes a Security Agreement under the Uniform Commercial Code of the state where the mortgaged Premises are located (herein called the "Code") with respect to any part of the Mortgaged Premises which may or might now or hereafter be or be deemed to be personal property, fixtures or property other than real estate owned by Mortgagor for the purposes of this paragraph ("Collateral"); and Mortgagor hereby grants to Mortgagee a security interest in such Collateral; all of the terms, provisions, conditions and agreements contained in this Mortgage pertain and apply to the Collateral as fully and to the same extent as to any other property comprising the Mortgaged Premises; and the following provisions of this paragraph shall not limit the generality or applicability of any other provisions of this Mortgage but shall be in addition thereto:
- A. Mortgagor (being the Debtor as that term is used in the Code) is and will be the true and lawful owner of the Collateral subject to no liens, charges or encumbrances other than the lien hereof.
- B. The Collateral is to be used by Mortgagor solely for business purposes, being installed upon the Mortgaged Premises for Mortgagor's own use or as the equipment and furnishings furnished by Mortgagor, as landlord, to tenants of the Mortgaged Premises.
- C. The Collateral will be kept at the roal estate comprised within the Mortgaged Premises, and will not be removed therefrom without the consent of Mortgagee (being the Secured Party as that term is used in the Code) or any other person and the Collateral may be affixed to such real estate but will not be affixed to any other real estate.
- D. The only persons having any interest in the Mortgaged Premises are Mortgagor and its permitted tenants and users thereof.
- E. No Financing Statements covering any of the Collateral or any proceeds thereof is on file in any public office except pursuant hereto; and Mortgagor will at its own cost and expense, upon demand, furnish to Mortgagoe such further information and will execute and deliver to Mortgagoe such financing statements and other documents in form satisfactory to Mortgagoe and will do all such acts and things as Mortgagoe may at any time or from time to time reasonably request or as may be necessary or appropriate to establish and maintain a perfected security interest in the Collateral as security for the indebtedness secured hereby, subject to no adverse liens or encumbrances and Mortgagor will pay the cost of filing the same or filing or recording such financing statements or other documents, and this instrument, in all public offices wherever filing or recording is deemed by Mortgagoe to be necessary or desirable.
- F. Upon any Event of Default hereunder and at any time thereafter (such default not having previously been cured), Mortgagee at its option may declare the indebtedness secured hereby



- G. The remedies of Mortgude hereunder are cumulative and the exercise of any one or more of the remedies provided for herein or uncer the Code shall not be construed as a waiver of any of the other remedies of the Mortgagee, including having the Collateral deemed part of the Real Estate upon any foreclosure thereof so long as any part of the independence secured hereby remains unsatisfied.


