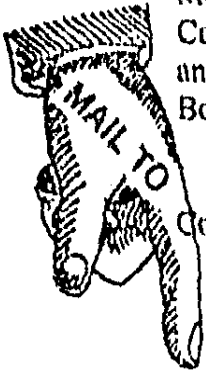

For and in consideration of the sum of Ten and no/100 (\$10.00) Dollars, cash in hand paid, and/or other valuable considerations, the receipt of which is hereby acknowledged on behalf of McKenzie Banking Company, McKenzie, Tennessee, I do hereby release the following Mortgage encumbering certain property described therein to secure the performance of a Promissory Note in the original principal amount of \$6,500.00 executed on July 19, 1985, by Stanley Stringer, hereinafter referred to as "Borrower," in favor of Equitable Bank. 
