THIS MORTGAGE IS DATED JUNE 13, 1997, between Jeffrey P. Magee and Susan H. Magee, Husband and Wife, whose address is 840 William Street, River Forest, IL 60305 (referred to below as "Grantor"); and The PrivateBank and Trust Company, whose address is Ten North Dearborn Street, Suite 900, Chicago, IL 60602-4202 (referred to below as "Lender").

GRANT OF MORTGAGE. Evidence of Payment. Grantor shall upon demand furnish to Lender suttisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental ufficial to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Grantor shall notify Lender at least fifteen (15) days before any work is commenced, any services are furnished, or any materials are supplied to the Property if any mechanic's lien, materials and the cost exceeds (15) the work, services, or materials and the cost exceeds (15) 000.00. Grantor will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage:

Maintenance of Insurance. Grantor shall procure and maintain policies of fire ir surance with standard extended coverage endorsements on a replacement basis for the full insuratie value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or climinished without a minimum of ten (10) days prior written notice to Lender and not containing any disclaimer of the insurer's liability for failure to give such notice. Each insurance policy also shall include an endursement providing that coverage in favor of Lender will not be impulsed in any way by any act omission or default of Grazilor or any other person. Should the Real Property at any time become located in an area designated by the Director of
