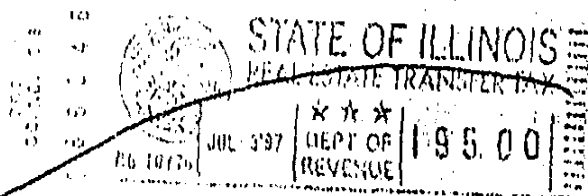
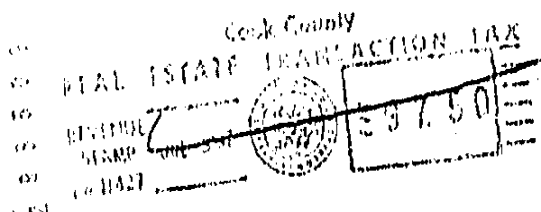
### Parcel 2:
