NOTICE OF SUBCONTRACTOR'S CLAIM FOR LIEN

That on or about November 20, 1996, the Owner owned the following described land in Cook County, Illinois (the "Property"):

That Robinette made a written proposal (the "Proposal"), dated April 23, 1996, to the Contractor pursuant to which Robinette was to furnish labor and materials for certain demolition work at the Property. The Proposal was accepted on or about November 20, 1970 orally and by the conduct of the parties and on March 14, 1997, Robinette completed all of the work required by its subcontract.

That the Contractor is entitled to credits on account thereof in the amount of Seventy Thousand Dollars (\$70,000), leaving due and owing to Robinette, after allowing all credits, the sum of Two Hundred Four Thousand Eight Hundred Eighty-Five and 42/100 Dollars (\$204,885.42), for which, with interest, Robinette claims a lien on said land and improvements
