THIS MORTGAGE AND SECURITY AGREEMENT (this "Mortgage") is made on June 26, 1997, by Felicia Ogbuli, and Anthony Ogbuli, wife and husband, having an address at 15509 Dobson, Dolton, IL 60419 ("Mortgagor"), to Cityscape Mortgage Corp., which is organized and existing under the laws of the State of New York, having an address at 565 Taxter Road, Elmsford, NY 10523 ("Mortgagee")

WITNESSETH:

To secure the payment of an indebtedness in the principal sum of FORTY NINE THOUSAND and 00/100 Dollars (\$49,000 00), lawful money of the United States of America, to be paid with interest according to a certain note dated the date hereof made by Mortgagor to Mortgagee (such note, together with all extensions, renewals or modifications thereof being hereinafter collectively called the "Note") (said-indebtedness, interest and all other sums owing hereunder and under the Note being collectively called the "Debt"), Mortgagor has mortgaged, given, granted, bargained, sold, aliened, enfeotied, conveyed, confirmed, pledged, assigned and by these presents does mortgage, give, grant, bargain, sell, alien, enfeotif, convey, confirm, pledge, assign and hypothecate unto Mortgagee the real property described in Exhibit A attached (we're) (the "Premises") and the buildings, structures, fixtures, additions, enlargements, extensions, modifications, repairs, replacements and improvements now or hereafter located thereon (the "Improvements"):

TOGETHER VITH: all right, title, interest and estate of Mortgagor now owned, or hereafter acquired, in and to the following property, rights, interests and estates (the Premises, the Improvements together with the following property, rights, interests and estate being hereinafter collectively referred to as the "Mortgaged Property"):

- (a) all easements, rights-of-way, ariph and gores of land, streets, ways, alleys, passages, sewer rights, water, water courses, water rights and powers, air rights and development rights, and all estates, rights, titles, interests, privileges, liberties, tenements, hareditaments and appurtenances of any nature whatsoever, in any way belonging, relating or pertaining to the Premises and the Improvements and the reversion and reversions, remainder and remainders, and all line diving in the bed of any street, road or avenue, opened or proposed, in front of or adjoining the Premises, and all the estates, rights, title, interests, dower and rights of dower, curtesy and rights of curtesy, property, possession, claim and demand whatsoever, both at law and in equity, of Mortgagor of, in and to the Premises and the Improvements and every part and parcel thereof, with the appurtenances thereto;
- (b) all machinery, equipment, materials, supplies, fixtures (fixfuring, but not limited to, all heating, air conditioning, plumbing, lighting, communications and elevator hattres) and other property of every kind and nature whatsoever owned by Mortgagor, or in which Mortgagor has a shall have an interest, now or hereafter located upon the Premises and the Improvements, or appurtenant thereto, and usable in connection with the present or future operation and occupancy of the Premises and the Improvements (hereinafter collectively called the "Equipment"), and the right, title and interest of Mortgagor in and to any of the Equipment which may be subject to any security interests, as defined in the Uniform Commercial Code, as adopted and enacted by the state or states where any of the Mortgaged Property is located (the "Uniform Commercial Code"), superior in lien to the lien of this Mortgage;
- (c) all awards, payments or judgments, including interest thereon, which may heretofore or hereafter be made with respect to the Mortgaged Property, whether from the exercise of the right of eminent domain (including, but not limited to, any transfer made in lieu of or in anticipation of the exercise of said right), or for a change of grade, or for any other injury to or decrease in the value of the Mortgaged Property; provided that in the event such award, payment or judgment includes compensation for both injury to or decrease in the value of the Mortgaged Property and compensation for any other injury or loss. Mortgagor agrees that the total amount of such award, payment or judgment shall be deemed compensation with respect to the Mortgaged Property; and Mortgagor hereby consents to Mortgagee's intervention into any proceeding regarding the Mortgaged Property;

- (d) all leases and other agreements affecting the use enjoyment or occupancy of the Premises and the Improvements heretofore or hereafter entered into (the "Leases"), and all rents issues and profits (including all oil and gas or other mineral royalbes and bonuses) from the Premises and the Improvements (the "Rents"), and all proceeds from the sale or other disposition of the Leases and the right to receive and apply the Rents to the payment of the Debt;
- (e) all proceeds of and any unearned premiums on any insurance policies covering the Mortgaged Property whether or not such insurance is required by Paragraph 3 of this Mortgage, including without limitation, the right to receive and apply the proceeds of any insurance, judgments or settlements made in lieu thereof, for damage to the Mortgaged Property, and
- (f) the right, in the name and on behalf of Mortgagor, to appear in and defend any action or proceeding brought with respect to the Mortgaged Property and to commence any action or proceeding to protect the interest of Mortgagee in the Mortgaged Property.

TO MAVE AND TO HOLD the above granted and described Mortgaged Property unto and to the use and benefit of Vlortgagee, and the successors and assigns of Mortgagee, forever

PROVIDED. ACMEVER, these presents are upon the express condition that, if Mortgagor shall well and truly pay to Mortgagor the Debt at the time and in the manner provided in the Note and this Mortgage and shall well and truly starte by and comply with each and every covenant and condition set forth herein and in the Note, these presents and the estate hereby granted shall cease. terminate and be void.

AND Mortgagor represents and warrants to and covenants and agrees with Mortgagee as follows:

- Payment of Debt and Incorporation of Covenants, Conditions and Agreements. (a) Mortgagor will pay the Debt at the time and in the manner provided in the Note and in this Mortgage. All the covenants, conditions and agreements contained in (i) the Note and (ii) all and any of the documents other than the Note or this Mortgage now or hereafter executed by Mortgagor and/or others and by or in favor of Mortgagee, which wholly or partially secure or guaranty payment of the Note (the "Other Security Documents"), are hereby made a part of this Mortgage to the same extent and with the same force as if fully set forth herein
- (b) All payments received by Mortgagee shall be applied first to interest accrued daily through the date the payment is received and the remainder if any to the principal. In the event that Mortgager owes Mortgagee any late charges or other fees or charges ("Other Fees"), such Other Fees shall be payable upon demand of Mortgagee. Unless prohibited by law the application of payments may be affected by the imposition of Other Fees. Therefore, payments of Other Fees, whether paid to the Mortgagee in addition to a regularly scheduled payment or separately, will be applied in a manner at the absolute discretion of the Mortgagee.
- Properly and has the full power, authority and right to execute deliver and perform its obligations under this Mortgage and to mortgage, give, grant, bargam, self, alien, enfeoff, convey, confirm, pledge, assign and hypothecate the same and that Mortgagor possesses an unencumbered fee estate in the Premises and the Improvements and that it owns the Mortgaged Property fee and clear of all liens, encumbrances and charges whatsoever except for these exceptions shown in the title insurance policy insuring the lien of this Mortgage Mortgager shall forever warrant, defend and preserve such title and the validity and priority of the lien of this Mortgage and shall forever warrant and defend the same to Mortgagee against the claims of all persons whomsoever.
 - 3 Insurance (a) Mortgagor at its sole cost and expense will keep the Mortgaged

Property insured during the entire term of this Mortgage for the mutual benefit of Mortgagor and Mortgagee against loss or damage by fire and against loss or damage by other risks and hazards covered by a standard extended coverage policy, including, but not limited to, riot and civil commotion, vandatism, malicious mischief, burglary and theft. Such insurance shall be in an amount (i) equal to the then full reptacement cost of the Improvements and Equipment, without deduction for physical depreciation, and (ii) such that the insurer would not deem Mortgagor a co-insurer under said policies. The policies of insurance carried in accordance with this paragraph shall be paid annually in advance and shall contain the "Replacement Cost Endorsement" with a waiver of depreciation.

- (b) Mortgagor, at its sole cost and expense, for the mutual benefit of Mortgagor and Mortgagee, shall also obtain and maintain during the entire term of this Mortgage the following policies of insurance:
- (i) Flood insurance if any part of the Mortgaged Property is located in an area identified by the Federal Emergency Management Agency as an area having special flood hazards and in which flood insurance has been made available under the National Flood Insurance Act of 1968 (and any amendment or successor act thereto) in an amount at least equal to the outstanding principal amount of the Note or the maximum fruit of coverage available with respect to the Improvements and Equipment under said Act, whichever is tess.
- Comprehensive public liability insurance, including broad form property damage, blanket contractual and personal injuries (including death resulting therefrom) coverages.
- (iii) , ((er tai loss insurance in an amount equal to the aggregate annual amount of all rents and additional rents payable by all of the tenants under the Leases (whether or not such Leases are terminable in the event of a fire or casualty), such rental loss insurance to cover rental losses for a period of at least two years after the date of the (re or casualty in question. The amount of such rental loss insurance shall be increased from time to time during the term of this Mortgage as and when new Leases and renewal Leases are entered into in accordance with the terms of this Mortgage, to reflect all increased rent and increased additional rent payable by all of the tenants under such new Leases.
- (iv) Insurance against loss or dar lags from explosion of steam boilers, air conditioning equipment, high pressure piping, machinery and equipment, pressure vessels or similar apparatus now or hereafter installed in the Improvements.
- (v) Such other insurance as may from time to time be reasonably required by Mortgagee in order to protect its interests.
- (c) All policies of insurance (the "Policies") required pursuant of this paragraph 3 shall (i) be issued by an insurer satisfactory to Mortgagee, (ii) shall contain the standard of charge non-contribution clause providing that no act, omission, default or misrepresentation by Mortgagor shall resjudice the right of the Mortgagee to recover the proceeds of such insurance policy and naming Mortgage as the person to which all payments made by such insurance company shall be paid, (iii) shall be maintained throughout the term of this Mortgage without cost to Mortgagee, (iv) shall be delivered to Mortgagee, (iv) shall contain such provisions as Mortgagee deems reasonably necessary or desirable to protect its interest including, without limitation, endorsements providing that neither Mortgagor, Mortgagee nor any other party shall be co-insurer under said Policies and that Mortgagee shall receive at least thirty (30) days prior written notice of any modification or cancellation, and (vi) shall be satisfactory in form and substance to Mortgagee and shall be approved by Mortgagee as to amounts, form, risk coverage, deductibles, loss payees and Insureds. Mortgagor shall pay the premiums for such Policies (the "Insurance Premiums") as the same become due and payable. Not later than thirty (30) days prior to the expiration date of each of the Policies, Mortgagor will deliver to Mortgagee satisfactory evidence of the renewal of each of the Policies.

If the Mortgaged Property shall be damaged or destroyed, in whole or in part, by five or other casualty. Mortgagor shall give prompt notice thereof to the insurance carrier and to Mortgagee. Sums paid to Mortgagee by an insurer may be retained and applied by Mortgagee, after deduction of Mortgagee's reasonable costs and expenses of collection, toward payment of the Debt in such prority and proportions as Mortgagee in its discretion shall deem proper or, at the discretion of Mortgagee either in whole or in part, to Mortgagor for such purposes as Mortgagee shall designate (such application to be without any prepayment consideration, except that if an Event of Default, or an event with notice and/or the passage of time, or both, would constitute an Event of Default, has occurred, then such application shall be subject to the prepayment consideration computed in accordance with the Note). If the Mortgaged Property shall be so damaged or destroyed, the Mortgagee may, but shall not be obligated to, make proof of loss if not made promptly by the Mortgagor, and each insurance company relating to such damage or destruction is authorized and directed to make payment for such loss directly to the Mortgagee instead of the Mortgagor. The Mortgagee is made and appointed an attorney-in-fact for the Mortgagor and as such is authorized to clake any proof of loss, to adjust and compromise any claim under any insurance policy relating to such damage or destruction, to commence, appear in and prosecute any proceeding relating to such claim and to deflect and receive any proceeds of such insurance. The appointment of the Mortgagee as attorney-in-fact of the Hortgagor is coupled with an interest and is irrevocable

Payment of Taxes, etc. Mortgagor shall pay all taxes, assessments, water charges and sewer rents, now or hereinter levied or assessed or imposed against the Mortgaged Property or any part thereof (the "Taxes") and all ground rents, maintenance charges, other governmental impositions, and other charges, including without limitation, wall charges and license fees for the use of vaults, chutes and similar areas adjoining the Premises, not or hereafter levied or assessed or imposed against the Mortgaged Property or any part thereof (the "Other Charges") as same become due and payable. Mortgagor will deliver to Mortgagee, promptly upon Mortgagee's request, evidence satisfactory to Mortgagee that the Taxes and Other Charges have been so paid or are not then delinquent. Mortgagor shall not suffer and shall promptly cause to be paid and discharged any lien or charge whats bever which may be or become a fien or charge against the Mortgaged Property, and shall promptly pay for all ublity services provided to the Mortgaged Property. Mortgagor shall furnish to Mortgagee or its designer receipts for the payment of the Taxes. Other Charges and said utility services prior to the date the same shall become definiquent.

After prior written notice to Mortgagee, Mortgage/, at its own expense, may contest by appropriate legal proceeding, promptly inflated and conducted in good faith and with due diligence, the amount or validity or application in whole or in part of any of the Taxes. Other Charges or charges for utility services, provided that (i) Mortgagor is not in default under the note or this Mortgage. (ii) Mortgagor is permitted to do so under the provisions of any mortgage or deed of trust subchor in len to this Mortgage. (iii) such proceeding shall suspend the collection of the Taxes. Other Charges or charges for utility services from Mortgagor and from the Mortgaged Property. (iv) such proceeding shall be permitted under and be conducted in accordance with the provisions of any other instrument to which Mortgagor is subject and shall not constitute a default thereunder. (v) neither the Mortgaged Property nor any part thereof or microst therein will be in danger of being sold, forfeited, terminated, cancelled or lost, (vi) Mortgagor shall have set aside adequate reserves for the payment of the Taxes. Other Charges or charges for utility services, together with all interest and penalties thereon, and (vii) Mortgagor shall have furnished such security as may be requested by Mortgagoe to insure the payment of any such Taxes. Other Charges or charges for utility services, together with all interest and penalties thereon.

Mortgages on the first day of each calendar month (a) one-twelfth of an amount which would be sufficient to pay the Taxes payable, or estimated by Mortgages to be payable, during the next ensuing twelve (12) months and (b) one-twelfth of an amount which would be sufficient to pay the Insurance Premiums due for the renewal of the coverage afforded by the Policies upon the expiration thereof [said amounts in (a) and (b) above hereinafter cafled the "Escrow Fund"]. The Escrow Fund and the payments of interest or principal or both, payable pursuant to the Note shall be added together and shall be paid as an aggregate sum by

Mortgagor to Mortgagee. Mortgagor hereby pledges to Mortgagee any and all monies now or hereafter deposited in the Escrow Fund as additional security for the payment of the Debt. Mortgagee will apply the Escrow Fund to payments of Taxes and Insurance Premiums required to be made by Mortgagor pursuant to paragraphs 3 and 4 hereof. If the amount of the Escrow Fund shall exceed the amounts due for Taxes and Insurance Premiums pursuant to paragraphs 3 and 4 hereof, Mortgagee shall, in its discretion, return any excess to Mortgagor or credit such excess against future payments to be made to the Escrow Fund. In allocating such excess, Mortgagee may deal with the person shown on the records of Mortgagee to be the agent of or the owner of the Mortgaged Property. If the Escrow Fund is not sufficient to pay the items set forth in (a) and (b) above, Mortgager shall promptly pay to Mortgagee, upon demand, an amount which Mortgagee shall estimate as sufficient to make up the deficiency. Upon the occurrence of an Event of Default (hereinafter defined) Mortgagee may apply any sums then present in the Escrow Fund to the payment of the following items in any order in its sole discretion:

- (i) Taxes and Other Charges;
- (iii) Insurance Premiums:
- (iii) Interest on the unpaid principal balance of the Note,
- (iv) Amortization of the unpaid principal balance of the Note; or
- (v) Air other sums payable pursuant to the Note, this Mortgage and the Other Security Locuments, including, without limitation, advances made by Mortgages pursuant to the terms of this Mortgage.

Until expended or applied as above provided, any amounts in the Escrow Fund shall constitute additional security for the Debt. The Escrow Fund shall not constitute a trust fund and may be commingled with other monies held by Mortgagee. No earnings or interest on the Escrow Fund shall be payable to Mortgagor.

- Condemnation. Mortgagor shall promotly give Mortgagee notice of the actual or threatened commencement of any condemnation or eminent domain proceeding and shall deliver to Mortgagee copies of any and all papers served in connection with such proceedings. Notwithstanding any taking by any public or quasi-public authority through eminent domain or otherwise (including, but not limited to, any transfer made in fieu of or in anticipation of the exercise of such taking), Mortgagor shall continue to pay the Debt at the time and in the manner provided for its payment in the Note and in this Mortgage and the Debt shall not be reduced until any award or payment therefor shall have been actually received and applied by Mortgagee, after the deduction of expenses of collection, to the reduction or discharge of the Debt. Mortgages shall not be limited to the interest paid on the award by the condemning authority but shall be entitled to receive out of the award, interest at the rate or rates provided herein and in the Note. Mortgagee may apply any such award interest at the rate or rates provided herein and in the Note. Mortgagee may apply any such award or payment to the reduction or discharge of the Debt of leftier or not then due and payable. Any reduction of the Debt pursuant to the terms of this paragraph 5 what not be deemed a prepayment of the Debt and no prepayment consideration, if any, shall be due. If the Microaged Property is sold, through foreclosure or otherwise, prior to the receipt by Mortgagee of such award or payment, Mortgagee shall have the right, whether or not a deficiency judgment on the Note shall have been sought, recovered or denied, to receive said award or payment, or a portion thereof sufficient to pay the Debt.
- 7. Leases and Rents: (a) Mortgagor does hereby absolutely and unconditionally assign to Mortgagee Mortgagor's right, title and interest in all current and future Leases and Rents, it being intended by Mortgagor that this assignment constitutes a present, absolute assignment and not an assignment for additional security only. Such assignment to Mortgagee shall not be construed to bind Mortgagee to the performance of any of the covenants, conditions or provisions contained in any such Lease or otherwise

Assignment of Leases and Rents and such additional instruments, in form and substance satisfactory to Mortgagee, as may hereafter be requested by Mortgagee to further evidence and confirm such assignment Nevertheless, subject to the terms of this paragraph 7. Mortgagee grants to Mortgagor a revocable license to operate and manage the Mortgaged Property and to collect the Rents. Mortgagor shall hold the Rents, or a portion thereof sufficient to discharge all current sums due on the Debt, in trust for the benefit of Mortgagee for use in the payment of such sums. Upon an Event of Default, the license granted to Mortgagor herein shall automatically be revoked, and mortgagee shall immediately be entitled to possession of all Rents, whether or not Mortgagee enters upon or takes control of the Mortgaged Property. Mortgagee is hereby granted and assigned by Mortgagor the right, at its option, upon revocation of the license granted herein, to enter upon the Mortgaged Property in person, by agent or by court-appointed receiver to collect the Rents. Any Rents collected after the revocation of the license may be applied toward payment of the Debt in such priority and proportions as Mortgagee in its discretion shall deem proper.

All Leases shall be written on the standard form of lease which has been **(b)** approved by Mortgages, Upon request. Mortgagor shall furnish Mortgages with executed copies of all Leases. No material changes may be made to the Mortgagee-approved standard lease without the prior written consent of Mortgagge, in addition, all renewals of Leases and all proposed leases shall provide for rental rates comparable to expering local market rates and shall be arms-length transactions. All proposed leases shall be subject to the grior approval of Mortgagee except that all proposed leases which (i) are on the same form of lease which has been approved by Mortgagee. (n) are the result of an arms-length transaction, (iii) which provide for rental rates comparable to existing market rates and (iv) do not contain any terms which would materially affect Moilgagee's rights under this Mortgage, the Note or the Other Security Documents, shall not be subject to fee prior approval of Mortgagee. All Leases shall provide that they are subordinate to this Mortgage and that trie bissee agrees to attorn to Mortgagee. Mortgagor (i) shaft observe and perform all the obligations imposed upon the lessor under the Leases and shall not do or permit to be done anything to impair the value of the Leases as sec into for the Debt. (ii) shall promptly send copies to Mortgagee of all notices of default which Mortgagor shall send or receive thereunder; (iii) shall enforce att of the terms, covenants and conditions contained in the Leases upon the part of the lessee thereunder to be observed or performed, short of termination thereof, (iv) ships not collect any of the Rents more than one (1) month in advance. (v) shall not execute any other assignment of lessor's interest in the Leases or the Rents, (w) shall not after, modify or change the terms of the Lease's without the prior written consent of Mortgagee, or except if a tenant is in default, cancel or terminate the Lear as or accept a surrender thereof or convey or transfer or suffer or permit a conveyance or transfer of the Premises or of any interest therein so as to effect a merger of the estates and rights of, or a termination or diffinithon of the obligations of lessees thereunder; provided, however, that any Lease may be canceled if at the time of the cancellation thereof a new lease is entered into on substantially the same terms or more favorable terms as the cancelled Lease; (vii) shall not after modify or change the terms of any quaranty of the Leases of ancel or terminate such guaranty without the prior written consent of Mortgagee (viii) shall not consent to any assignment of or subjetting under the Leases not in accordance with their terms, without the prior written consent of Mortgagee; and (ix) shall execute and deliver at the request of Mortgagee all such further assurances confirmation and assignments in connection with the Mortgaged Property as Mortgagee shall from three to time require

Maintenance of Mortgaged Property. Mortgagor shall cause the Mortgaged Property to be used, operated occupied and maintained in a good and safe condition and repair and in accordance with all applicable laws and regulations, including without limitation. (i) zoning and land use laws and regulations, and (ii) building fire and safety codes, laws and regulations pertaining to environmental matters and public health. The Improvements and the Equipment shall not be removed, demolshed or materially aftered (except for normal replacement of the Equipment) without the consent of Mortgagee. Mortgagor shall promptly comply with all laws, orders and ordinances affecting the Mortgaged Property, or the use thereof. Mortgagor shall promptly repair, replace or rebuild any part of the Mortgaged Property which may be destroyed by any casualty, or become damaged, worn or diapidated or which may be affected by any

proceeding of the character referred to in paragraph 6 hereof and shall complete and pay for any structure at any time in the process of construction or repair on the Premises. Mortgagor shall not initiate, join in, acquiesce in, or consent to any change in any private restrictive covenant, zoning taw or other public or private restriction, limiting or defining the uses which may be made of the Mortgaged Property or any part thereof. If under applicable zoning provisions the use of all or any portion of the Mortgaged Property is or shall become a nonconforming use. Mortgagor will not cause or permit such nonconforming use to be discontinued or abandoned without the express written consent of Mortgagee.

- Transfer of Encumbratice of the Mortgaged Property. (a) Mortgagor acknowledges that Mortgagee has examined and refied on the creditworthiness of Mortgagor and experience of Mortgagor in owning and operating properties such as the Mortgaged Property in agreeing to make the loan secured hereby, and that Mortgagee will continue to rely on Mortgagor's ownership of the Mortgaged Property as a means of maintaining the value of the Mortgaged Property as a security for repayment of the Debt. Mortgagor acknowledges that Mortgagee has a valid interest in maintaining the value of the Mortgaged Property so as to ensure that, social Mortgagor default in the repayment of the Debt, Mortgagee can recover the Debt by a sale of the Mortgage Property. Mortgagor shall not, without the prior written consent of Mortgagee, sell, convey, alien, mortgage. Property or any part thereof, or permit the Mortgageo Property or any part thereof to be sold, conveyed, aliened, mortgaged, encumbered, pledged or otherwise transferried.
