LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement is made and entered into to be effective as of July 1, 1997, by and between ROYAL NEIGHBORS OF AMERICA, a fraternal benefit society organized under the laws of the State of Illinois ("Lender"), and SOUTH HOLLAND TRUST AND SAVINGS BANK, AS TRUSTEE UNDER TRUST AGREEMENT DATED DECEMBER 1, 1993, AND KNOWN AS TRUST NO. 10874 ("South Holland").

- C. The parties desire to amena the Note and Mortgage as hereinafter provided, but not otherwise, and the parties hereto desire to evidence their agreements in writing upon the land records of Cook County, Illinois.

AGREEMENT

NOW THEREFORE, in consideration of Lender's advance of an additional sum of Five Hundred Three Thousand Five Hundred Thirty-eight and 07/110 Dollars (\$503.538.07) to South Holland, as well as other good and valuable consideration, it is agreed by and between the parties hereto as follows:

1. The Note is hereby amended as follows:

- A. The principal amount of the loan is hereby increased to Two Million Seven Hundred Eighty-five Thousand Dollars (\$2,785,000).
- B. The amount of the monthly principal and interest payment is hereby increased to Twenty-two Thousand Four Hundred Flfty-two and 06/100 Dollars (\$22,452,06).
- 2. The Mortgage is hereby amended as follows:
 - A. Paragraph 1 of the Mortgage is amended by adding following the word ("Note") the words "as amended", and thereafter all references to the note shall include the words, "as amended".

B. Paragraph 2 of the Mortgage is amended by increasing the sum from TWO MILLION FOUR HUNDRED THOUSAND DOLLARS (\$2,400,000) to TWO MILLION SEVEN HUNDRED EIGHTY-FIVE THOUSAND DOLLARS (\$2,785,000).

In all other respects the Note and Mortgage shall remain unmodified and in full force and effect.


