> > FIRST MORTGAGE

THIS FIRST MORTGAGE is made this $3^{\sqrt{t}}$ day of July, 1997, by and between JJB, L.L.C., an Illinois limited liability company (Pereinafter referred to as "Borrower"), and American National Bank and Trust Company o Chicago, a National Banking Association (hereinafter referred to as "Mortgagee").

WITNESSETH

WHEREAS, to secure the payment of an indebtedness in the meximum principal amount of TWO MILLION FIFTY THOUSAND AND 00/100 DOLLARS (\$2,050,000), to be paid with interest thereon evidenced by that certain Note (Secured) bearing even date berewith, and any amendments, modifications, extensions, renewals, or replacements thereof (he ein referred to as the "Note"), which indebtedness will be disbursed pursuant to a Loan Agreement of even date herewith among Mortgagor and Mortgagee (the "Loan Agreement"). Terms not otherwise defined herein shall have such meanings as ascribed to them in the Loan Agreement

WHEREAS, the indebtedness secured hereby was and will be created by one or more disbursements made by Mortgagee to or on behalf of Mortgagor to finance the acquisition of, and construction of improvements upon, the Mortgaged Property.

WHEREAS, pursuant to authority granted by its duly authorized representatives, the Mortgagor hereby mortgages, conveys, transfers and grants unto Mortgagee, its successors and assigns forever, real property, and all improvements thereon, situated in the County of Cook, State of Illinois (hereinafter referred to as the "Mortgaged Property" or "Premises"), legally

described in Exhibit "A" attached hereto and by this reference made a part hereof, and this Mortgage is a construction mortgage as such term is defined in Section 9-313 (1)(c) of the Illinois Uniform Commercial Code.

TOGETHER, with all buildings, and improvements now or hereafter thereto belonging upon the Mortgaged Property or any part thereof, all fixtures now or hereafter installed including, but not limited to, all lighting, cooling, ventilating, air conditioning, plumbing, sprinklers, communications, electrical systems and the equipment pertaining thereto, all building materials and goods which are procured or to be procured for use on or in connection with the Improvements or the construction of additional Improvements, whether or not such materials and goods have been delivered, all plans, specifications, architectural renderings, drawings, licenses, permits, soil test reports, other reports of examination or analyses of the Premises or the Improvements and contracts for services to be rendered to Mortgagor or any beneficiary of Mortgagor in confection with the Improvements or the construction of additional Improvements and together with the rents, issues, profits and leases of the Mortgaged Property.

TO HAVE AND FOUR the Premises unto said Mortgagee, its successors and assigns, forever, for the purpose and uses set forth herein.

I. MOETGAGOR COVENANTS

Mortgagor represents to and covenants with Mortgagee that Mortgagor holds fee simple title to the Mortgaged Property, free and clear of any and all liens and encumbrances (other than those exceptions accepted by Bank as set forth or Exhibit "B" attached hereto) and Mortgagor has the power and authority to mortgage the Mortgaged Property.

The Mortgagor shall cause the Improvements to be constructed on the Mortgaged Property in accordance with the Plans and Specifications. The Mortgagor shall maintain or cause to be maintained the Mortgaged Property in good repair, working order, and condition and make or cause to be made, when necessary, all repairs, renewals, are replacements, structural, non-structural, exterior, interior, ordinary and extraordinary. The Mortgagor shall refrain from and shall not permit the commission of waste in or about the Mortgaged Property and shall not remove, demolish, alter, change or add to the structural character of any improvement at any time erected on the Mortgaged Property without the prior written consent of the Mortgagee, except as hereinafter otherwise provided. Mortgagor covenants and agrees that in the ownership, operation and management of the Premises, Mortgagor will observe and comply with all applicable federal, state and local statutes, ordinances, regulations, orders and restrictions. Mortgagee shall have the right at any time, and from time to time, to enter the Premises for the purpose of inspecting the same.

II. INSURANCE

Mortgagor shall at all times keep the Mortgaged Property, including all buildings, improvements, fixtures and articles or personal property now or hereafter situated on the

Premises insured against loss or damage by fire and such other hazards as may reasonably be required by Mortgagee, including without limitation: (a) all-risk fire and extended coverage insurance, with vandalism and malicious mischief endorsements, for the full replacement value of the Premises; in an agreed amount, with inflation guard endorsement; (b) if there are tenants under leases at the Premises, rent or business loss insurance for the same perils described in (a) above payable at the rate per month and for the period specified from time to time by Mortgagee; (c) boiler and sprinkler damage insurance in an amount reasonably satisfactory to Mortgagee, if and so long as the Premises shall contain a boiler and sprinkler system, respectively; (d) if the Premises are located in a flood hazard district, flood insurance whenever in the opinion of the Mortgagee such protection is necessary and available; and (e) such other insurance as Mortgagee may from time to time reasonably require. Mortgagor also shall at all times maintein comprehensive public liability, property damage and workmen's compensation insurance covering the Premises and any employees thereof, with such limits for personal injury, death and property camage as Mortgagee may reasonably require, but in no event less than Two Million Dollars (\$2,000,000). All policies of insurance to be furnished hereunder shall be in forms, companies, amounts and deductibles reasonably satisfactory to Mortgagee, with mortgage clauses attached to all policies in favor of and in form satisfactory to Mortgagee, including a provision requiring the coverage evidenced thereby shall not be terminated or materially modified without thirty (30) days prior written notice to Mortgagee. Mortgagor shall deliver all policies, including additional and renewal policies, to Mortgagee, and, in the case of insurance about to expire, shall deliver renewal policies not less than thirty (30) days prior to their respective dates of expiration,

Mortgagor shall not take out separate insurance concurrent in form of contributing in the event of loss with that required to be maintained hereunder unless Mortgagee is included thereon under a standard mortgage clause acceptable to Mortgagoe. Mortgagor immediately shall notify Mortgagee whenever any such separate insurance is taker out and promptly shall deliver to Mortgagee the policy or policies of such insurance.

In the event of loss, Mortgagor will give immediate notice of mail to Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss cirectly to Mortgagee instead of to Mortgagor and Mortgagee jointly, and the insurance proceeds, or any part thereof, shall be applied by Mortgagee to the restoration or repair of the property damaged. In the event of foreclosure of this Mortgage, all right, title and interest of Mortgagor in and to any insurance policies then in force shall pass to the purchaser at the foreclosure sale. Mortgagor shall furnish Mortgagee, without cost to Mortgagee, at the request of Mortgagee, from time to time, evidence of the replacement value of the Premises.

If the Mortgagor fails to keep the Mortgaged Property insured in accordance with the requirements of the Loan Documents (as herein defined), the Mortgagee shall have the right, at its option, to provide for such insurance and pay the premiums thereof, and any amounts paid thereon by the Mortgagee shall bear interest at the Default Rate (as herein defined) from the date of payment.

III. PAYMENT OF TAXES AND ASSESSMENTS

Mortgagor shall pay before any penalty or interest attaches all general taxes, special taxes, special assessments, water charges, sewer service charges, and all other liens or charges levied or assessed against the Premises of any nature whatsoever when due, and shall furnish to Mortgagee duplicate receipts of payment therefor. If any special assessment is permitted by applicable law to be paid in installments, Mortgagor shall have the right to pay such assessment in installments, so long as all such installments are paid prior to the due date thereof. With respect to any tax or assessment which Mortgagor may desire to contest, Mortgagor shall pay such tax or assessment in full under protest in order to prevent a default under this Mortgage on accoun; thereof.

IV. FUNDS FOR TAXES AND INSURANCE

If required by Mortgagee, Mortgagor shall pay to Mortgagee, at the times provided in the Note for payment of installments of principal and/or interest, and in addition thereto, installments of taxes and assessments to be levied upon the Premises, and installments of the premiums that will become due and payable to renew the insurance hereinabove provided; said installments to be substantially equal and to be in such amount as will assure to Mortgagee that not less than thirty (30) days before the time when such taxes and premium respectively become due, Mortgagor will have paid to Mortgagora sufficient amount to pay such taxes and premiums in full. If it is within Bank's customary practice and does not result in any added cost or burden to Bank, said amounts paid to Mortgagee hereunder shall be segregated or kept in a separate fund and interest shall accrue for the benefit of Mortgagor. Said amounts shall be held by Mortgagee as additional security for the indebtedness secured hereby. Said amount shall be applied to the payment of said taxes, assessments and insurance premiums when the same become due and payable; provided, however, that Mortgagez shall have no liability for any failure to so apply said amounts for any reason whatsoever. Nothing herein contained shall in any manner limit the obligation of Mortgagor to pay taxes and to maintain insurance as above provided. In the event of any default by Mortgagor, Mortgagee may, at its option but without any obligation on its part so to do, apply said amount upon said taxes, assessments and insurance premiums, and/or toward the payment of any amounts payable by Mortgagor to Mortgagee under the Mortgage and/or toward the payment of the indebtedness secured hereby or any portion thereof, whether or not then due or payable. Mortgagee shall not require payments hereunder so long as Mortgagor makes timely payment of taxes and insurance and provides Mortgage with evidence of same.

V. PROTECTION OF MORTGAGEE'S SECURITY

If default be made in the payment of any of the aforesaid taxes or assessments or in making repairs or replacements or in procuring and maintaining insurance and paying the premiums therefore, or in keeping or performing any other covenant of Mortgagor herein, Mortgagee may, at its option and without any obligation on its part so to do, pay said taxes and assessments, make such repairs and replacements, effect such insurance, pay such premiums,

and perform any other covenant of Mortgagor herein. All amounts expended by Mortgagee hereunder shall be secured hereby and shall be due and payable by Mortgagor to Mortgagee forthwith on demand with interest thereon at the rate applicable under the Note from the date of such expenditure.

VI. REIMBURSEMENT FOR MORTGAGEE LEGAL EXPENSE

In the event that Mortgagee is made a party to any suit or proceedings by reason of the interest of Mortgagee in the Premises, Mortgagor shall reimburse Mortgagee for all costs and expenses, including reasonable attorney's fees, incurred by Mortgagee in connection therewith, whether or not said proceeding or suit ever goes to trial. All amounts incurred by Mortgagee hereunder shall be secured hereby and shall be due and payable by Mortgagor to Mortgagee forthwith on around with interest thereon at the rate applicable under the Note from the date of such expenditure.

VII. FINANCIAL STATEMENTS

Throughout the term of the Mortgage, Mortgagor, and Mortgagor's members and managers shall cause to be furnished to Mortgagee, within ninety (90) days after the close of each fiscal year of Mortgagor, balance sheets and statements of profit and loss and supporting schedules, in such form as requested by Mortgagee, for the Mortgaged Property and for the Mortgagor for such fiscal year of Mortgagor, and personal financial statements for the members and manager(s) of Mortgagor and any entities owned by or affiliated with the members and manager(s) of mortgagor who lease space in the chortgaged Property (the "affiliated tenants"), reviewed (with respect to Mortgagor's financial statements) by a certified public accountant acceptable to Mortgagee. In addition, Mortgagor shall crose to be furnished to Mortgagee such additional financial information concerning the Mortgagor, its members and manager(s) and the affiliated tenants as the Mortgagee may reasonably request from time to time (including but not limited to rent rolls and operating statements for the Mortgaged Property, on an annual basis), the reasonably free access to the Mortgaged Property and to inspect all books, records and contracts of the Mortgagor relating to the Mortgaged Property.

VIII. CONDEMNATION

If all or any part of the Mortgaged Property is damaged, taken or acquired, either temporarily or permanently, in any condemnation proceeding, or by exercise of the right of eminent domain, the amount of any award or other payment for such taking or damages made in consideration thereof, to the extent of the full amount of the remaining unpaid indebtedness secured by this instrument, is hereby assigned to Mortgagee, who is empowered to collect and receive the same and to give proper receipts therefor in the name of Mortgager and the same shall be paid forthwith to Mortgagee, who shall release any such award or monies so received or apply the same in whole or in part, after the payment of all expenses, including reasonable costs and attorney's fees, to the restoration or repair of the Mortgaged Property damaged, if the

Mortgaged Property can be restored or repaired to constitute a complete architectural unit. In the event the said Mortgaged Property cannot be restored or repaired to constitute a complete architectural unit, then such award or monies received after the payment of expenses of Mortgagee as aforesaid shall be applied on account of the unpaid principal balance of the Note, irrespective of whether such principal balance is then due and payable. Furthermore, in the event such award or monies so received shall exceed the cost of restoration or repair of the Mortgaged Property and expenses of Mortgagee as aforesaid, then such excess monies shall be applied on account of the unpaid principal balance of the Note, irrespective of whether such principal balance is then due and payable.

IX. EVENTS OF DEFAULT

Each of the following shall constitute an "Event of Default" for purpose of this Mortgage:

- (A) Failure of Mortgagor to make prompt payment, when due, of any payment of principal or interest under the Note.
- (B) An Event of Default occurring under, failure by Mortgagor to promptly perform or observe any other covenant, promise, term or agreement contained in, this Mortgage, the Loan Agreement, the Note, the Assignment of Rents and Leases (Real Property) securing the Note, the Guaranties (as defined in the Loan Agreement), or parts of any other loan document executed in connection with this loan transaction (including without limitation, the Construction Escrow and any and all documents executed and delivered in connection therewith) (collectively, the "Loan Documents"), any of which is not cared within thirty (30) days of the date of such occurrence; provided, however, may if cure is not possible within such 30 day period (through no fault of Borrower), the Event of Default shall be deemed stayed so long as Mortgagor shall, within such period, commence using its best efforts to effect such cure and such Event of Default shall not remain uncured for greater than ninety (90) days.
- (C) Any sale, agreement, transfer, lease, agreement to transfer, grart of security interest, mortgage, or other encumbrance or alienation of any increst in the Mortgagor, or Mortgaged Property without the prior written consent of Mortgagee; provided, however, that (i) so long as Jeff McClusky, Joe Shanahan and M. Brad Wood, III retain, in the aggregate, a controlling interest in the Mortgagor, Mortgagor may admit additional members in accordance with the procedures set forth in its Operating Agreement and (ii) Joe Shanahan and M. Brad Wood, III shall be permitted to transfer their interests in the Mortgagor to 1644 North Honore, L.L.C. (an entity to be formed and controlled by Joe Shanahan) and Olive Real Estate Group, L.L.C. (an entity to be formed and controlled by M. Brad Wood, III), respectively, provided, further, that at the time of any such transfers, Messrs. Shanahan, Prino and Leporte shall be the members

of 1644 North Honore, L.L.C. and Messrs. Wood, Thornton and Bond shall be the members of Olive Real Estate Group, L.L.C..

- (D) The commencement of any petition in Bankruptcy, whether voluntary or involuntary by or against Mortgagor or any guarantor of this Mortgage or the Note (a "guarantor"), if Mortgagor or a guarantor is adjudicated bankrupt or insolvent or files any petition or answer seeking restoration, assignment, composition, liquidation or similar relief under the present or any future Federal or state law or seeks or covenants to acquiesce in the appointment of any trustee, receiver, or similar officer of the Mortgagor or a guarantor, regarding the Mortgaged Property, any of which remains in effect for sixty (60) days.
- (F) Any material adverse change in the financial condition of the Mortgagor or a guaranter the effect of which is likely to hinder or impair the payment to Bank of all or any part of Borrower's Liabilities.

X. LEYDER'S DETERMINATION OF FACTS

Mortgagee will at all times be free independently to establish to its satisfaction and in its absolute discretion the existence or nonexistence of any fact or facts, the existence or nonexistence of which is a condition, warranty or covenant of this Mortgage or in any other Loan Documents.

XI. ACCELERATION AND DEFAULT RATE

If an Event of Default occurs, Mortgagee may, reas option, declare the whole of the indebtedness hereby secured to be immediately due and payable without notice to the Mortgagor. Then, at any time thereafter, at the sole option of the Mortgagor, the principal balance and accrued interest on the Note shall become immediately due and payable, and any other sums secured hereby shall become immediately due and payable. All sums coming due and payable hereunder shall bear interest, after acceleration, at the Default Rate, which shall mean the interest rate stated in the Note plus three percent (3%) per annum and shall constitute additional indebtedness secured by this Mortgage. After any such Event of Default, Mortgagee may institute or cause to be instituted, proceedings for the realization of its right under this Mortgage or any other Loan Documents.

XII. RIGHTS, POWERS AND REMEDIES OF MORTGAGEE

When the indebtedness hereby secured, or any part thereof, shall become due, whether by acceleration or otherwise, Mortgagee may at its election:

(A) Foreclose this Mortgage by legal action, as provided by applicable law.

- (B) Enter upon and take possession of the Mortgaged Property with the irrevocable consent of Mortgagor as granted and evidenced by execution of this Mortgage. As Mortgagee in possession, Mortgagee may hold, operate, manage and control the Mortgaged Property and conduct business, if any, either personally or by its agents. The Mortgagee may collect rents and lease the Mortgaged Property, cancel or modify existing leases and generally exercise all powers and rights customarily incident to ownership. Mortgagee may pay out of any rents collected, taxes, insurance, conversions, fees and any expenses attributable to the Mortgaged Property.
- Upon, or at any time after the filing of a complaint or petition to foreclose this Mortgage, the Mortgagee may apply to the court for appointment of a receiver of the Mortgaged Property. Such receiver shall have the power to collect the ren's, issues and profits of the Mortgaged Property during the pendency of the foreclosure suit up to and after any sale of the Mortgaged Property. The court may authorize the receiver to apply net income from management and control of the Mortgaged Property in whole or in part to the indebtedness secured hereby or to any tax or special assessment which may be or become superior to the lien hereof.
- (D) Exercise any and all rights the Mortgagee may have as a secured party under the Loan Documents.

XIII. CROSS-DEPAULT CLAUSE

Any default by Mortgagor or guarantor in the performance or observance of any covenant, promise, condition or agreement hereof shall be deemed an Event of Default under each of the Loan Documents, entitling Mortgagee to exercise all or any remedies available to Mortgagee under the terms of any or all Loan Documents, and any default or Event of Default under any other Loan Document, relating to any of Mortgagor's, affa ac's, Master Lessee's or guarantor's obligations to Mortgagee, shall be deemed a default hereunder, entitling Mortgagee to exercise any or all remedies provided for herein. Failure by Mortgagee to exercise any right which it may have hereunder shall not be deemed a waiver thereof unless so agreed in writing by Mortgagee, and the waiver by Mortgagee of any default by Mortgagor hereunder shall not constitute a continuing waiver of any other default or of the same default in the function

XIV. BUSINESS PURPOSE

Mortgagor covenants that the proceeds of the loan evidenced by the Note and secured by this Mortgage will be used for business purposes only and that the principal obligation constitutes a business loan which comes within the purview of applicable law.

XV. WAIVER OF REDEMPTION

- (A) Mortgagor hereby waives all rights of redemption and/or equity of redemption which exist by statute or common law for sale under any order or decree of foreclosure of this Mortgage on its own behalf and on behalf of each and every person, beneficiary or any other entity, except decree or judgment creditors of Mortgagor who may acquire any interest in or title to the Mortgaged Property or the trust estate subsequent to the date hereof.
- (B) Mortgagor hereby waives the benefit of all appraisement, valuation, stay, or extension laws now or hereafter in force and all rights of marshalling in the event of any sale hereunder of the Mortgaged Property or any part thereof or any interest therein.
- (C) Morgagor hereby waives the benefit of any rights or benefits provided by the Homestead Exemption laws, if any, now or hereafter in force.

X77. MORTGAGEE'S RIGHT OF INSPECTION

Mortgagee and/or its representative shall have the right to inspect the Mortgaged Property at all reasonable times and access thereto shall be permitted for that purpose.

XVII. FURTHER INSTRUMENTS

Upon request of Mortgagee, Mortgagor will execute, acknowledge and deliver all such additional instruments and further assurances of title and will do or cause to be done all such further acts and things as may reasonably be necessary fully to effectuate the intent of this Mortgage.

XVIII. NOTICES

Any notice, demand, requests or other communication desired to be given or required pursuant to the terms hereof shall be in writing and shall be delivered by personal service or sent by registered or certified mail, return receipt requested, postage prepaid, andressed as follows or to such other address as the parties hereto may designate in writing from true of time:

XIX. SUCCESSORS AND ASSIGNS

This Mortgage and all provisions hereof shall run with the Mortgaged Property and shall be binding upon and enforceable against Mortgagor, its members and manager(s) and their permitted successors, grantees and assigns, any subsequent owner or owners of the Premises who acquire the Premises subject to this Mortgage and all persons claiming under or through Mortgagor, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the Note or this Mortgage. This Mortgage and all provisions hereof shall inure to the benefit of Mortgagee, i.e. successors and assigns and any holder or holders, from time to time, of the Note.

XX. ENVIRONMEN CAL MATTERS

- (A) The Mortgagor hereby represents and warrants to the Mortgagee that neither the Mortgagor, nor any of its members, manager(s) or their partners, principals, affiliates or subsidiaries, nor, to the best of Mortgagor's knowledge, any other person or entity (except as set forth on that certain Environmental Phase I report prepared by Mostardi-Platt Associates and delivered to Bank), has ever caused or permitted any Hazardous Majorial to be placed, held, located or disposed of in, under or at the Premises or any part thereof, and that the Premises has never been used by the Mortgagor, or any other affiliates or subsidiarier, or, to the best of the Mortgagor's knowledge, by any other person or entity, as a temporary or premanent dump or storage site for any Hazardous Material. "Hazardous Material" means any hazardous, toxic, or dangerous waste, substance or material defined as such in (or for purposer of) the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, any so-called "Superfund" or "Superfien" law, or any other federal, state or local statute, law, ordinance, code, rule, regulation, order of decree regulating, relating to or imposing liability or standards on conduct concerning any hazardous, toxic or dangerous waste, substance or material, as now or at any time hereafter in effect.
- (B) Without limitation on any other provision hereof, the Mortgagor hereby agrees to indemnify and hold the Mortgagee harmless from and against any and all losses, liabilities, damages, injuries, costs, expenses and claims of any kind whatsoever including, without

limitation, any losses, liabilities, damages, injuries, costs, expenses or claims asserted or arising under any of the following (collectively, "Environmental Laws"): The Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, any so-called "Superfund" or "Superlien" law, or any other federal, state or local statute, law, ordinance, code, rule, regulation, order or decree, now or hereafter in force, regulating, relating to, or imposing liability or standards on conduct concerning any Hazardous Material paid, incurred, suffered by or asserted against the Mortgagee as a direct or indirect result of any of the following regardless of whether or not caused by, or within the control of the Mortgagor: (i) the presence of any Hazardous Material on or under, or the escape, seepage, leakage, spillage, discharge, emission, discharging or release of any Hazardous Material from (a) the Premises or any part thereof, or (b) any other real property in which the Mortgagor or any of its members, manager(s) or their partners, principals or affiliates or subsidiaries holds any estate or interest whatsoever (including, without limitation, any property owned by a land trust the beneficial interest in which is owned, in whole or in part, by the beneficiary of any of its affiliates or subsidiaries), or (ii) any ijens against the Premises permitted or imposed by environmental laws. or any actual or asserted liability or obligations of the Mortgagor or any of its members, manager(s) or their partners, principals or affiliates or subsidiaries under any environmental laws, or (iii) any actual or asserted liability or obligations of the Mortgagor or any of its members, manager(s) or their partners, principals or affiliates or subsidiaries under any environmental law relating to the Preirises.
