#### MORTGAGE

THIS MORTGAGE IS DATED JULY 3, 1997, between JAMES 2 GREEN and SUSAN F. GREEN, HUSBAND and WIFE, whose address is 879 Oak Street, Winnetka, IL 60093 (m/mred to below as "Grantor"); and HARRIS BANK GLENCOE-NORTHBROOK, N.A., whose address is 333 PARK AVENUE, GLENCOE, IL 60022 (referred to below as "Lender").

GRANT OF MORTGAGE. Under no circumstances shall the interest rate be more than the lesser of 18.000% per annum or the maximum rate allowed by applicable law.

Existing indebtedness. The words "Existing Indebtedness" mean the indebtedness described below in the Existing Indebtedness section of this Mortgage.

Compliance with Governmental Requirements. DUE ON SALE - CONSENT BY LENDER. Payment. Might To Contest. Evidence of Payment. Grantor shall upon demand furnish to Lender satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Holice of Construction. Grantor shall notify Lender at least filteen (15) days before any wink is commenced, any services are turnished, or any materials are supplied to the Property, if any mechanic's light materialmen's light, or other tion could be asserted on account of the work, services, or materials and the cost exceeds \$10,000.00. Grantor will upon request of Lender turnish to Lender advance assurances satisfactions to Lender that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Montgage.

Melintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a riplacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurance deliver as acceptable to the coverage from each insurance deliver as acceptable. and in such form as may be reasonably acceptable to Lender. claimant (including without Imitation Grantor), the Indebtedness shall be considered unpaid for the purpose of enforcement of this Mortgage and this Mortgage shall continue to be effective or shall be reinstated, as the case may be, notwithstanding any cancellation of this Mortgage or of any note or other instrument or agreement evidencing the Indebtedness and the Property will continue to secure the amount repaid or recovered to the same extent as if that amount never had been originally received by Lender, and Grantor shall be bound by any judgment, decree, order, settlement or compromise relating to the Indebtedness or to this Mortgage.

DEFAULT. Each of the following, at the option of Lender, shall constitute an event of default ("Event of Default") under this Mortgage: (a) Grantor commits fraud or makes a material misrepresentation at any time in connection with the credit line account.
