MODIFICATION AGREEMENT (Mortgage)

- 2. Except as specifically amended herein, the Mortgage remains in full force and effect and is hereby ratified and confirmed in its entirety by the parties hereto.
- 3. All terms used herein and not otherwise defined shall have the respective meanings set forth in the Mortgage.
- 4. This Agreement shall be incorporated into and made a part of the Mortgage, as amended, and all other related documents executed by Borrower.
