MEMORANDUM OF RIGHT OF FIRST REFERSALD PENALTY

**PARTIES** 

THIS MEMORANDUM OF RIGHT OF FIRST REFUSAL (herein, "Memorandum") dated this TTH day of APRIL , 1997, between THE VILLAGE OF HODGKINS, ILLINOIS, an Illinois municipal corporation, whose address is 8990 Lyons Street, Hodgkins, IL 60525 (herein referred to as "Owner"), and PLITT THEATERS, INC., a Delaware corporation, whose address is 70 E. Lake Street, Chicago, IL 60601 (herein referred to as the "Right Holder").

#### WITNESSETH:

WHEREAS Owner is the owner of that certain property (the "Property") consisting of approximately ten (10) acres located in the Village of Hodgkins, Illinois and legally described on Exhibit A attached hereto and made part hereof; and

WHEREAS the Right Holder is the ground lessee under a ground lease ("Ground Lease") entered into by the parties hereto for certain property located adjacent to the Property; and

WHEREAS Owner has granted to the Right Holder a right of first refusal in the Property as set forth herein.

#### RIGHT OF FIRST REFUSAL

1. For a period of eighteen (18) months from the date hereof, Owner shall be allowed to transfer all or any portion of Owner's fee interest in the Property to the California State Teacher's Retirement System. During said eighteen (18) month period, if to any other third party, and thereafter, Owner shall not transfer all or any portion of Owner's fee interest in the Property (the "Offered Interest") unless Owner has obtained a bona fide offer to purchase the Offered Interest from a third party and Owner delivers a written notice (the "Offer Notice") to the Right Holder enclosing an executed copy of the third party bona fide offer and advising the Right Holder of the identity of the proposed transferee. Delivery of the Offer Notice to the Right Holder shall be deemed an offer by Owner to sell the Offered Interest to the Right Holder on the terms and conditions

stated in the Offer Notice, subject to the provisions of Subsection 21.6 of the Ground Lease. The offer may be accepted by the Right Holder at any time on or before thirty (30) days following the date of delivery of the Offer Notice to the Right Holder (the "Offer Period").

#### **PURPOSE**

2. The sole purpose of this instrument is to give notice of said Right of First Refusal and its terms, covenants and conditions to the same extent as if said Right of First Refusal were fully set forth herein. The Ground Lease contains certain other rights and obligations in relation to the Right of First Refusal which are more fully set forth therein.

#### BINDING EFFECT/COVENANTS RUN WITH THE LAND

3. The conditions, covenants and agreements contained in this instrument shall be binding upon and inure to the benefit of the parties hereto, their respective heirs, executors, administrators, successors and assigns for the term of the Ground Lease and any extensions thereof. The Right of First Refusal shall run with the land described in Exhibit "A".


