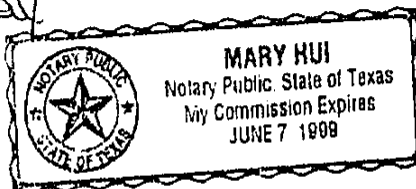

EXHIBIT "A"

A portion of Section 7 Township 41 North, Range 14 East of the Third Principal Meridian in the City of Evanston, County of Cook, and State of Illinois described as follows:

Using as a reference line the north point of a line parallel to and 762.0 feet east of the east line of Sheridan Road, and as a point of beginning a point on this line that is 921.38 feet north of the south line of Section 7, Township 41 North, Range 14, East of the Third Principal Meridian and running by azimuths measured clockwise from the above reference line:

On an azimuth of 0° a distance of 231.0'; thence on an azimuth of 45° a distance of 100.41'; thence on an azimuth of 90° a distance of 60.0'; thence on an azimuth of 135° a distance of 258.0'; thence on an azimuth of 225° a distance of 169.07'; thence on an azimuth of 270° a distance of 193.90' to the point of beginning.
