THIS ASSIGNMENT OF RENTS IS DATED JULY 17, 1997, between STANDARD BANK AND TRUST COMPANY AS TRUSTEE U/T/A #15631, AND NOT INDIVIDUALLY, whose address is 7800 W. 96TH ST., HICKORY HILLS, 60457 (referred to below as "Grantor"); and Bank of Matteson, whose address is 4600 W. ASSIGNMENT. For valuable consideration, Grantor assigns, grants a continuing security interest in, and conveys to Lender all of Grantor's right, title, and interest in and to the Rents from the following described Property located in COOK County, State of Illinois:
