AGREED ORDER FOR ATTORNEYS FEES

IT IS HEREBY ORDERED that:

1. EWA KRZYK having been advised of her right to a full and complete hearing with respect to her attorney's fees under Section 508 of the Illinois Marriage and Dissolution of Marriage Act, and her right to seek independent legal advice before entering into this Order, and having knowingly and voluntarily waived her right to said hearing, agrees that she shall pay KURT MULLER the sum of \$ 7500.00 as and for additional attorney's fees in addition to the fees she has already paid said lawyer.

2. EWA KRZYK acknowledges that she has entered into a written attorney fee agreement with KURT MULLER and that she has received and reviewed a detailed attorney fee statement itemizing the services rendered and costs advanced to date. EWA KRZYK further acknowledges that said charges are fair and reasonable.

3. Accordingly, a Judgment is hereby awarded to KURT MULLER against EWA KRZYK for \$ 7500.00.

4. EWA KRZYK agrees to pay said \$ 7500.00 Judgment to MULLER in full within 30 days from the entry of the Judgment for Dissolution of Marriage in this cause. Said Judgment entered in favor of Muller shall constitute a lien upon the real property commonly known as 7748 W. Gregory Street, Chicago, Illinois. Based upon the representation of the Respondent that said property is currently eligible for refinancing and that Muller's Judgment will be paid in full out of the proceeds of said refinancing, execution of Muller's Judgment will be stayed for thirty (30) days from the date hereof or until the date of the refinance, whichever is first to occur.
