

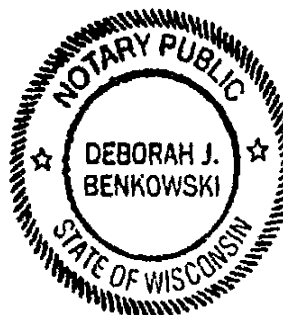

## RIDER
