2: Definitions. In this document, the following definitions apply.

"Mortgage": This document will be called the "Mortgage": said chicken will be called the "Mortgage".

"Borrower": CHICAGO TITLE AND TRUST CO, A CORP. OF IL., ATUTA DATED 11-10-78
AND KNOWN AS TR # 1073627 will be called "Borrower".

Borrower's address in shown below.

"Lender": TCF Bank Illinois fsb will be called "Lender". Lender is a federal savings bank which was formed and vehich exists under the laws of the United States of America. Lender's address for the purpose of receiveing notices and making payments is 1420 Kensigton, Suite 320, Oak Brook, IL 60521-2147.

"Agreement": The CommandCredit Plus Agreement signed by one or more Borrower and dated the same date as this Mortgage will be called the "Agreement". Under the Agreement, any Borrower signing the Agreement has a revolving line of credit called the "Account". The Agreement allows Borrower to obtain Loan Advances from the Account, make payments, and obtain readvances. Under the Agreement, Borrower may request Loan Advances from the Lender at any time until the final due date, shown in Section 3 below.

"Property": The property that is described in section 5 is called the "Property".

- 3. Final Due Jan. The scheduled date for final payment of what Borrower owes under the Agreement is 03-24-2012
- 4. Variable Animal Percentage Rate. The Annual Percentage Rate is the cost of Borrower's credit as a yearly rate. The Annual Percentage figure Lender uses to figure Finance Charges will go up and down, based on the highest U.S. prime rate published daily in The Wall Street Journal under "Money Rates" (the "Index"). The index is not the lowest or best rate: offered by Lender of other lenders, if the index becomes unavailable, Lender will select, to the extent permitted by applicable laws and regulations, some other interest rate index that is comparable to the index and notify Borrower. If the Annual Percentage Rate goes up or down, the Daily Periodic Rate will also go up or down. To figure the ANNUAL PERCENTAGE RATE, we add 2.40 percentage points to the index rate in effect the previous business day. ("business day" does not include Saturday's Sundays and legal holidays.) On each business day we will recalculate the ANNUAL PERCENTAGE RATE for this loan so that it is 2.40 % (2.40 percentage points) above the index published the previous business day. If the index ate changes, however, the ANNUAL PERCENTAGE RATE for this loan will charge the next business day. The beginning index rate for this loan is 8.25 % per year. The beginning ANNUAL PERCENTAGE RATE for this loan is therefore 10.65 % per year, which is a Daily Periodic Rate of .029178 %.

- 5. Description of the Property. Borrower gives Londer white in the following Property:

- b. All buildings and all other improvements and fixtures (such as plumbing and electrical equipment) that are now or will in the future be located on the Land.
- c. All "easements, rights, hereditaments, appurtanances, rents, royalties, and profits" that go along the Land.

 These are rights in other property that Borrower has as owner of the Land.
- 6. Notice of Variable Rate of Interest. This Mortgage secures a line of credit that has a variable rate of interest. This means that the interest rate may increase or decrease from time to time, as explained in paregraph 4.
- 7. Finance Charge. Borrower will nav a Finance Charge until Borrower has repaid everything owed under the Agreement. Lender figures the Finance Charge at the end of every monthly billing cycle. The monthly billing cycle runs from and including the first day of a month to and including the lead day of that month. To figure the Finance Charge for a monthly billing cycle, Lender adds up the Finance Charges for each day in the billing cycle. Lender multiplies the Daily Périodforfaire times the Daily Balance of Borrower's Account on that day (for each day in the monthly billing cycle). Lender figures the Daily Periodic Rate by dividing the Annual Percentage Rate by 365 (or 366, in any leap year). 10. Promises of Borrower -- Borrower represents and warrants that:

a. Borrower owns the Property;

Borrower gives a general warranty of title to Lender. This means that Borrower will be fully responsible for any classes which Lender suffers because someone other than Borrower has some of the rights in the Property that Borrower trappearnts and warrants to have. Borrower will defend ownership of the Property against any claims of auch rights.

11. Sorrower's Promise to Pay - The Agreement. Borrower promises to promptly pay all amounts due on the

12. Borrower's Promise to Pay -- Charges and Assessment. Borrower promises to pay all present and future lians, taxes, assessments, utility bills, and other charges on the Property, including any amounts on any prior mortgage, as

13. Borrower's Promise to Buy Hazard Insurance. Borrower promises to obtain a hazard insurance policy naming Lender as mortgaged, and which covers all buildings on the Property. The insurance must be satisfactory to Lender and must cover loss or demage caused by fire and hazards normally covered by "extended coverage" hazard Insurance policies. If Lender forecloses this Mortgage, anyone who buys the Property at the foreclosure sale will have all the rights

- 14. Horower's Promise to Buy Flood hav aics. If the Land or any part of the Land is located in a designated official flood-hazardous area, Borrower promises to buy flood insurance in the maximum amount available or the amount secured by this Mortgage, whichever is less. Borrower agrees to direct that any money payable under the flood insurance will be paid to Lender, but Borrower will still have to make regular payments under the Agreement until the entire amount Borrower owes is paid in full.
- 15. Borrower's Promise to Maintain the Property: Borrower promises that Borrower won't damage or destroy the Property. Borrower also promises to keep the Property in good repair. If any improvements are made to the Property, Borrower promises that they won't be removed from the Property.
- 16. Lender's Right to Take Action to Protect die Property. Lender may enforce and exercise them one at a time or all at once.

18. Joint Borrowers. Each person that signs this Mortgage is responsible for keeping all of the promises made by "Borrower". Lender may choose to enforce its rights against anyone signing the Mortgage as an individual or against all of them. 20. Seiling the Property. Borrower agrees not to sell or transfer all or any part of the Property, or any rights in the Property, without the Lender's written consent. This includes sale by Contract for Deed

21. No Defaults Under Prior Mortgages. If there is already a mortgage against the Property, the Borrower promises

that there will never be a default under that mortgage.

22. No Other Mortgages. Borrower agrees not to mortgage all or any part of the Property or allow anyone else to

have a lien on the Property without the Lender's written consent.

- 23. Landar': Remedies -- Foreclosure.
