MODIFICATION AGREEMENT 1502624/001

NOW THEREFORE, IT is agreed by and between the parties hereto:



- 1) The outstanding principal balance is \$51,838.39;



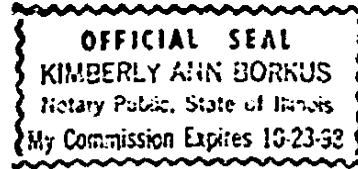

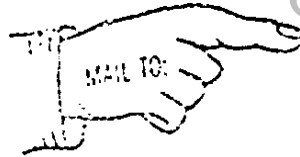
