MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED APRIL 16, 1997, BETWEEN IKE JOSIM and RITTA JOSIM, HUSBAND AND WIFE, AS TENANTS IN COMMON, (referred to below as "Grantor"), whose address is 9436 N. KARLOV AVENUE, SKOKIE, IL 60076; and BRICKYARD BANK (referred to below as "Lender"), whose address is 6676 N. LINCOLN AVENUE, LINCOLNWOOD, IL 60645-3631.

MORTGAGE. Grantor and Lender have entered into a mortgage dated March 2, 1994 (the "Mortgage") recorded in COOK County, State of Illinois as follows:

RECORDED MARCH 10, 1994, AS DOCUMENT 94218907 MADE BY IKE JOSIM AND RITTA JOSIM TO BRICKYARD BANK TO SECURE A NOTE FOR \$175,000.00 AND MODIFICATION OF MORTGAGE DATED 6-1-95 AND RECORDED JUNE 13, 1995 AS DOCUMENT 05320888, STIPULATING, AMONG OTHER THINGS, A LOAN INCREASE OF \$15,000.00; MODIFICATION DATED JULY 19, 1997 AND RECORDED JULY 29, 1998 AS DOCUMENT NUMBER 96575946 FOR AN ADDITIONAL ADVANCE OF \$21,175.74.

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property (the "Real Property") located in COOK County, State of Illinois:

SAID COMBINED LOAN IS EVIDENCED BY A NEW PROMISSORY NOTE (NOTE) DATED APRIL 16, 1997 AND TO BE FULLY REPAYED ON OR BEFORE APRIL 21, 2002. SAID NOTE IS SECURED BY THE PROPERTY PURSUANT TO THE TERMS OF THE MORTGAGE.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorers to the Note, including accommodation parties, unless a party is
