## POSTNUPTIAL PROPERTY AGREEMENT (hereinafter "Agreement")

Husband and Wife mutually agree that upon the death of Wife, the decedent's real property interest in 2643 Drury Lane, Arlington Heights, Illinois shall pass by will or intestate succession to decedent's heirs as if the marriage between Husband and Wife never occurred.
