LEGAL DESCRIPTION

The West 570 ft. of that part of the SW 1/4 South of the Indiana Boundary Line of Section 34, Township 40 North, Range 12 East of the Third Principal Meridian, lying South of the Southeasterly right of way line of the Indiana Harbor Belt Railroad Co. and North of the North line of the right of way of West North Avenue as widened, described as follows:

Beginning at the intersection of the West line of said SW 1/4 and the North line of right of way of West North Avenue, said point being 102.43 ft. North of the SW corner of said SW 1/4; thence North along the West line of said SW 1/4, 1342.09 + ft. on the intersection of said line with the southeasterly right of way line of the Indiana Harbor Belt Railroad Co., said point being 342.74 ft. south of the Indiana Boundary line, northeasterly along the southeasterly right of way line of said Railroad along a line forming an angle of 126 degrees 30 minutes 52 seconds from South to East to North with the West line of said SW 1/4, 626.38 ft. to intersection of said right of way line with the East line of the West 570 ft. of said SW 1/4; thence South along a line 570 ft.
