UNIFORM COVENANTS. Borrowers and Lender devenant and agree as follows.

1. Payment of Principal and Interest. Borrowers shall promptly pay when due the principal and interest sidebtedness evidenced by the Note and late charges as provided in the Note.

2. Funds for Taxes and Insurance. Subject to applicable law or a written waiver by Lender, Borrowers shall pay to Londer on the day monthly payments of principal and interest are payable under the Note, until the Note is paid in full, a sum (horen "Funds") equal to one-levelith of the yearly taxes and assessments (including condominium and planned unit development assessments, if any) which may attain priority over this Mortgage and ground rents on the Property, if any, plus one-levelith of yearly premium installments for hazard insurance, plus one-twelfth of yearly premiums installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof. 3. Application of Payments. Unless applicable aw provides otherwise, all payments received by Lender under the Note and paragraphs 1 and 2 hereof shall be applied by Lender first in payment of amounts payable to Lender by Borrowers under paragraph 2 hereof, then to interest payable on the Note, and then to the principal of the Note.

4. Prior Mortgages and Deeds of Trust; Charges; alens, Berrowers shall perform all of Borrowers' obligations under any mortgage, deed of trust or other security agreef ent with a filen which has priority over this Mortgage, including Borrowers' covenants to make payments when due. Borrowers shall pay or cause to be paid all taxes, accessments and other charges, lines and impositions attributable to the Placerty which may attain a priority over this Mortgage and leasehold payments or ground rents, if any.

5. Hazard Insurance. Dorrowers shall keep the improvements now existing or hereafter erected on the Property Insured against loss by fire, hazards included within the term "extended coverage" in a such other hazards as Lender may require and in such amounts and for for such periods as Lender may require.

If the Property is abandoned by Berrowers, or if Derrowers fail to respond to Lender within 30 days for the date notice is mailed by Lender to Berrowers that the insurance curren offers to settle a claim for insurance benefits. Lender is authorized to collect and apply the insurance proceeds at Lender's option either to restoration or repair of the Property or to the sums secured by this Murtuage.

6. Preservation and Maintenance of Property; Leaseholds; Condominiums; Planned Unit Developments. Borrowers shall keep the property in good repair and shall not commit wasto or permit impairment or deterioration of the Property and shall comply with the provisions of any lease if this Mortgage is on a leasehold. 7. Protection of Lender's Security, if Borrovers fail to perform the covenants and agrapments contained in this Mortgage, or if any action or proceeding is commenced which materially affect Lender's Interest in the Property, then Lender, at Lender's option, upon notice to Borrowers, may make such appearances, disburse such sums, including reasonable attorneys' fees, and take such action us is necessary to protect Lender's interest. If Londer required Mortgage insurance as a condition of making the loan secured by this Mortgage, Borrowers shall pay the premiums required to maintain such insurance in effect until such time as the regulrement for such insurance terminates in accordance with Borrowers' and Lender's written agreement or applicable law.

Any amounts disbursed by Lender pursuant to this paragraph 7, with interest thereon, at the Note rate, shall become additional indebtedness of Borrowers secured by this Mortgage. Unless Borrowers and Lender agree to other terms of payment, such amounts shall be payable upon notice from Lender to torrowers inquisiting payment thereof. Nothing contained in this paragraph 7 shall require Lender to incur expense or take any action hereunder.

8. Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrowers notice prior to any such inspection smoothing reasonable cause therefor related to Lender's interest in the Property.

- 9. Condemnation. - 10. Borrowers Not Released; Forbearance by Lender Not a Walver. Extension of the fine for payment or modification of amortication of the sums secured by this Mortgage granted by Lender to any successor in intensit of Dorrowers shall not operate to release the liability of the original Borrowers or Borrowers' successors in Interest, Londer shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any domaind made by the original Borrowers or Borrowers' successors in Interest, Any forbangance by Lender in exercising any right or remedy humander, or otherwise afforded by applicable law, shall not be a waiver of or proclude the exercising any such right or remedy.
- 11. Successor and Assigns Bound; Joint and Several Liability; Co-signers. The covenants and agreements hence contained shall bind and the rights horounder shall mure to, the respective successors and assigns of Linder and Borrowers, subject to the provisions of paragraph 16 hereof. - 17. Acceleration; Remedies. Except as provided in paragraph 16 hereof, upon Borrowers' breach of any covenant or agreement in this Mortgage, including the covenants to pay when due any sums secured by this Mortgage, Lender prior to acceleration shall give notice to Borrowers as provided in paragraph 12 hereof specifying: (1) the breach; (2) in action required to cure such breach; (3) a date, not less that 10 days from the date the roller is mailed to Borrowers, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified on the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and sale of the Property. The notice shall further inform Borrowers of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Borrowers to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, Lender at Lender's option may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorneys' fees, and costs of documentary evidence, abstracts and title reports.
- 18. Borrowers' Right to Reinstate. Notwithstanding Lender's acceleration of the sums secured by this Mortgage due to Borrowers' breach, Borrowers shall have the right to have any proceedings begun by Londer to enforce this Mortgage discontinuous at any time prior to entry of a judgment enforcing this Mortgage ift. 19. Assignment of Henta; Appointment of Receiver.
