On or about February, 1996, Custom Communications Services, L.L.C. entered into a contract (the "Contract") with Claimant, wherein Claimant agreed to improve the Property by furnishing the supervision, labor, materials, and equipment necessary to, among other things: do an interior build-out, including removing old walls and floor covering, patching walls, installing new doors and frames in office and divider wall, constructing inventory room with shelving, replacing ceiling tile in sales area, providing all electrical work including outlets, additional lighting, track lighting and data conduit, upgrading HVAC ductwork, upgrading restroom including removal of shower,

patching walls, replacing toilet and lavatory, removing and replacing rear pass door, removing and replacing overhead door and operator, roof repairs, installing new carpeting, providing and installing new wall and floor display fixtures, sales counters, cabinets, decks, installing new cylinders in doors to current security system.

- 3. The Owner duly authorized and/or knowingly permitted Custom Communications Services, L.L.C. to enter into the Contract with Claimant.
- 4. On or about November 18, 1996, the Claimant substantially completed performance of its obligations under the Contract by substantially completing the Work.
- 5. Furguant to the terms of the Contract, the value of the Work, and the corresponding benefit to the Owner is \$46,401.55.
- 6. Claiment has been paid a total of \$263.55 for the Work that it performed under the Contract.
- 7. Pursuant to the terms of the Contract, there is now due and owing to Claimant by Cistom Communications Services, L.L.C. a total of \$46,138.00.
- 8. The Owner has retained a benefit to the Property, resulting from the Work and to the detriment of the Claimant, in the amount of \$46,138.00.
- 9. According to the Statute, Claimant now claims a Mechanic's Lien on the Property against the Owner, and all other persons interested in the Property, for the sum of \$51,138.00, plus interest and costs.
