CLAIM FOR LIEN

- 3. The Owner duly authorized and/or knowingly permitted Custom Communications Services, L.L.C. to enter into the Contract with Claimant.
- 4. On or about June 26, 1996, the Claimant substantially completed performance of its obligations under the Contract by substantially completing the Work.
- 5. Pursuant to the terms of the Contract, the value of the Work, and the corresponding benefit to the Owner is \$31,817.43.
- 6. Claimant has been paid a total of \$22,787.43 for the Work that it performed under the Contract.
- 7. It suant to the terms of the Contract, there is now due and owing to Claimant by Custom Communications Services, L.L.C. a total of \$9,030.00.
- 8. The Owner has retained a benefit to the Property, resulting from the Wurk and to the detriment of the Claimant, in the amount of \$9,030.05.
- 9. According to the Statute, Claimant now claims a Mechanic's Lien on the Property against the Owner, and all other persons interested in the Property, for the sum of \$9,030.00, plus interest and costs.
