AGREED JUDGMENT ORDER

THIS MATTER coming on to be heard upon the agreement of the Petitioner, MARILYN HOCHWERT ("Marilyn"), and her attorneys of record, KANTER & MATTENSON, LTD., for payment of Kanter & Mattenson, Ltd.'s outstanding costs and attorney's fees; the Judgment for Dissolution of Marriage providing that Marilyn is to pay and defray her own attorney's fees in connection with the dissolution of marriage proceedings except for the \$10,000.00 contribution to be made by Respondent, STEVEN HOCHWERT ("Steven"); and the Court being fully advised that the premises;

IT IS HEREBY ORDERED:

1. Kanter & Mattenson, Ltd. and Marilyn agree that there is presently due and owing to Kanter & Mattenson, Ltd. an outstanding balance for attorney's fees, costs and expenses in the amount of \$46,047.33 in connection with representation of Marilyn in her dissolution of marriage proceedings.

2. Marilyn has reviewed Kanter & Mattenson, Ltd.'s detailed billing statements sent to her throughout the proceedings dated September 10, 1991 and thereafter through the statement dated August 18, 1994, and agrees that these billing statements set

forth with specificity the services rendered and time spent by the attorneys at Kanter & Mattenson, Ltd. on Marilyn's behalf from October 14, 1991 through July 28, 1994. Marilyn further agrees that Kanter & Mattenson, Ltd.'s services rendered to her in connection with her dissolution of marriage proceedings were reasonable and necessary for the issues presented in her case and that she is satisfied with Kanter & Mattenson, Ltd.'s representation of her in her dissolution of marriage proceedings.

3. Marilyn agrees that Kanter & Mattenson, Ltd. has advised her of her right to a full and complete hearing and advice of counsel with respect to her attorneys fees under Section 508 of the Illinois of Marriage and Dissolution of Marriage Act, and Marilyn freely, knowingly, intelligently and voluntarily waives her right to such a hearing to contest or otherwise challenge said fees and costs. Marilyn agrees that her waiver of a Section 508 hearing is made without coercion or duress.

4. Marilyn and Kanter & Mattenson, Ltd. understand and acknowledge that Respondent, Steven Hochwert, is obligated under the Judgment for Dissolution of Marriage to pay to Kanter & Mattenson, Ltd. \$10,000.00 of the above attorney's fees and costs, and that the net amount which Marilyn presently owes to Kanter & Mattenson, Ltd. is \$36,047.33.

5. Marilyn and Kanter & Mattenson, Ltd. agree that Marilyn shall pay to Kanter & Mattenson, Ltd. the sum of \$27,035.50 in full and final settlement of all attorneys fees and costs due Kanter & Mattenson, Ltd. from Marilyn, and that this amount is fair, just and equitable.

6. Accordingly, judgment be and is hereby entered in favor of Kanter & Mattenson, Ltd. and against Marilyn Hochwert in the amount of \$27,035.50, and said judgment shall accrue interest from this day forward until fully and finally paid at the rate of 5% per annum rather than the statutory amount. Kanter & Mattenson, Ltd. agrees to stay execution on said judgment until Marilyn sells the residence located at 8632 Major, Morton Grove, Illinois, and that Marilyn shall have the right to prepay any portion of said judgment.

7. Kanter & Mattenson, Ltd. and Marilyn agree that the above judgment in favor of Kanter & Mattenson, Ltd. may be a lien against and secured by Marilyn's interest in the 8632 Major, Morton Grove, Illinois residence occupying a position directly behind the original mortgage and the second mortgage/loan for with Steven Hochwert is solely responsible for payment. In the event of a refinancing, Kanter & Mattenson, Ltd. shall occupy the second position directly behind the refinancing institution.


