2. MAXIMUM OBLIGATION LIMIT. The total principal amount of the Obligations secured by this Mortgage, not including, however, any sums advanced for the protection of the Property or Bank's Interest therein, nor interest, attorneys' fees, paralegal fees, costs and other legal expenses, shall not exceed the sum of \$110,000.00, provided, however, that nothing contained herein shall constitute a commitment to make additional or future loans or advances in any amounts.

- 7. ASSIGNMENT OF LEASES AND RENTS. Mortgagor grante, bargains, mortgages, sells, conveys, warrants, assigns and transfers as additional security all the right, title and interest in and to any and all:
 - A. Existing or future leases, subleases, licenses, guaranties and any other written or verbal agreements for the use and occupancy of any portion of the Property, including any extensions, renewals, modifications or substitutions of such agreements (all referred to as "Leases").
 - B. Mortgagor will promptly provide Bank with true and correct copies of all existing and future Leases. Mortgagor may collect, receive, enjoy and use the Rents so long as Mortgagor is not in default. Except for one lease period's rent, Mortgagor will not collect in advance any Rents due in future lease periods, unless Mortgagor first obtains Bank's written consent. Upon default, Mortgagor will receive any Rents in trust for Bank and Mortgagor will not commingle the Rents with any other funds. Any amounts collected shall be applied at Bank's discretion first to costs of managing, protecting and preserving the Property, and to any other necessary related expenses including Bank's court costs. Mortgagor agrees that this assignment is immediately effective between the parties to this Mortgage and effective as to third parties on the recording of this Mortgage. Mortgagor agrees that Bank is entitled to notify Mortgagor or Mortgagor's tenants to make payments of Rents due or to become due directly to Bank after such recording, however Bank agrees not to notify Mortgagor's tenants until Mortgagor defaults and Bank notifies Mortgagor of the default and demands that Mortgagor and Mortgagor's tenants pay all Rents due or to become due directly to Bank. On receiving the notice of default, Mortgagor will endorse and deliver to Bank any gayments of

Mortgagor warrants that no default exists under the Leases or any applicable landlord law. Mortgagor also warrants and agrees to meintain, and to require the tenants to comply with, the Leases and any applicable law. Mortgagor will promptly notify Bank of any noncompliance. If Mortgagor neglects or refuses to enforce compliance with the terms of the Leases, then Bank may opt to enforce compliance to the extent that the law permits. Mortgagor will obtain Bank's written authorization before Mortgagor consents to subjet, modify, cancel, or otherwise after the Leases, to accept the surrender of the Property covered by such Leases (unless the Leases so require), or to assign, compromise or encumber the Leases or any tuture Rents. A default or breach by Borrower, Montgagor or any co-signer, endorser, surely, or guarantor under any of the terms of this Montgage, the Note, any construction loan agreement or other loan agreement, any security agreement, mortgage, deed to secure debt, deed of trust, trust deed, or any other document or instrument evidencing, guarantying, securing or otherwise relating to the Obligations; or

C. The making or furnishing of any verbal or written representation, statement or warranty to Bank which is or becomes taken or incorrect it, any material respect by or on behalf of Mongagor, Borrower, or any one of them, or any co-signer, endorser.

- 9. REMEDIES ON DEFAULT. At the option of Bank, all or any part of the principal of, and accrued interest on, the Obligations shall become immediately due and payable without notice or demand, upon the occurrance of an Event of Default or at any time thereafter. In addition, upon the occurrence of any Event of Default, Bank, at its option, has immediately commence foreclosure proceedings and may immediately invoke any or all other remedies provided in the Note, this Mongage or conted documents. Bank is entitled to all rights and remedies provided at law or equity whether or not expressly stated in this Mongage. By choosing any remedy, Bank does not waive its right to an immediate use of any other remedy if the event of default continues or occurrance.
- 10. DUE ON SALE OR ENCUMBRANCE. Bank may, at Bank's option, declare the entire balance with all accrued interest on the Obligations to be immediately due and payable upon the contract for, or creation of, any lien, encumbrance, it ransfer or sale of the Property, or any portion thereof, by Mortgagor. Lapse of time or the acceptance of payments by Bank after such president of any lien, encumbrance, transfer or sale, or contract for any of the foregoing, shall not be deemed a waiver or estoponil of Bank's right to accelerate the Obligations. If Bank exercises such option to accelerate, Bank shall mail, by certified mail or otherwise who 'gagor notice of acceleration to the address of Mortgagor shown on Bank's records; the notice shall provide for a period of not less than 20 days from the date the notice is mailed within which Mortgagor shall pay the sums declared due. - 16. ENVIRONMENTAL LAWS AND HAZARDOUS SUBSTARCES.

 - (1) "Environmental Law" means, without limitation, the Comprehensive Environmental Response, Compensation, and Liability Act ("CERCLA", 42 U.S.C. 9601 of \$10.), all federal, state and local faws, regulations, ordinances, court orders, attorney general opinions or interpretive letters concerning the public health, safety, welfare, environment or a Hazardous Substance (as defined herein).
 - (2) "Hazardous Substance" means any toxic, radicactive or hazardous material, waste, poliutant or contaminant which has characteristics which render the substance dimensions or potentially dangerous to the public health, safety welfare or the environment. The term includes, without limitation, any substances defined as "hazardous material." "toxic substances," "hazardous waste" or "hazardous suor ar be" under any Environmental Law.
 - B. Mortgagor represents, warrants and agrees that:
 - (1) Except as previously disclosed and acknowledged in writing to dan; no Hazardous Substance has been, is or will be located, transported, manufactured, treated, refined, or handled by any person on, under or about the Property screept in the ordinary course of business and in strict compliance with a applicable Environmental Law.
 - (2) Except as previously disclosed and acknowledged in writing to Book, Mortgagor has not and shall not cause. contribute to or permit the release of any Hazardous Substance on the Property.
 - (3) Mortgagor shall immediately notify Bank it: (a) a release or threatened release of Hazardous Substance occurs on. under or about the Property or migrates or threatens to migrate from nearby pipperty; or (b) there is a violation of any Environmental Law concerning the Property. In such an event, Mortgagor shall take all necessary remedial action in accordance with any Environmental Law.
 - (4) Except as previously disclosed and acknowledged in writing to Bank, Montgagor has no functioning of or reason to believe there is any pending or threatened investigation, claim, or proceeding of any kind relating to (a) any Hazardous Substance located on, under or about the Property or (b) any violation by Mortgagur or any tenant of any Environmental Law. Mortgagor shall immediately notify Bank in writing as soon as Mortgagor in chason to believe there is any such pending or threatened investigation, claim, or proceeding. In such an event, Sank has the right, but not the obligation, to participate in any such proceeding including the right to receive copies of any documents relating to such proceedings.
 - (5) Except as previously disclosed and acknowledged in writing to Bank, Mortgagor and every tenant have been, are and shall remain in full compliance with any applicable Environmental Law.
 - (6) Except as previously disclosed and acknowledged in writing to Bank, there are no underground storage tanks. private dumps or open wells located on or under the Property and no such tank, dump or well shall be added unless Bank first agrees in writing.
 - (7) Montgagor will regularly inspect the Property, monitor the activities and operations on the Property, and confirm that all permits, licenses or approvate required by any applicable Environmental Law are obtained and complied with
 - (8) Mortgagor will permit, or cause any tenant to permit, Bank or Bank's agent to enter and inspect the Property and review all records at any reasonable time to determine: (a) the existence, location and nature of any Hazardous Substance on, under or about the Property; (b) the existence, location, nature, and magnitude of any Hazardon's Substance that has been released on, under or about the Property; (c) whether or not Mortgagor and any tenant are in compliance with any applicable Environmental Law.
 - (3) Upon Bank's request, Mongagor agrees, at Mongagor's expense, to engage a qualified environmental engineer to prepare an environmental audit of the Property and to submit the results of such audit to Bank. The choice of the

(10) Bank has the right, but not the obligation, to perform any of Mortgagor's obligations under this paragraph at

Mortgagor's expense.

(11) As a consequence of any breach of any representation, warranty or promise made in this paragraph, (a) Montgagor will indemnify and hold Bank and Bank's successors or assigns harmless from and against all losses, claims. demands, liabilities, damages, cleanup, response and remediation costs, penalties and expenses, including without limitation all costs of litigation and reasonable attorneys' less, which Bank and Bank's successors or assigns may sustain; and (b) at Bank's discretion, Bank may release this Mortgage and in return Mortgagor will provide Bank with collateral of at least equal value to the Property secured by this Mortgage without prejudice to any of Bank's rights under this Morigage.

- 18. PROTECTION OF BANK'S SECURITY. If Mortgagor falls to perform any covenant, obligation or agreement contained in the Note, this Mortgage or any lan documents or if any action or proceeding is commenced which materially affects Bank's interest in the Property. Including, but not implied to, foreclosure, eminent domain, insolvency, housing or Environmental Law or law enforcement, or arrangements or procedures involving a bankrupt or decedent, then Bank, at Bank's sole option, may make such appearances, disburs, such sums, and take such action as is necessary to protect Bank's interest. Mortgagor hereby assigns to Bank any right Mortgagor may have by reason of any prior encumbrance on the Property or by law or otherwise to cure any default under said prior encumbrance. Without Bank's only written consent, Mortgagor will not partition or subdivide the Property.
- 19. COLLECTION EXPENSES.
