TOOETHER with all the improvements now or hereafter erected on the property, any, and all easements, rights, appurtenances and rents all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property."

- 5. Hazard Insurance. 

- 6. Preservation and Maintenance of Property: Leaseholds; Condominiums; Planned Unit Developments. - 9. Condemnation. 13. Governing Law: Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located.
