MORTGAGE

THIS MORTGAGE IS DATED AUGUST 29, 1997, between Michael K. Sepot and Eileen A. Sepot, f/k/a Elleen A. Casey, as joint tenants, whose address is 429 Garden Circle, Streamwood, IL 60193 (referred to below as "Grantor"); and Harris Bank Hoffman-Schaumburg, whose address is 275 S. Roselle Rd., Schaumburg, IL 60193 (referred to below as "Lender").

GRANT OF MORTGAGE. Existing Indebtedness. The words "Existing Indebtedness" mean the indebtedness described below in the Existing Indebtedness section of this Mortgage.

Grantor. The word "Grantor" means Michael K. Sepot and Eileen A. Sepot. The Grantor is the mortgagor under this Mortgage.

Guarantor. The word "Guarantor" means and includes without limitation each and all of the guarantors, sureties, and accommodation parties in connection with the Indebtedness.

DEFAULT. Each of the following, at the option of Lender, shall constitute an event of default ("Event of Default") under this Mortgage: (a) Grantor commits fraud or makes a material misrepresentation at any time in connection with the credit line account.
