## LEGAL DESCRIPTION RIDER

PARCEL 1: Lots N and O in Rueter and Company's Sylvan Court, being a Sub-division in the South half of the North East quarter of Section 7, Township 35 North, Range 14, East of the Third Principal Meridian, according to the plat thereof recorded September 26, 1928 as Document 10158413, in Cook County, Illinois.

PARCEL 2: A tract of land in the South half of the North East quarter of Section 7, Township 35 North, Range 14, East of the Third Principal Meridian, described as follows: Beginning at a point on the East line of said North East quarter of Section 7 at a distance 660 feet South of the North line of the South half of the said North East quarter of Section 7 (said point being the South East corner of O. Rueter and Company's Sylvan Court Subdivision in the South half of the North East quarter of Section 7, Township 35 North, Range 14, East of the Third Principal Meridian); thence South along the East line of said North East quarter a distance of 85 feet; thence West along a line 85 feet South of and parallel to the South line of aforesaid Sylvan Court Subdivision, a distance of 650 feet thence North along a line 650 feet West of and parallel to the East line of the North East quarter a distance of 85 feet to the South West corner of lot "J" of said Sylvan Court Sub-division thence East along the South line of said Sylvan Court Sub-division a distance of 650 feet to the place of beginning (excepting from said premises the West 400 feet thereof) in Cook County, Illinois.
