To Secure to Lender on condition of the repayment of the REVOLVING LINE OF CREDIT indebtedness evidenced by a Success National Bank Success Plus Agreement and Disclosure Statement ("Agreement") of even date herewith and by Borrower's Variable Interest Rate Promissory Note ("Note") of even date herewith, in the principal sur of U.S. TWO HUNDRED THOUSAND AND NO/100 DOLLARS (\$200,000,00), or so much thereof as may be advanced and outstanding, with interest thereon, providing for monthly installments of interest with the principal balance of the indebtedners, if not sooner paid or required to be paid, due and payable ten (10) years from the date thereof; the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage or advanced by honoring overdrafts under paragraph 6(c) of the Agreement; and the performance of the covenants and agreements of Borrower contained herein and in the Agreement and the Note. The Agreement, the Note and this Mortgage are collectively referred to The Credit Documents contemplate, and this as the "Credit Documents". Mortgage permits and secures, at Mortgagee's discretion future advances in a total amount up to 1-1/2 times the principal sum of the Note as set forth above.

Borrower acknowledges that the Note calls for a variable interest rate, (utilizing the prime rate of interest published from time to time in The Wall Street Journal, all as set forth in greater detail in the Note), and that the Lender may, prior to the expiration of the term of the Note, cancel future advances thereunder and/or require repayment of the outstanding balance under the Note, in this regard, the Note provisions set forth verbatim below relate to the variable interest rate and the Lender's option to require repayment prior to expiration of the term of the Note or to cancel future advances for reasons other than default by the Borrower.

The terms, provisions, conditions and limitations of the Note are

incorporated herein by reference.

COVENANTS. Borrower and Lender covenant and agree as follows:

Subject to the rights and terms of any mortgage, deed of Trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, the amounts collected by Borrower or Lender under any Hazard insurance policy may, at Lender's sole discretion, either be applied to the indebtedness secured by this Mortgage (after payment of all reasonable costs, expenses and attorneys' fees necessarily paid or incurred by Lender and Borrower in this connection) and in such order as Lender may determine or be released to parrower for use in repairing or reconstructing the Property, and Lender is hereby irrevocably authorized to do any of the above. Such application of release shall not cure or waive any default or notice of default under this Mortgage or invalidate any act done pursuant to such notice.

PRESERVATION AND MAINTENANCE OF PROPERTY; LEASEHOLDS; CONDOMINIUMS; PLANNED UNIT DEVELOPMENTS. 8. CONDEMNATION. S. BORROWER NOT LELEASED; FORBERANCE BY LENDER NOT A WAIVER. Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower, or the waiver or failure to exercise any right granted herein or under the Credit Documents shall not operate to release, in any manner, the liability of the original Borrower, Borrower's successors in interest, or any guarantor or surety thereof. Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Lender shall not be deemed, by any act of omission or commission, to have waived any of its rights or remedies hereunder unless and only to the extent that such waiver is in writing and signed by Lender.
