BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. 13. Loan Charges. The Property richides a unit in, together with an undivided interest in the common elements of, a condominium proiest known as:

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest

CONDOMINIUM COVENANTS. In addition to the covenants and agreements made in the Security

Instrument, Borrower and Lender further covenant and agree as follows:

Borrower shall give Lender prompt notice of any lapse in required hazard insurance coverage.

D. Condemnation. E. Lender's Prior Consent. Borrower shall not, except after notice to Lender and with Lender's prior
