THIS INDENTURE WITNESSETH, THAT THE GRANTORS, DAVID P. MURPHY AND SUSAN R. MURPHY, husband and wife, of Park Ridge, Illinois, for and in consideration of the sum of Ten Dollars and No/100 (\$10,00), and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, conveys and warrants unto SUSAN R. And said GRANTORS hereby expressly wrive and release any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
