MARTGAGE

THIS MORTGAGE IS DATED AUGUST 28, 1997, between Pairicia A. Coyle, A Spinster, whose address is 3605 W. 68th Street, Chicago, IL 60629 (referred to below as "Crantor"); and Interstate Bank, whose address is 15533 Souti: Cicero, Attn: Loan Department, Oak Forest, IL 60452 (referred to below as "Lender").

GRANT OF MORTGAGE. Grantor warrants that: (a) Grantor holds good and marketable title of record to the Property in fee simple, free and clear of all liens and encumbrances other than those set forth in the Real Property description or in the Existing Indebtedness section below or in any title insurance policy, title report, or final title opinion issued in favor of, and accepted by, 'Lender in connection with this Mortgage, and (b) Grantor has the full right, power, and authority to execute and deliver this Mortgage to Lender.

Defense of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons.
