MORTGAGE

THIS MORTGAGE IS DATED SEPTEMBER 11, 1997, between Debra Dobbs and Richard Dobbs, Her Husband, as Joint Tenants, whose address is 2914 N. Attorney-in-Fact. If Grantor fails to do any of the things referred to in the preceding paragraph, Lender may do so for and in the name of Grantor and at Grantor's excense.
